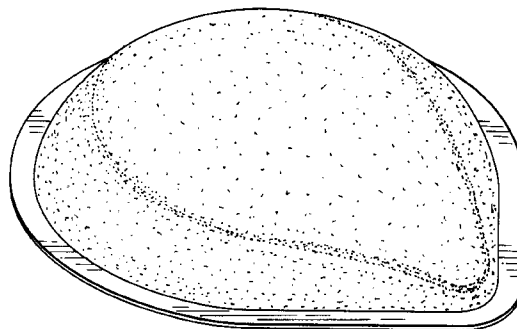
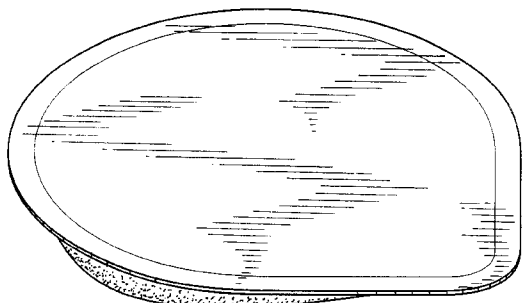
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view thereof;
FIG. 2 is a top plan view thereof;

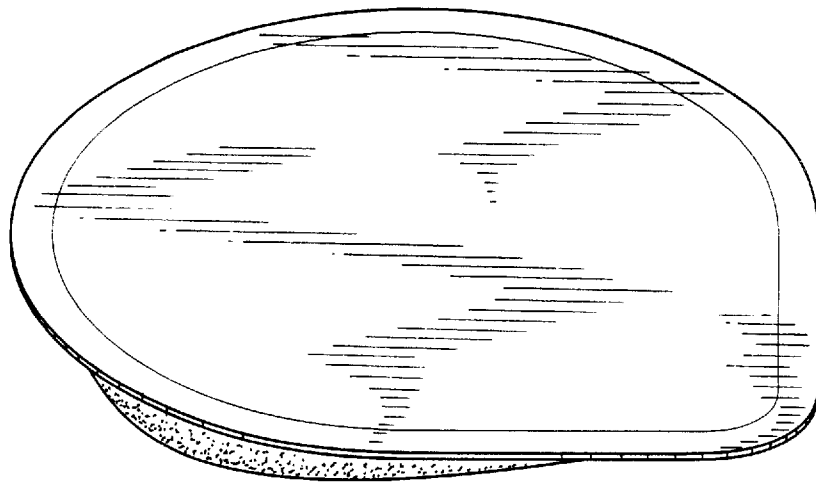

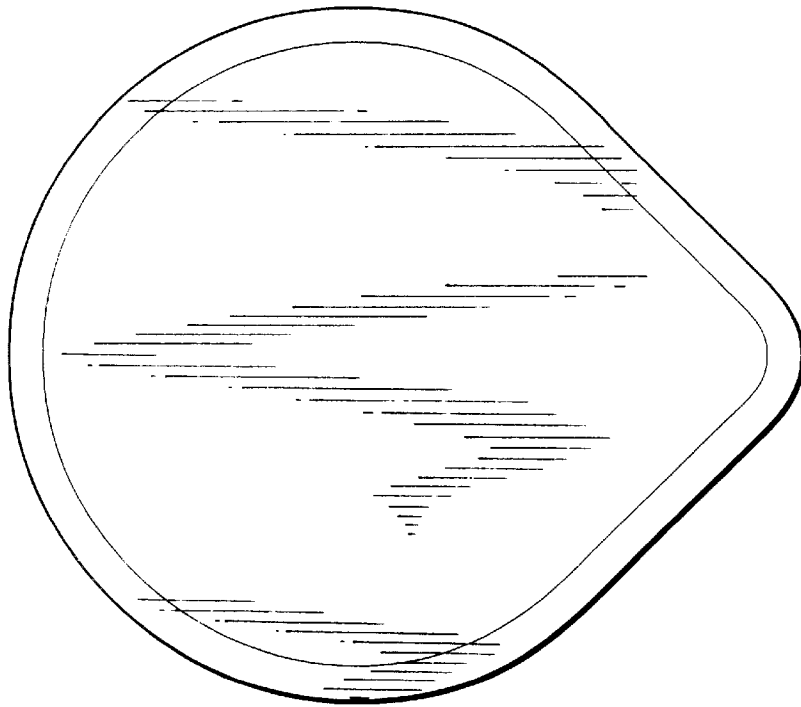

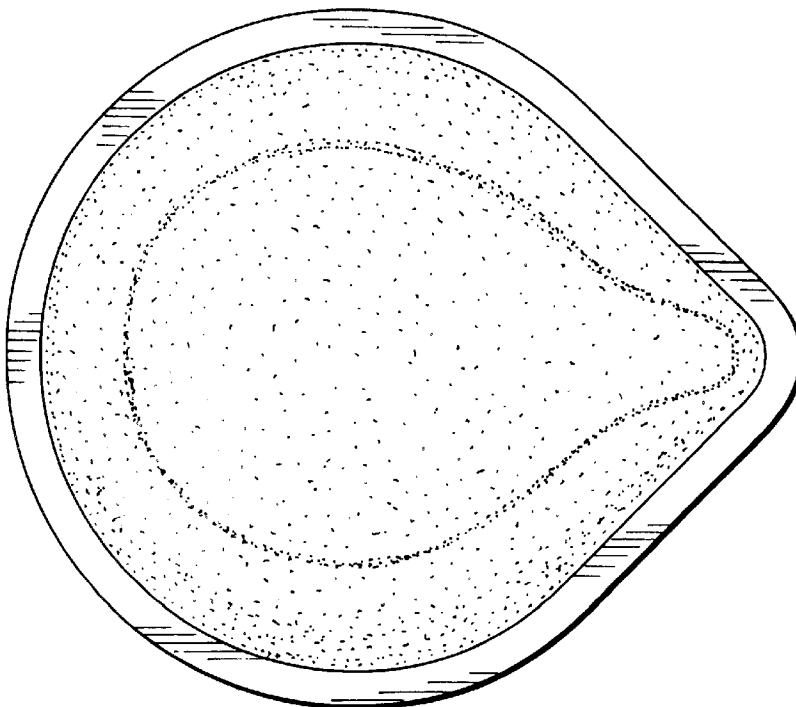

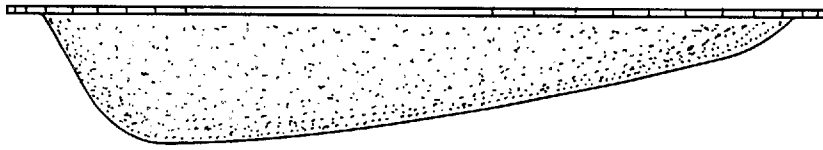

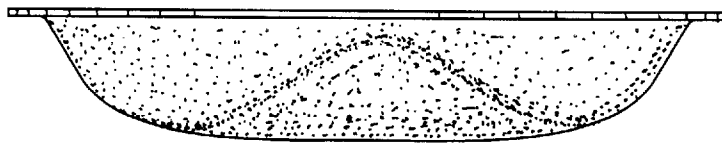

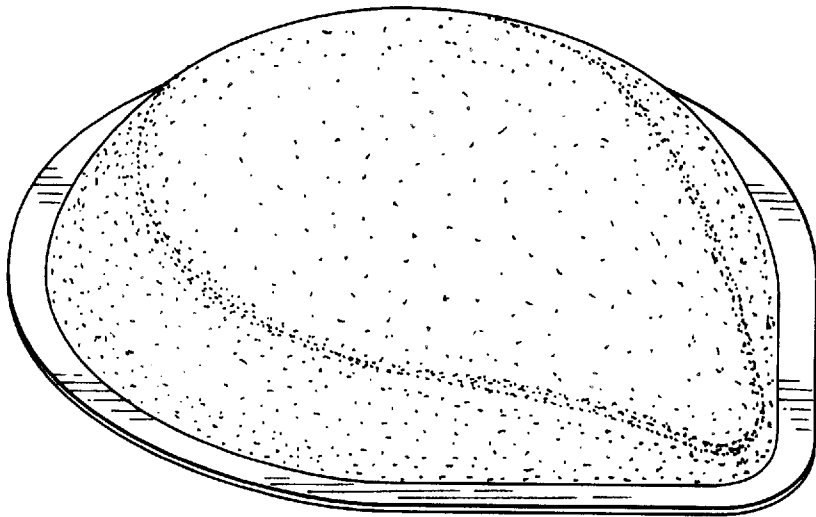
