puter screen, as shown and described.

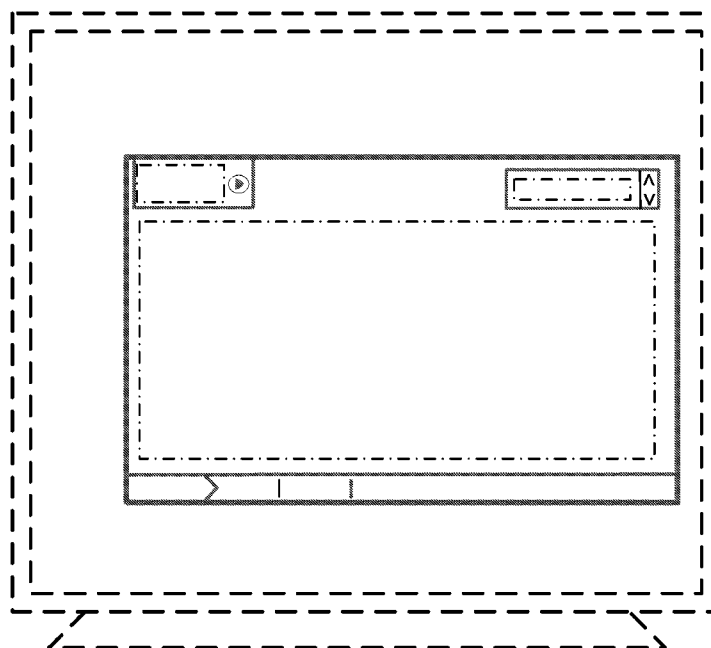

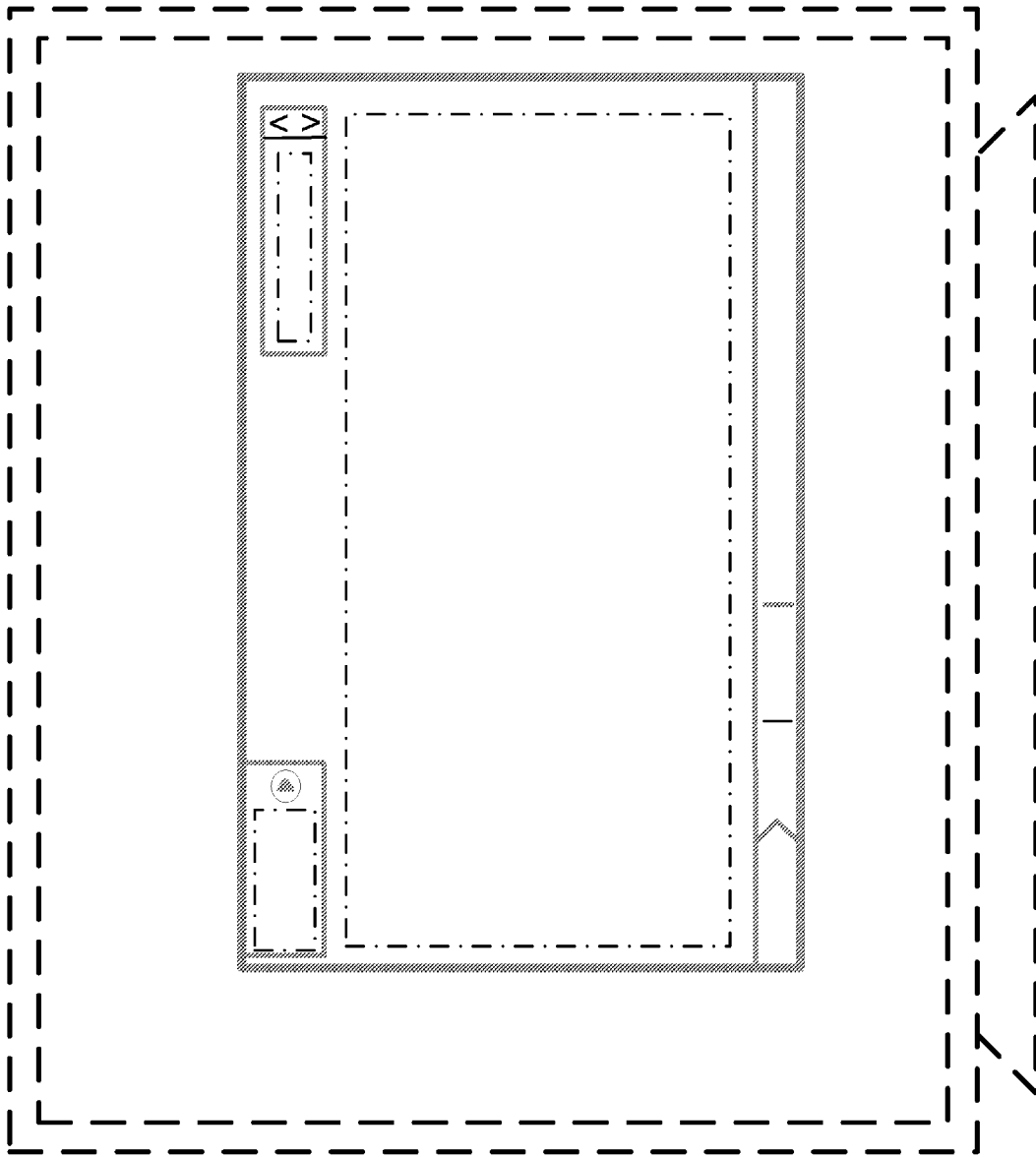
