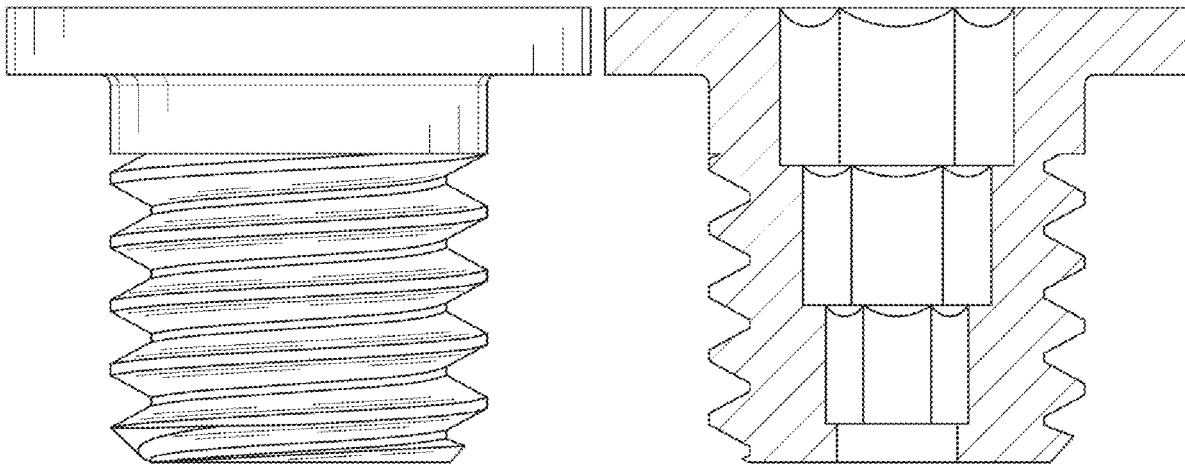
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a screw;  
FIG. 2 is a front side view of the screw of FIG. 1;

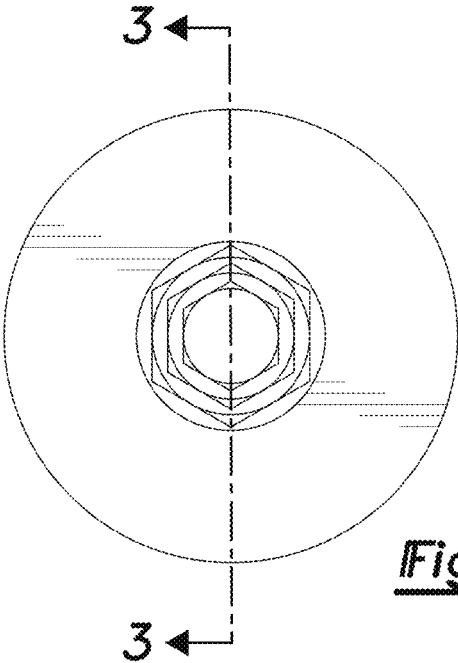

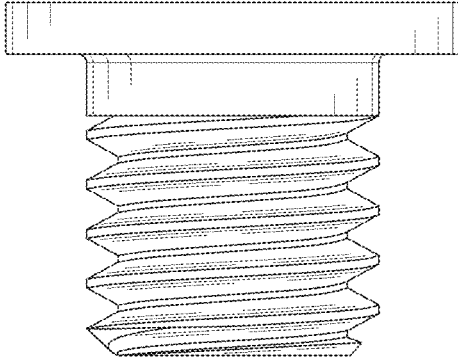

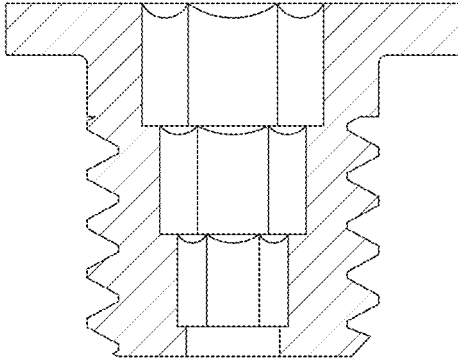

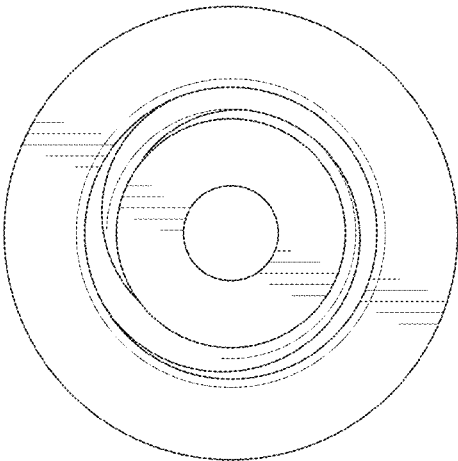

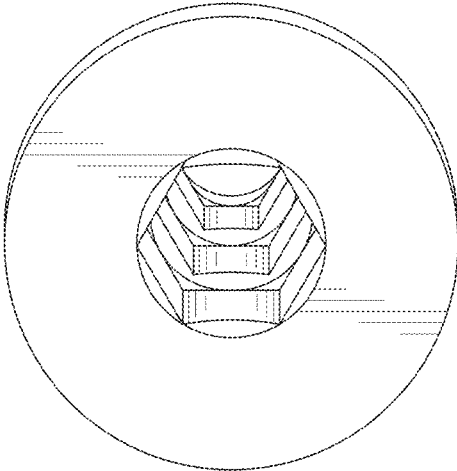

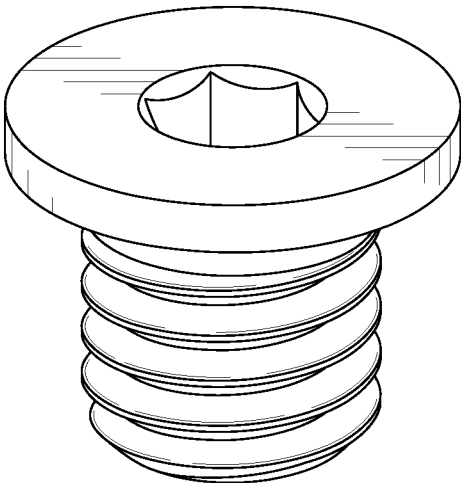

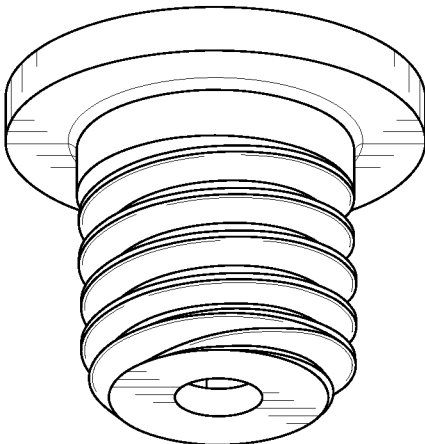

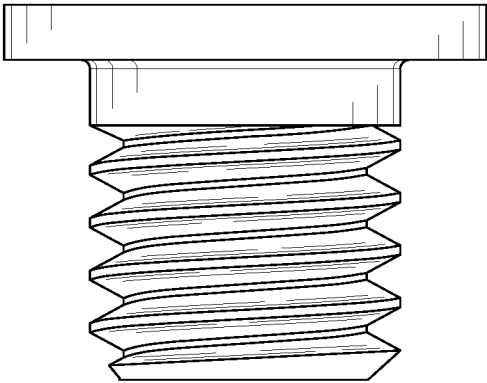

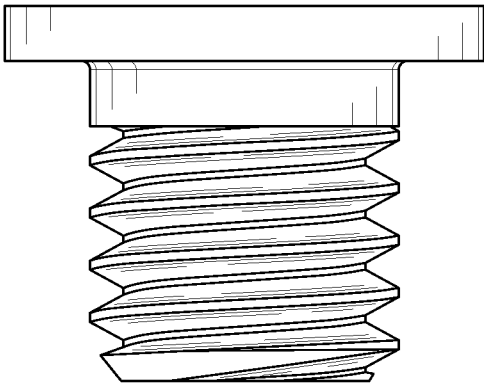

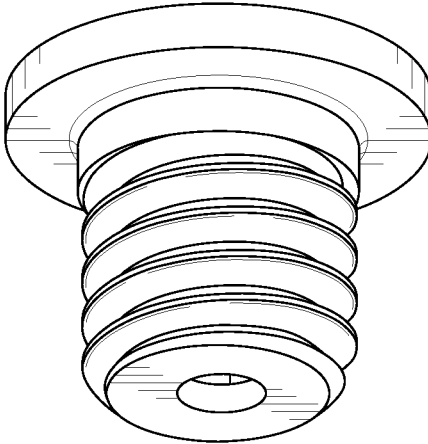
