
(57) **CLAIM**

The ornamental design for a head mounted display, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of front, top and right side of a head mounted display showing our new design;  
FIG. 2 is a perspective view of rear, bottom and left side thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;


















