(57) **CLAIM**

The ornamental design for a refractory anchor, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refractory anchor showing the design;

FIG. 2 is a front elevation view of FIG. 1;

FIG. 3 is a rear elevation view of FIG. 1;

FIG. 4 is a first side elevation view of FIG. 1;

FIG. 5 is a second side view of FIG. 1;

FIG. 6 is a top elevation view of FIG. 1;

FIG. 7 is a bottom elevation view of FIG. 1;

FIG. 8 is a perspective view of a second embodiment of the refractory anchor showing the design;

FIG. 9 is a front elevation view of FIG. 8;

FIG. 10 is a rear elevation view of FIG. 8;

FIG. 11 is a first side elevation view of FIG. 8;

FIG. 12 is a second side view of FIG. 8;


FIG. 13 is a top elevation view of FIG. 8; and,




























