
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design; FIG. 2 is a side view thereof; and, FIG. 3 is a rear perspective view thereof. The broken lines immediately adjacent to the solid line depicted region define the bounds of the claimed design and form no part thereof. 




