(57) **CLAIM**


The ornamental design for a transparent card with an antenna and a rectangle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a transparent card with an antenna and a rectangle showing our new design; FIG. 2 is a top plan view of the card of FIG. 1; FIG. 3 is a bottom plan view of the card of FIG. 1; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a front elevational view thereof; and, FIG. 7 is a rear elevational view thereof.

The broken lines showing environment in the drawings are shown for illustrative purposes only and form no part of the claimed design.










