



[57] **CLAIM**

The ornamental design for a combined grass collector and blower, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a combined grass collector and blower showing new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a side elevational view taken from the right of FIG. 1; FIG. 6 is a side elevational view taken from the left of FIG. 1; FIG. 7 is a top plan view thereof; and FIG. 8 is a bottom plan view thereof.








