The ornamental design for an electric connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and right side perspective view of an electric connector showing our new design; FIG. 2 is a front, bottom, and right side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right side elevation view thereof; FIG. 8 is a left side elevation view thereof; and, FIG. 9 is a front, top, and right side perspective view thereof, in use condition.



















