DESCRIPTION


FIG. 1 is a top isometric view of a wick of the present invention;
 FIG. 2 is a front elevational view of the wick of FIG. 1, a rear elevational view being identical thereto;
 FIG. 3 is an elevational view of a first side of the wick of FIG. 1, a second side of the wick opposite the first side being identical thereto;
 FIG. 4 is a top elevational view of the wick of FIG. 1;
 FIG. 5 is a bottom elevational view of the wick of FIG. 1; and,
 FIG. 6 is a front elevational view of the wick of FIG. 1 within a container.












