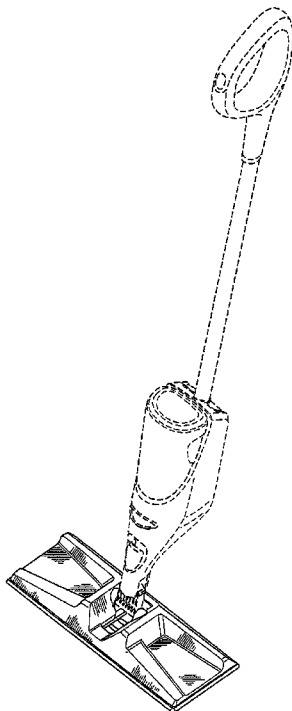
(57) **CLAIM**

The ornamental design for a stick mop, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the stick mop of this invention; FIG. 2 is a front view of the stick mop of this invention; FIG. 3 is a rear view of the stick mop of this invention; FIG. 4 is a view of a left side of the stick mop of this invention; FIG. 5 is a view of a right side of the stick mop of this invention; FIG. 6 is a top view of the stick mop of this invention; and, FIG. 7 is a bottom view of the stick mop of this invention. 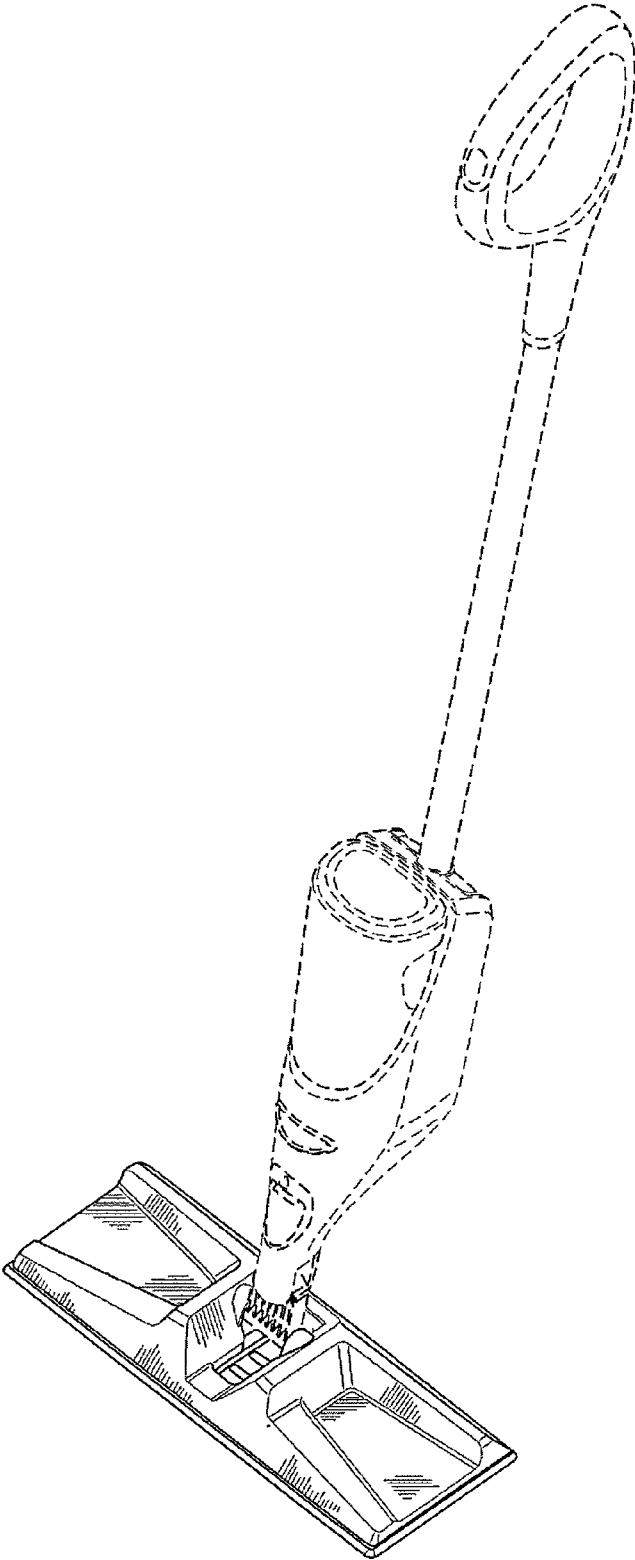
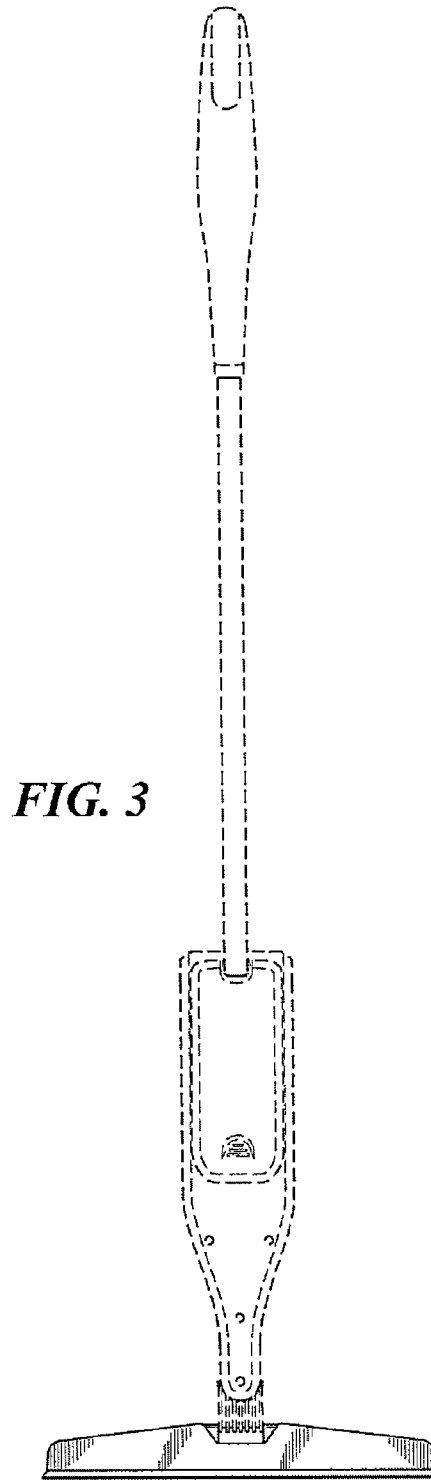
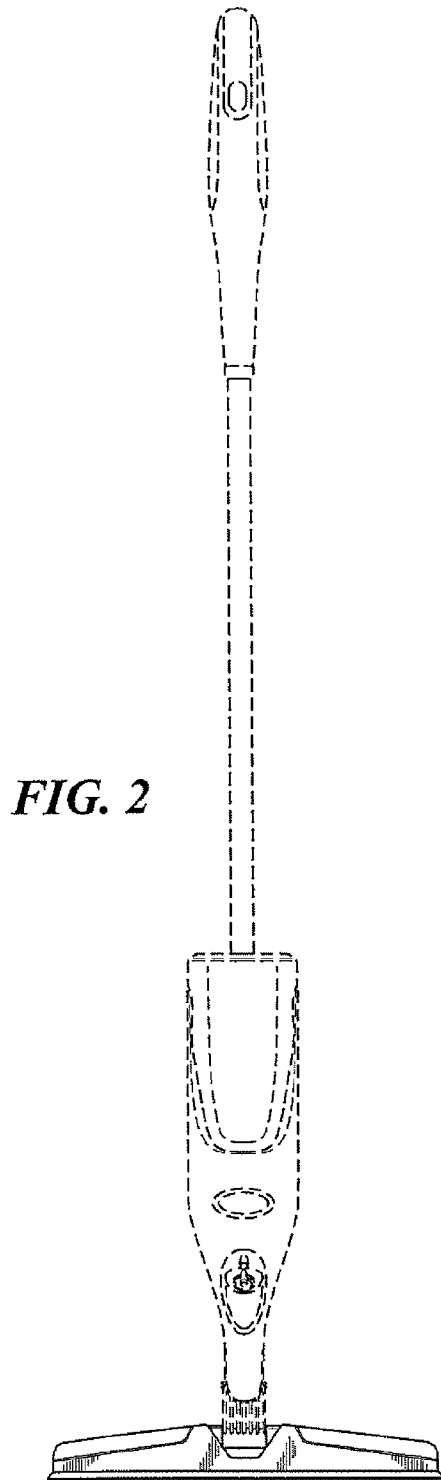
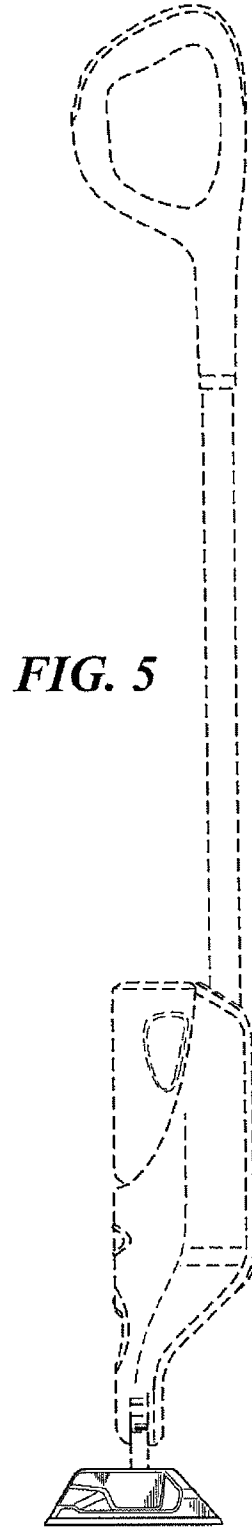
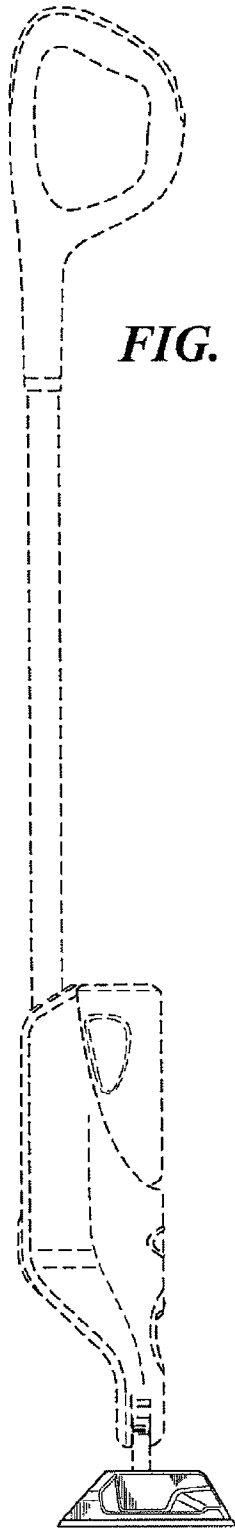

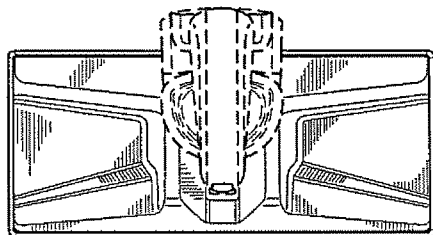

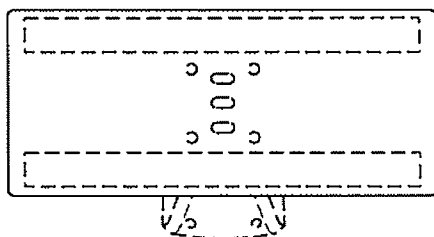
