The ornamental design for a light fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a first embodiment of a light fixture;  
 FIG. 2 is a top plan view of the light fixture of FIG. 1;  
 FIG. 3 is a side elevation view of the light fixture of FIG. 1;  
 FIG. 4 is a bottom plan view of the light fixture of FIG. 1;  
 FIG. 5 is a front elevation view of a second embodiment of a light fixture;  
 FIG. 6 is a top plan view of the light fixture of FIG. 5;  
 FIG. 7 is a side elevation view of the light fixture of FIG. 5;  
 FIG. 8 is a bottom plan view of the light fixture of FIG. 6;  
 FIG. 9 is a front elevation view of a third embodiment of a light fixture;

 The broken lines shown on the drawings depict portions of the light fixture that form no part of the claimed design.

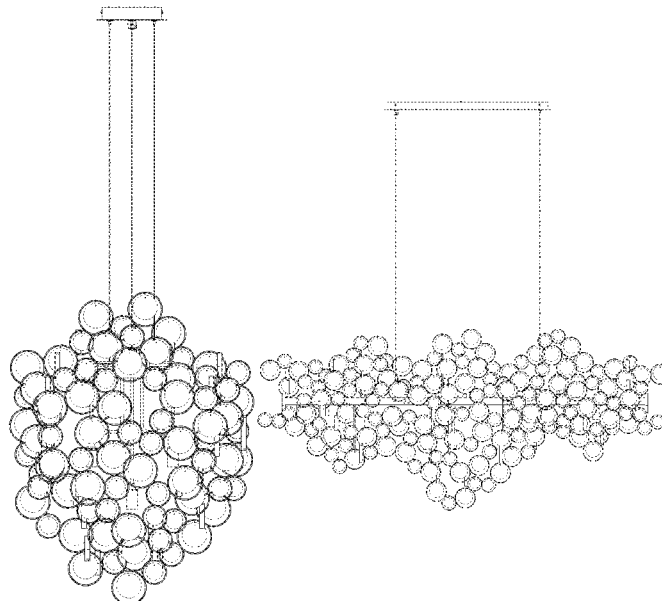

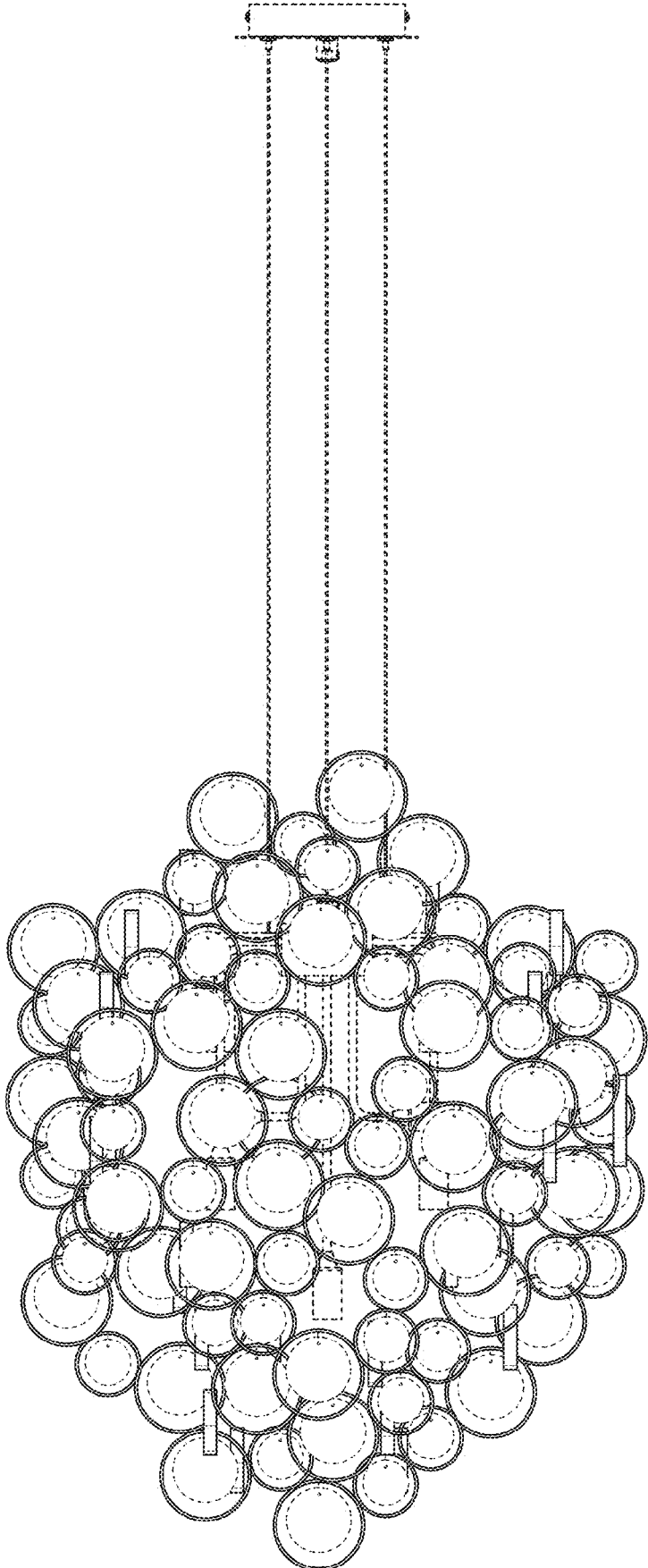

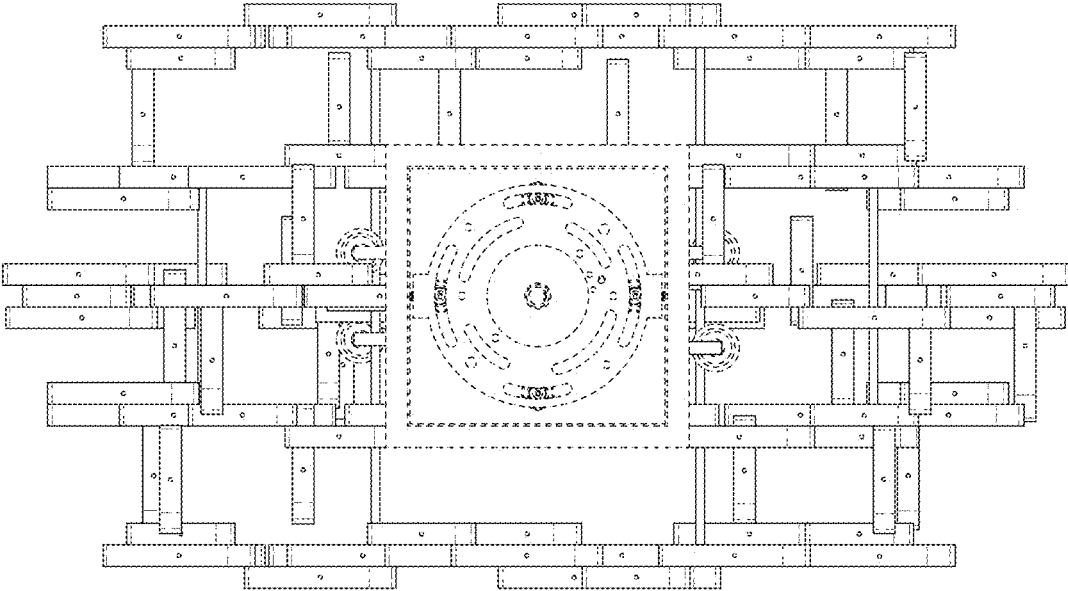

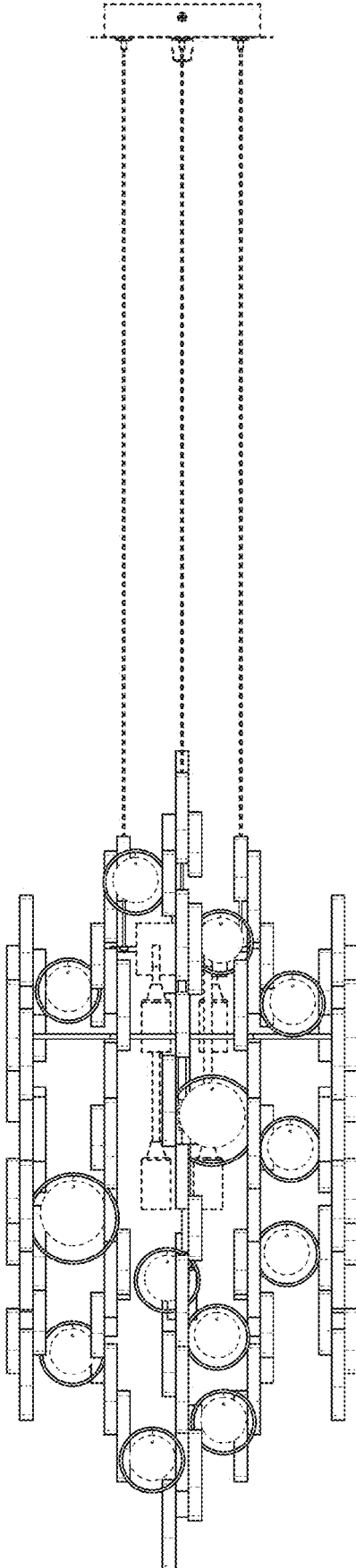

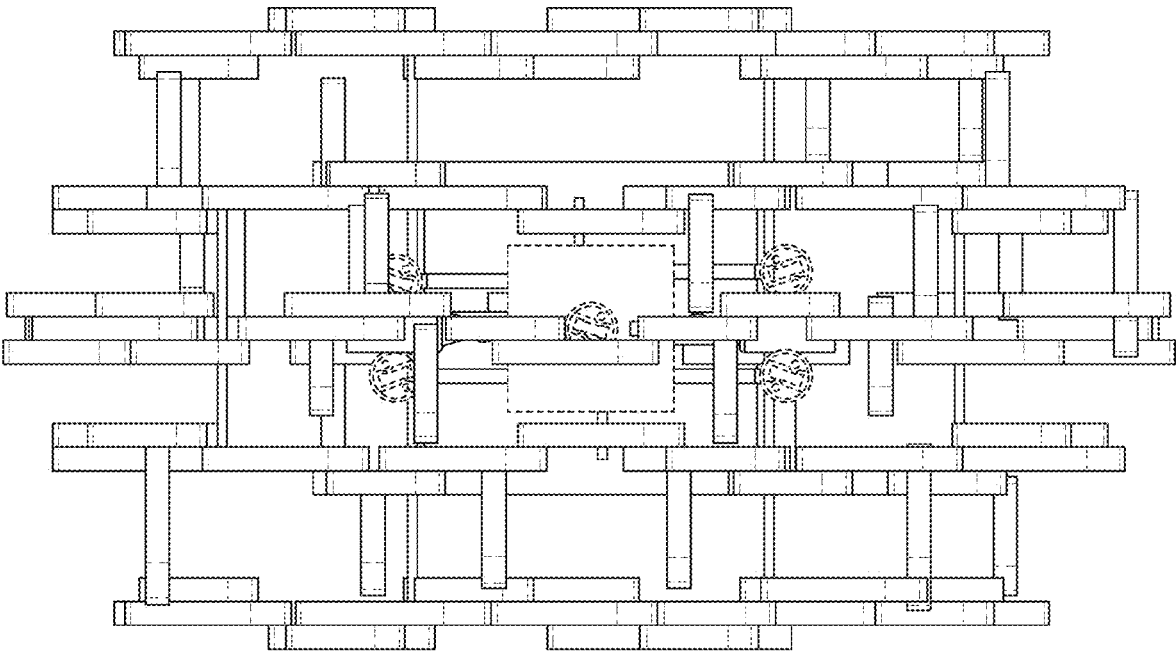

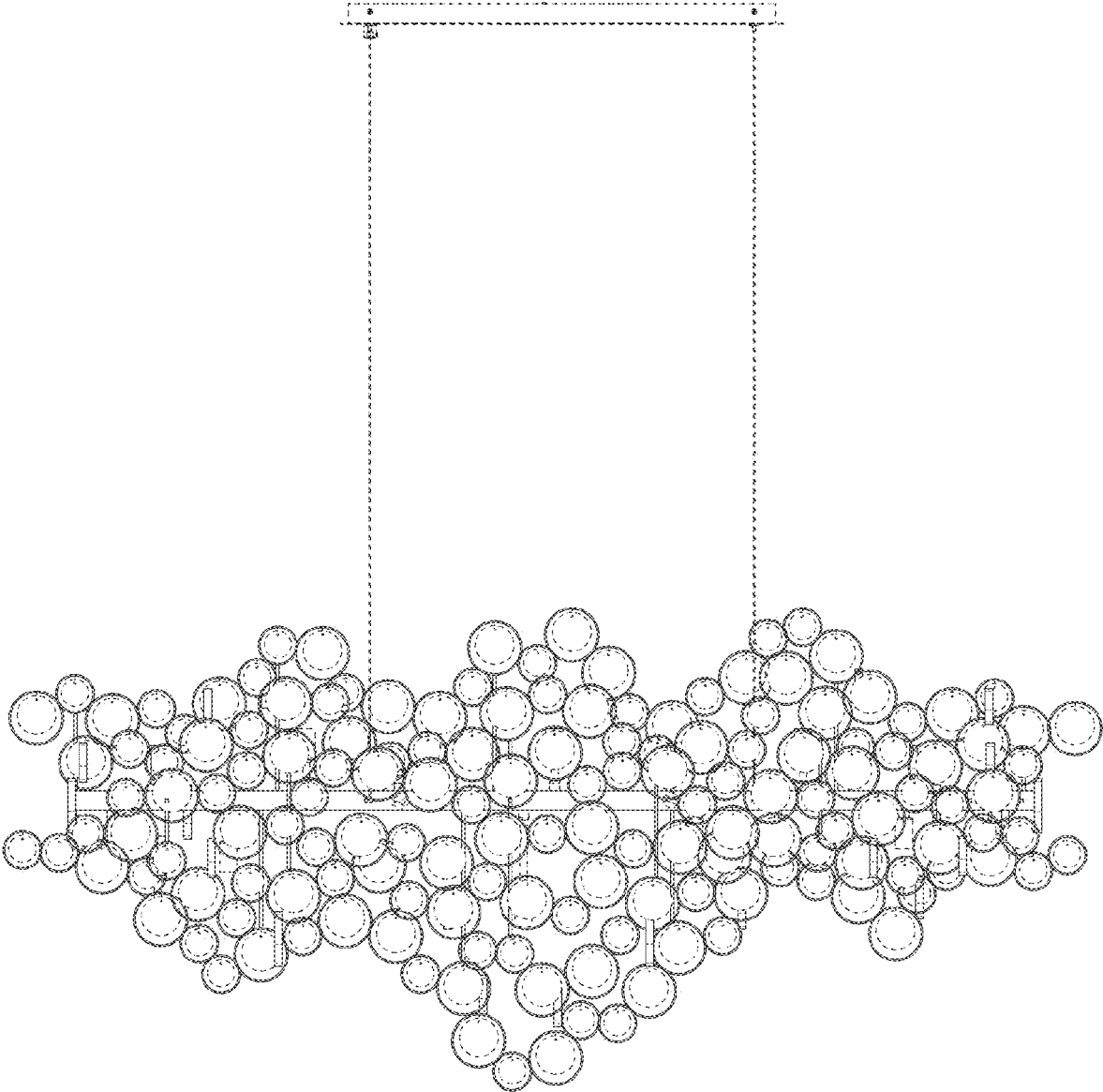

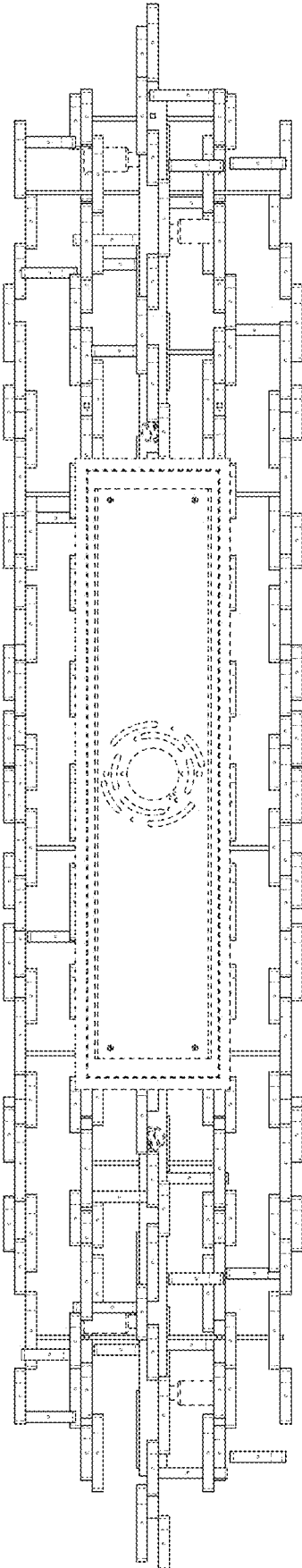

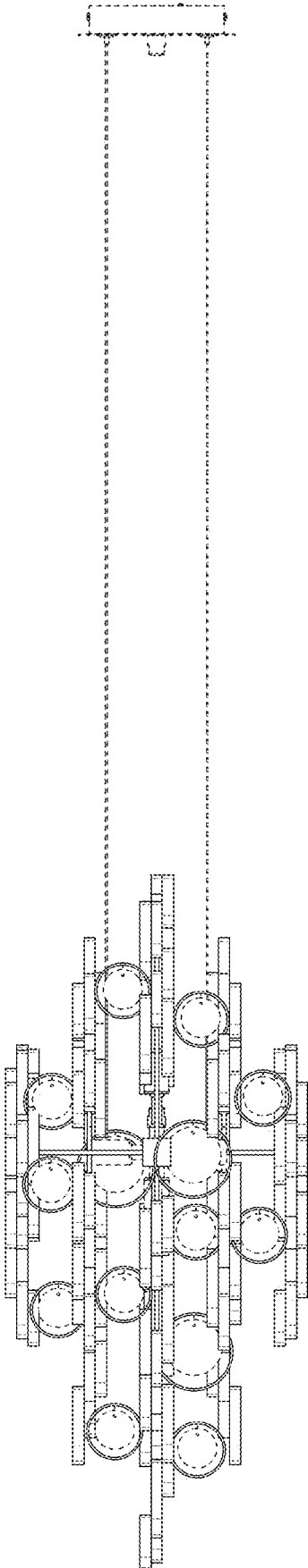

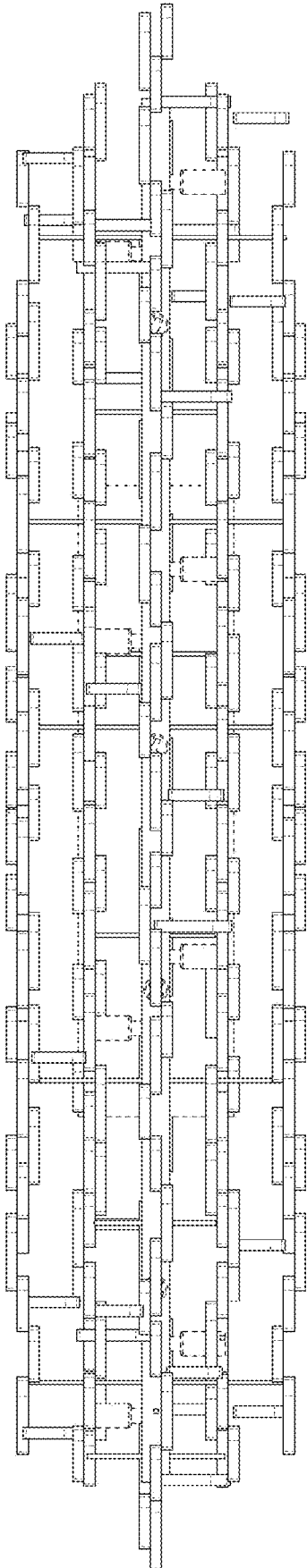

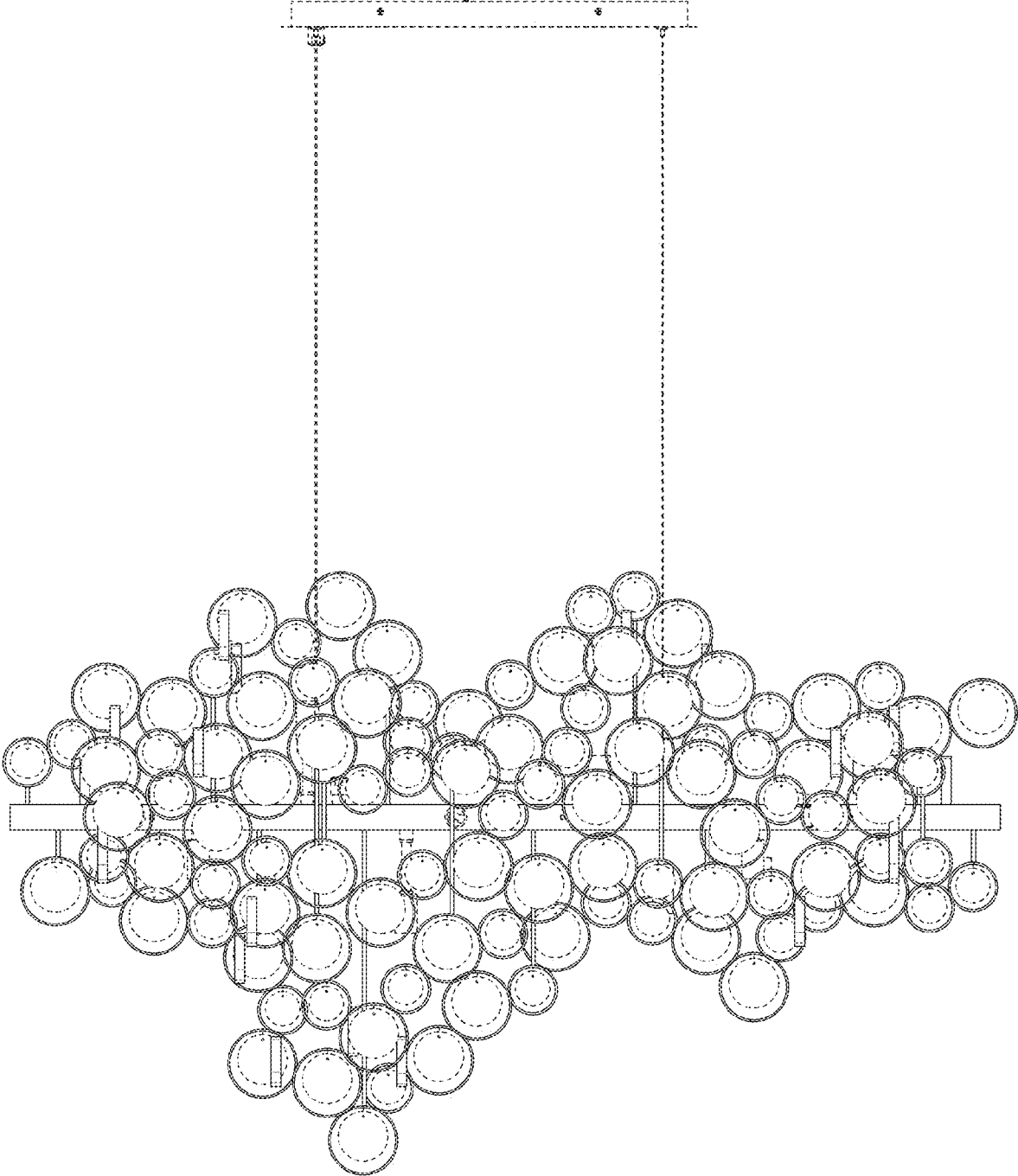

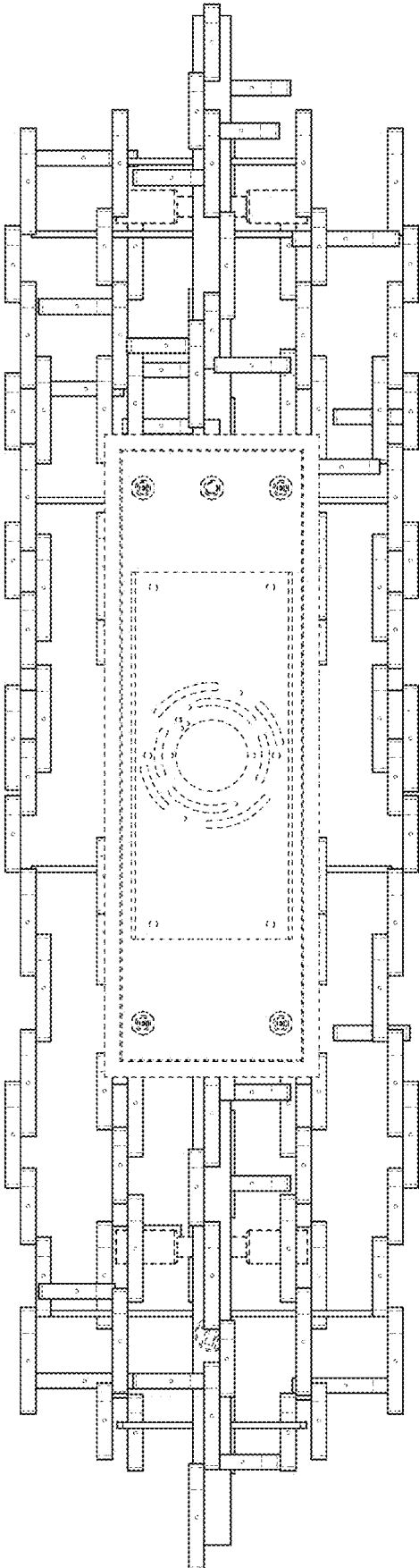

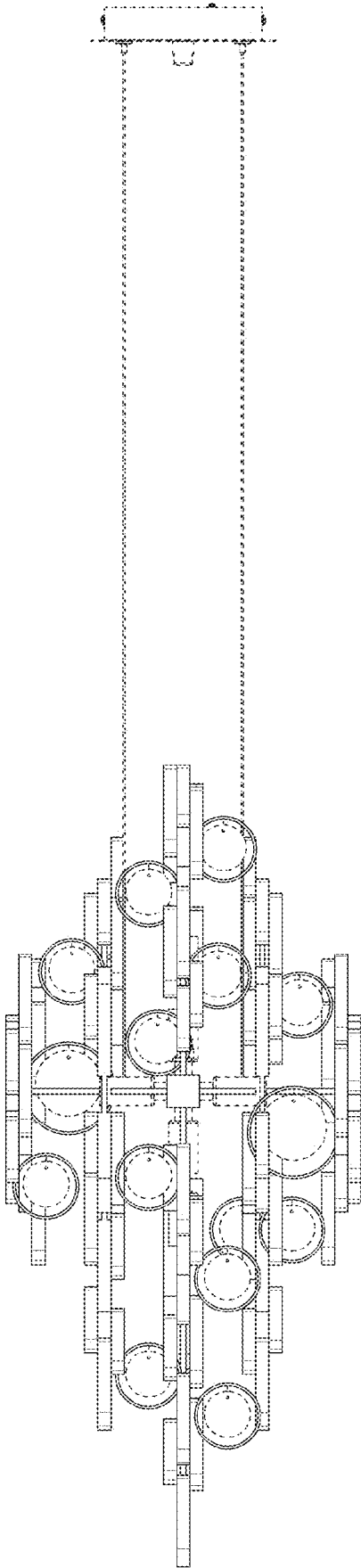

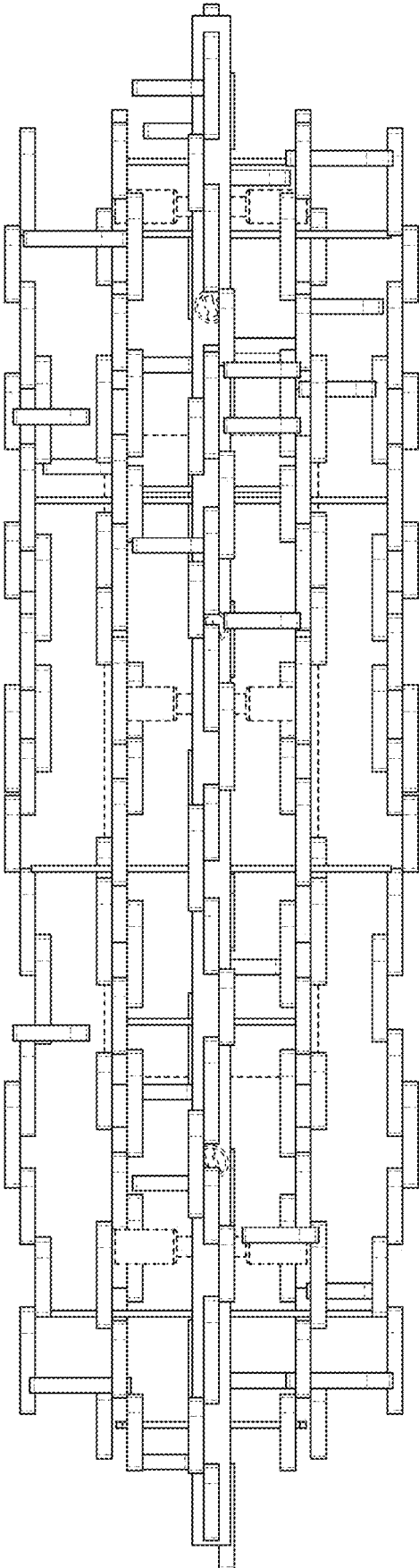
