(57) **CLAIM**


The ornamental design for a shoe rack, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe rack; FIG. 2 is a top plan view of the shoe rack of FIG. 1; FIG. 3 is a front elevational view of the shoe rack of FIG. 1; FIG. 4 is a left side elevational view of the shoe rack of FIG. 1; FIG. 5 is a rear elevational view of the shoe rack of FIG. 1; FIG. 6 is a right side elevation view of the shoe rack of FIG. 1; and, FIG. 7 is a bottom plan view of the shoe rack of FIG. 1. The broken lines shown represent unclaimed subject matter and form no part of the claimed design.














