The ornamental design for a label, as shown and described.

DESCRIPTION

FIG. 1 is a view of a first embodiment of a label showing our new design;
FIG. 2 is a view of the label shown in FIG. 1 on overall apparel;
FIG. 3 is a view of the label shown in FIG. 1 on glove apparel;
FIG. 4 is a view of the label shown in FIG. 1 on packaging for glove apparel of FIG. 3; and,
FIG. 5 is a view of a second embodiment of the label.
The broken lines are used to show environmental subject matter and form no part of the claimed design. The embodiment of FIG. 5 can be, for example, applied to the environmental subject matter of FIGS. 2-4.

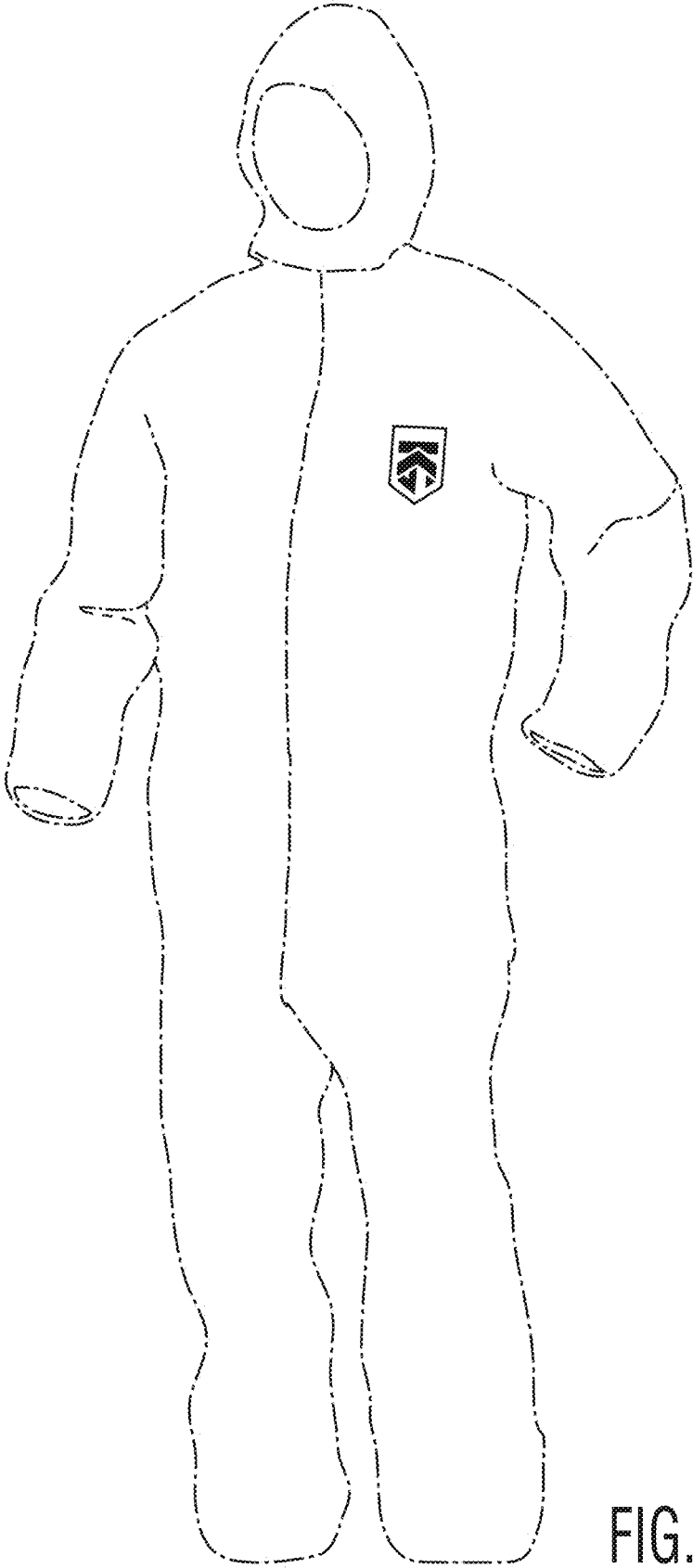

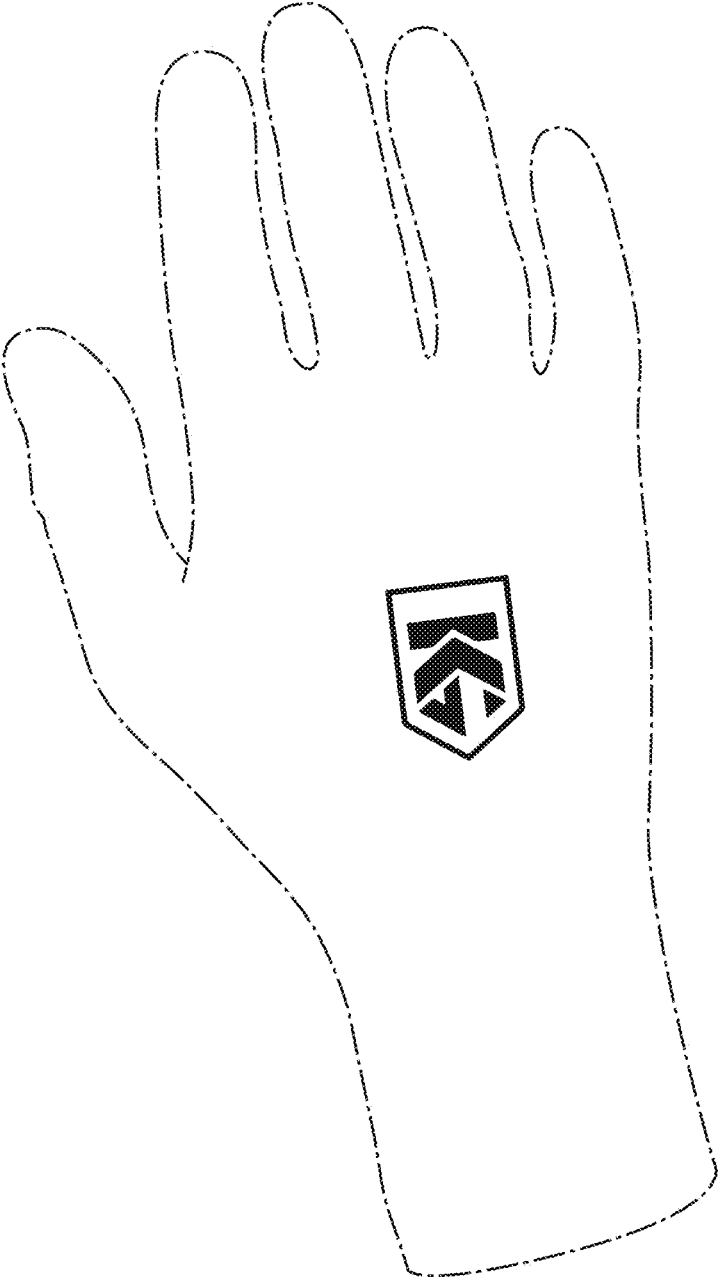

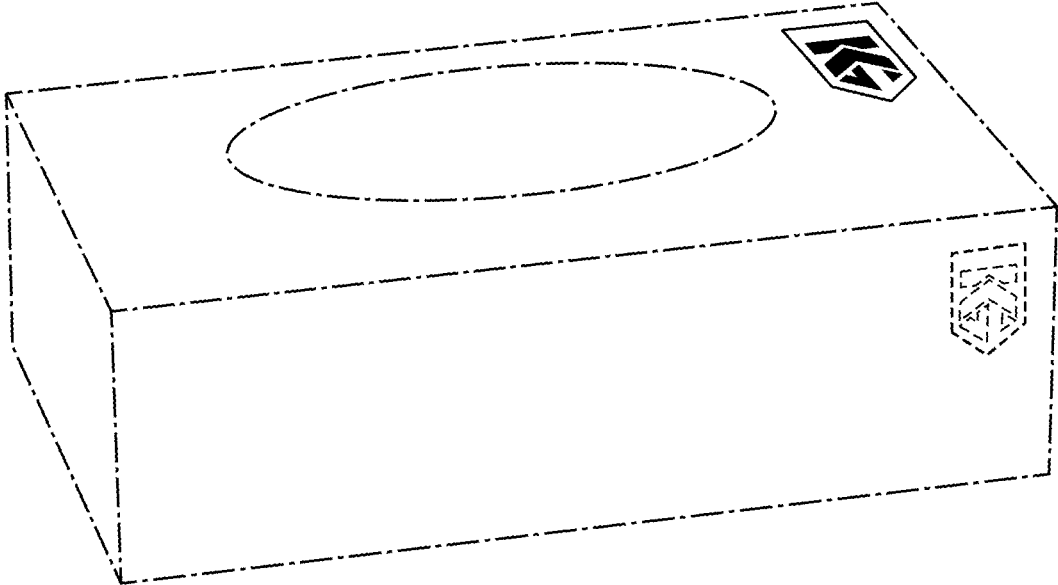

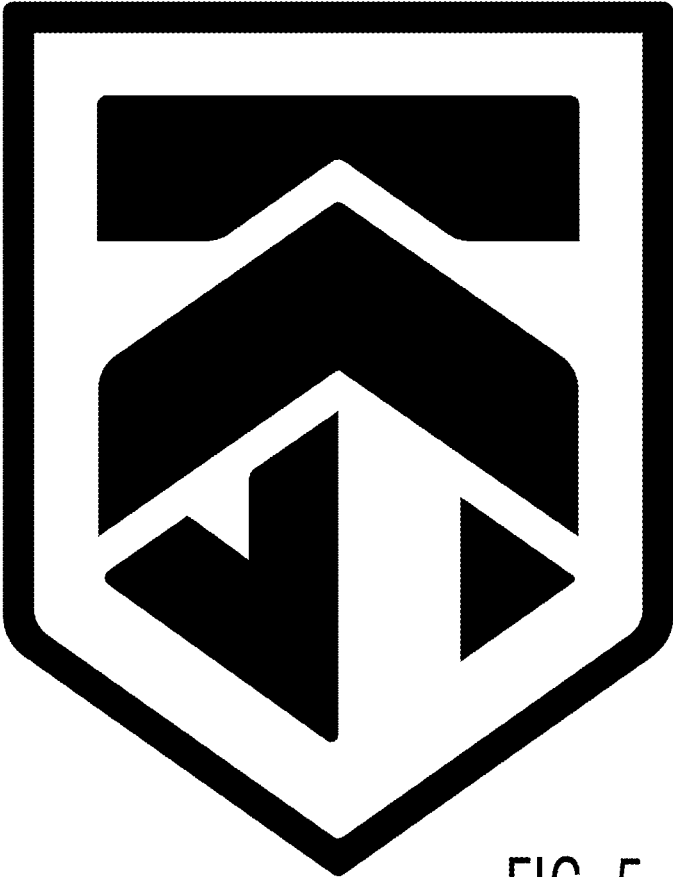
