
FIG. 1 is a top, front, left side perspective view of a collapsible, washable and reusable food and drink container showing the design in an unfilled condition.

FIG. 8 is a bottom, back, right side perspective view thereof.
FIG. 9 is a front plan view thereof, the back plan view being a mirror image thereof.
FIG. 10 is a top plan view thereof.
FIG. 11 is a bottom plan view thereof; and,
FIG. 12 is a right side elevational view thereof, the left side being a mirror image thereof.
Shading lines are used to show solid structures and are not intended to indicate surface decoration.
The dotted lines shown in FIGS. 1-12 showing the spout and cap are included for the purpose of illustrating portions of the container that form no part of the claimed design.
























