DESCRIPTION

FIG. 1 is a frontal isometric view showing our combined bench and decorative storage box;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a side elevational view thereof, as viewed either from the front or rear of FIG. 1;
 FIG. 4 is an end view thereof, as viewed either from the left side or right side of FIG. 3; and,

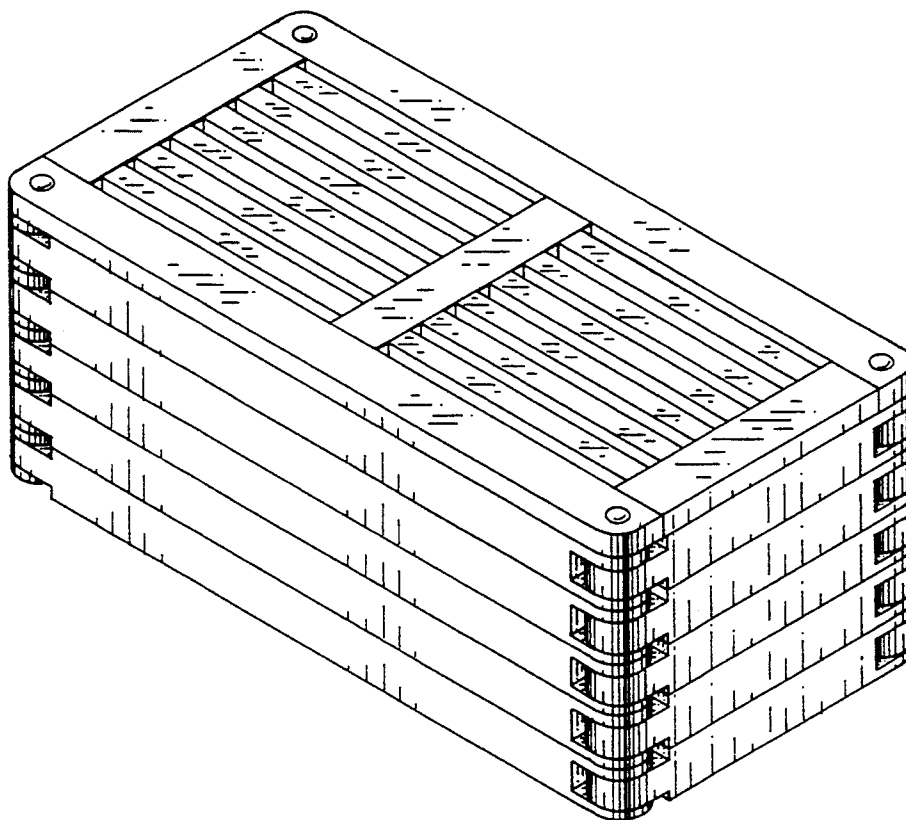

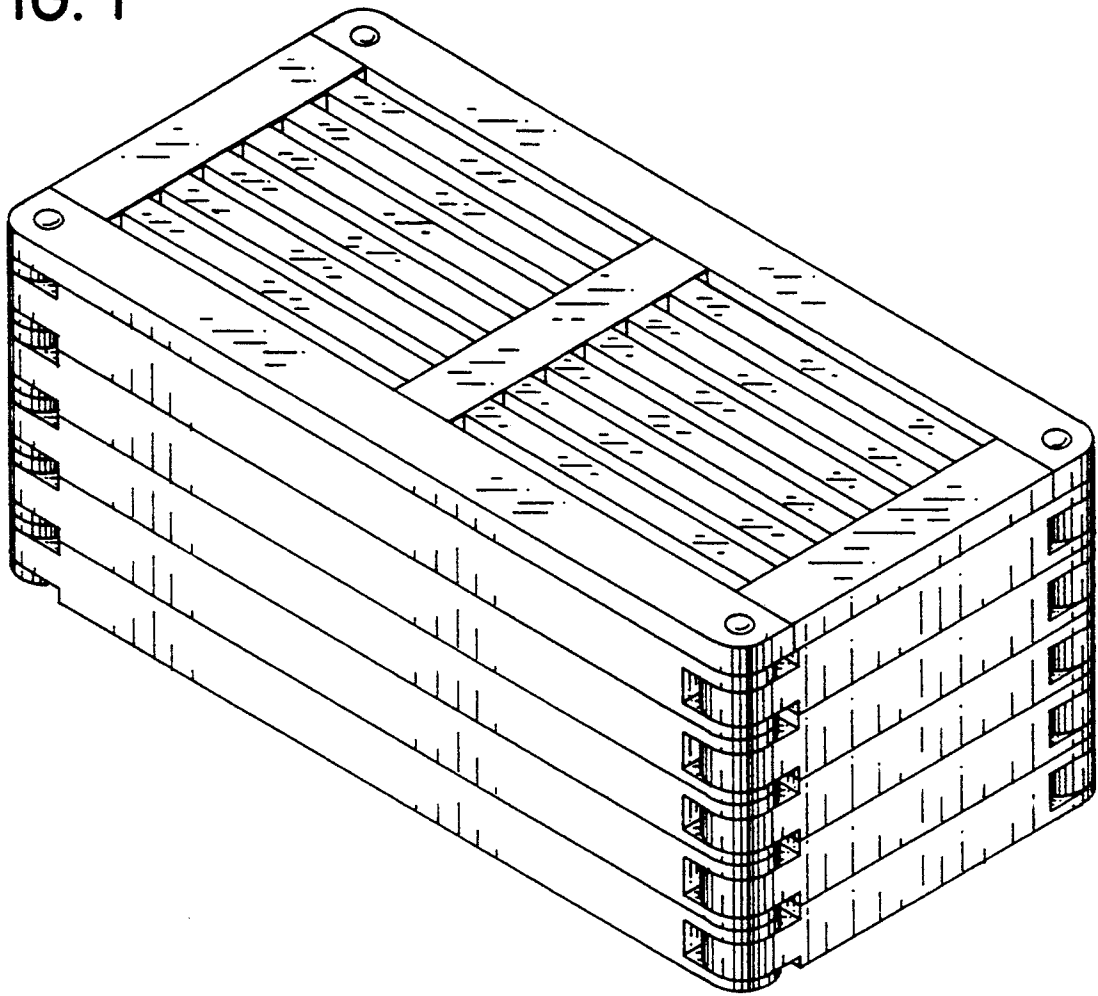

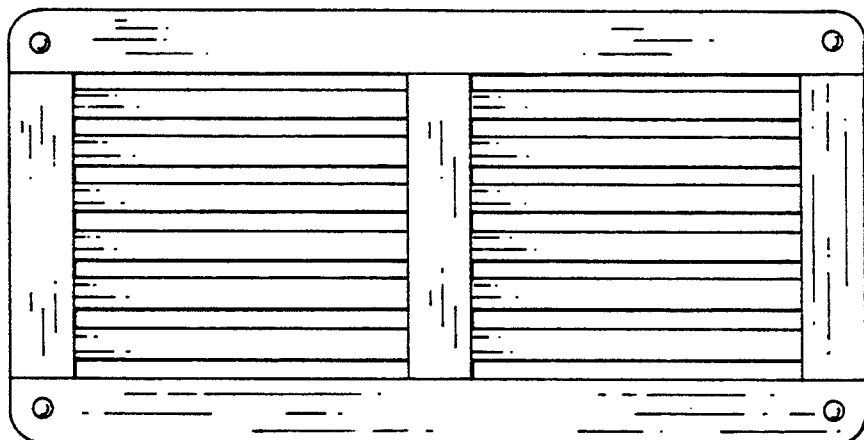

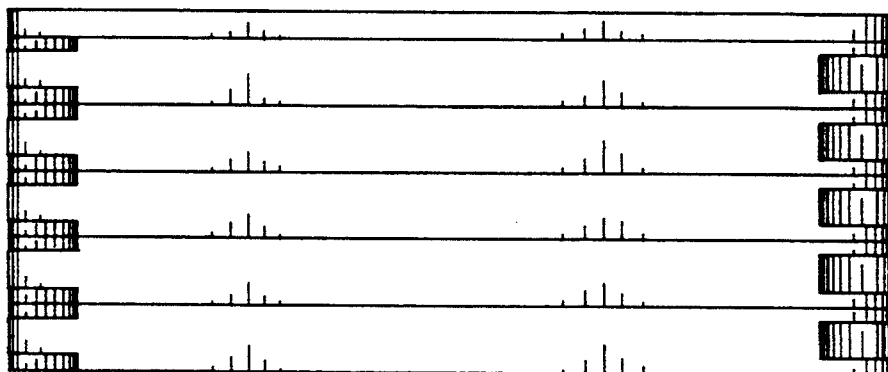

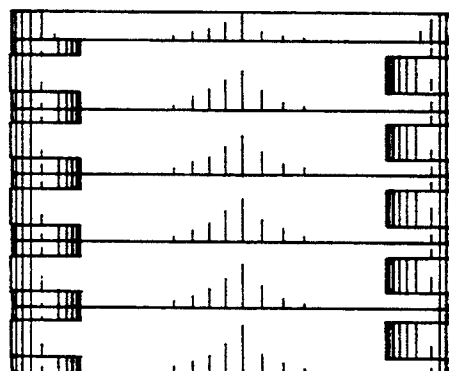
