(57) **CLAIM**

The ornamental design for a fragrance bottle and cap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a first embodiment of a fragrance bottle and cap, embodying our new design;

FIG. 2 is a front elevation view thereof, a rear elevation view being identical thereto;

FIG. 3 is a right side elevation view thereof, a left side elevation view being identical thereto;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top, front and right side perspective view of a second embodiment of a fragrance bottle and cap, embodying our new design;

FIG. 7 is a front elevation view thereof, a rear elevation view being identical thereto;

FIG. 11 is a top, front and right side perspective view of a third embodiment of a fragrance bottle and cap, embodying our new design;


FIG. 12 is a front elevation view thereof, a rear elevation view being identical thereto;






























