The ornamental design for an electronic game machine supported on a base stand, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and left perspective view of an electronic game machine supported on a base stand showing our new design;

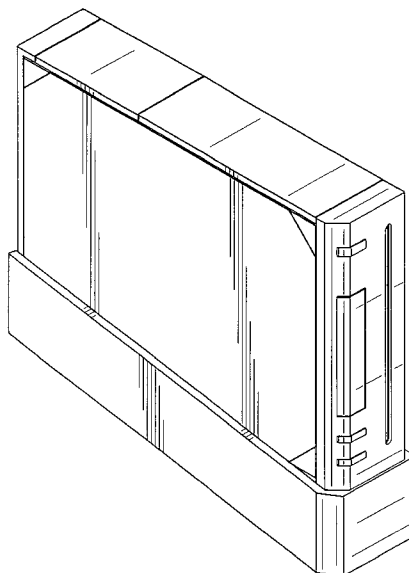

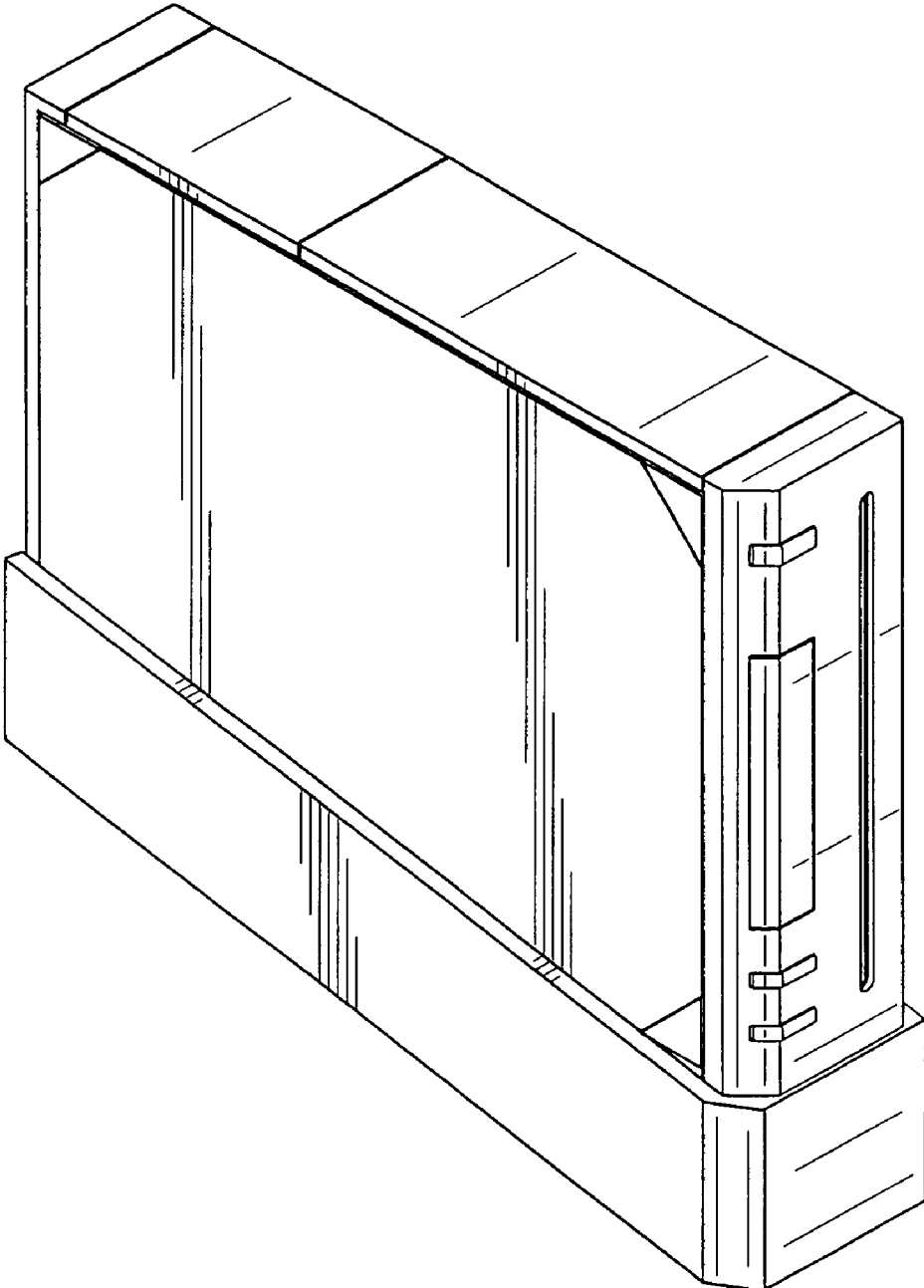

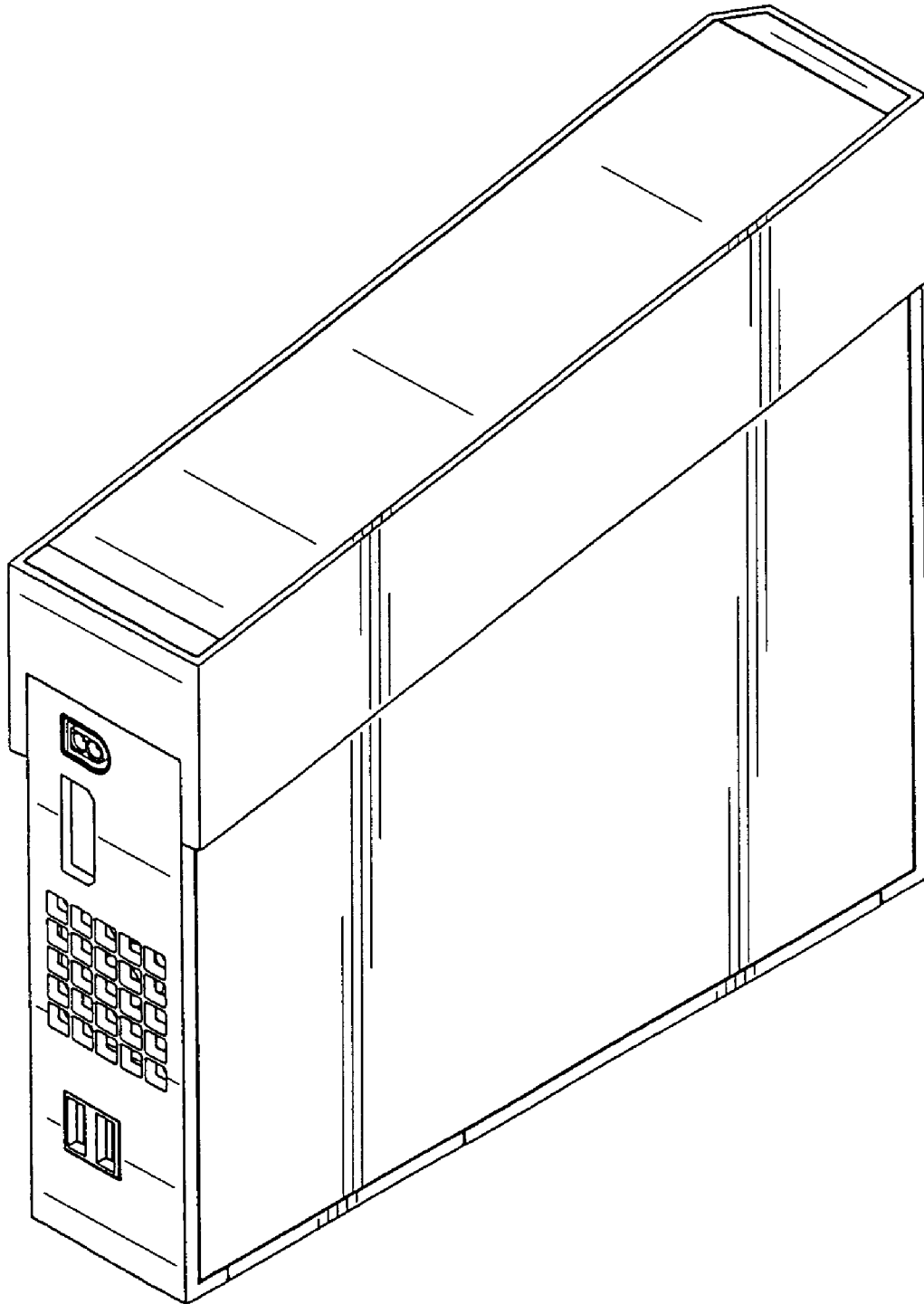

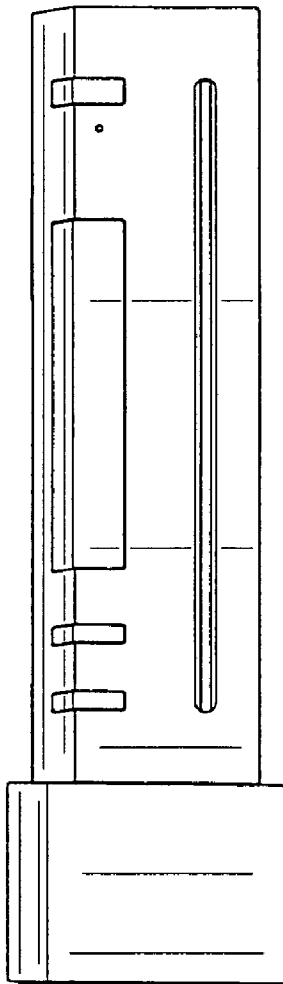

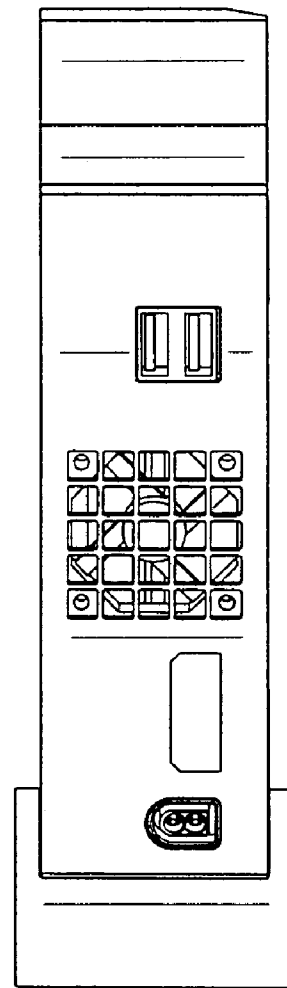

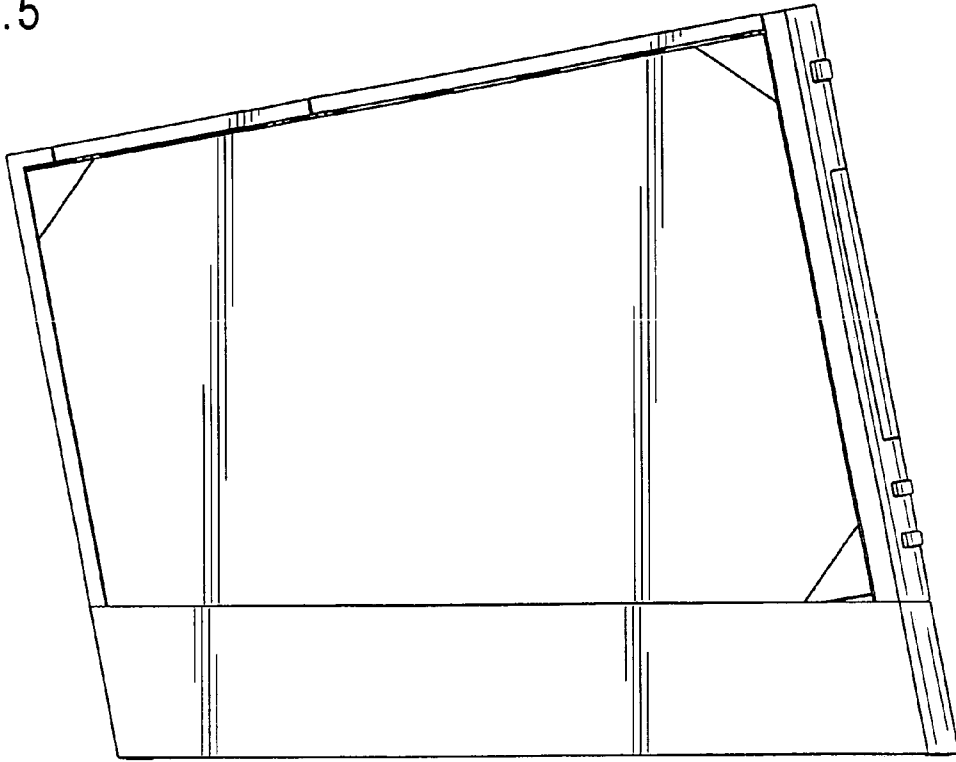

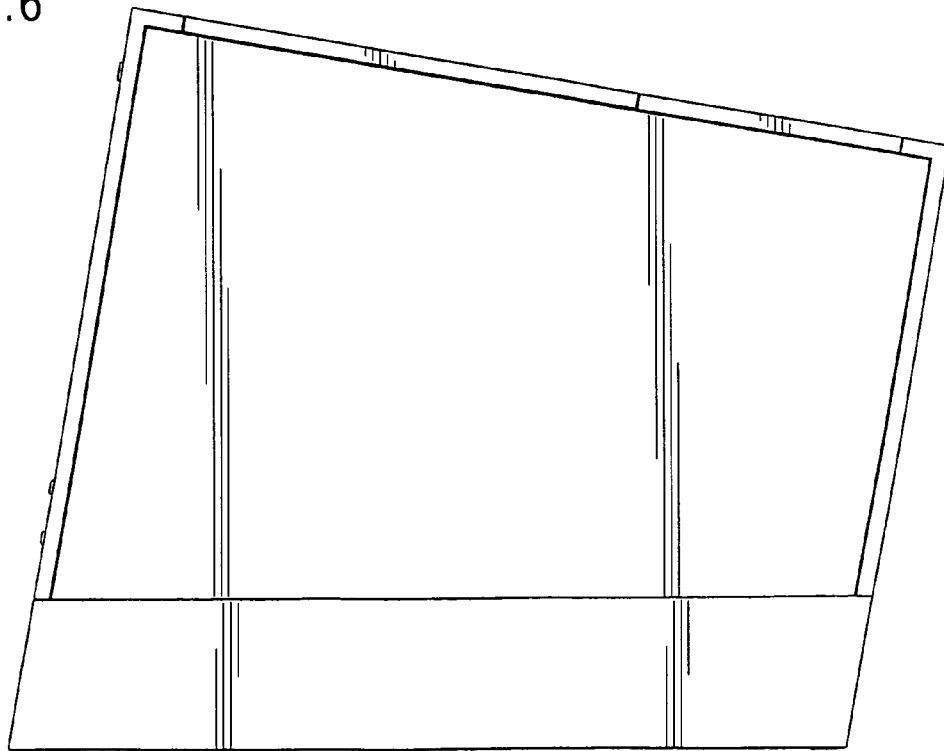

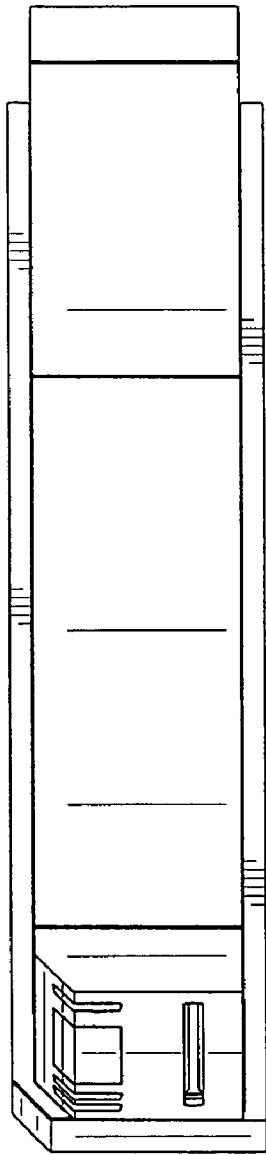
