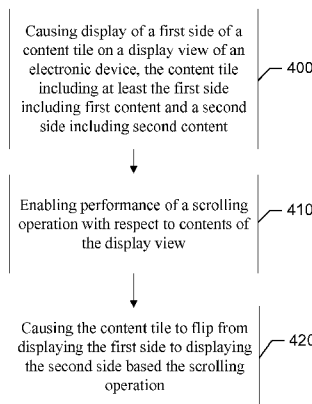

(57) Abstract: A method for providing content flipping based on a scroll operation may include causing display of a first side of a content tile on a display view of an electronic device where the content tile includes at least the first side including first content and a second side including second content, enabling performance of a scrolling operation with respect to contents of the display view, and causing the content tile to flip from displaying the first side to displaying the second side based on the scrolling operation. An apparatus and computer program product corresponding to the method are also provided.
