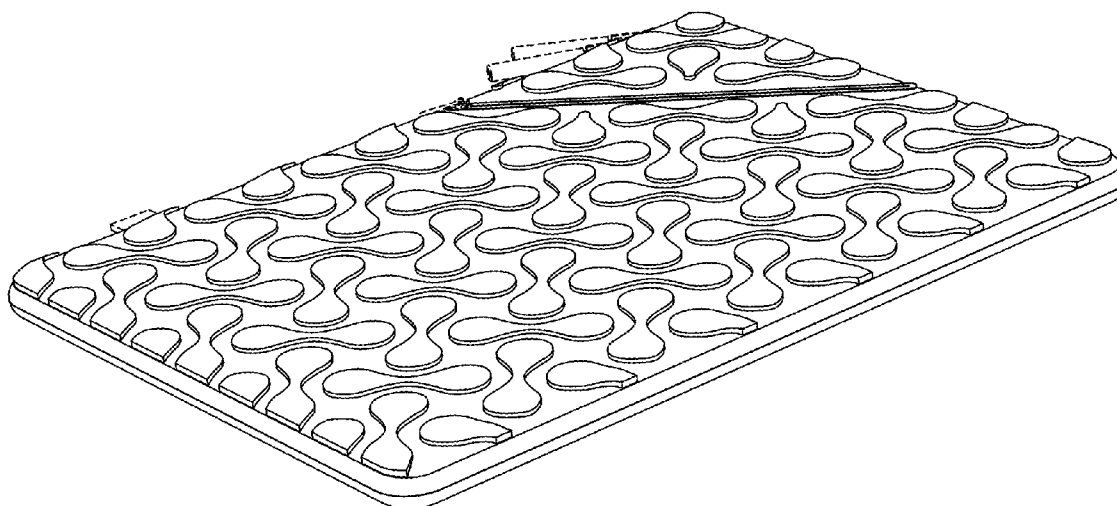
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a case for multimedia
portable player showing my new design;
FIG. 2 is a rear elevational view thereof;

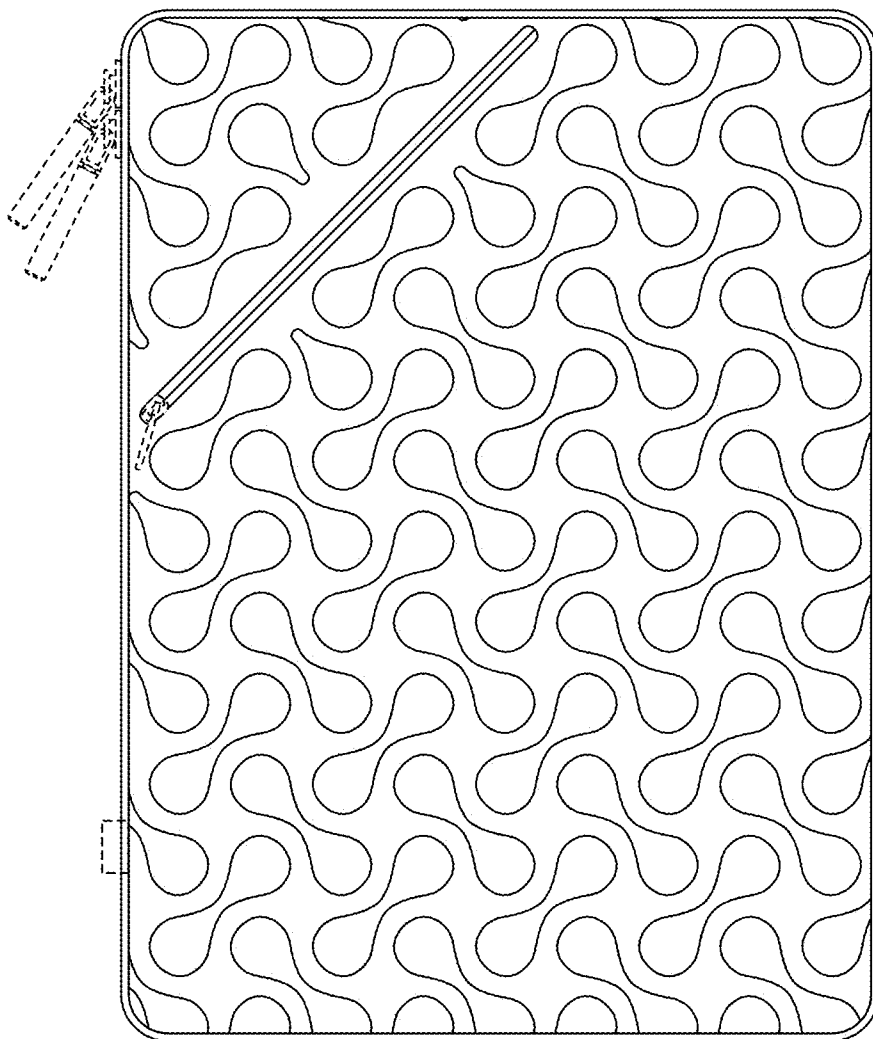

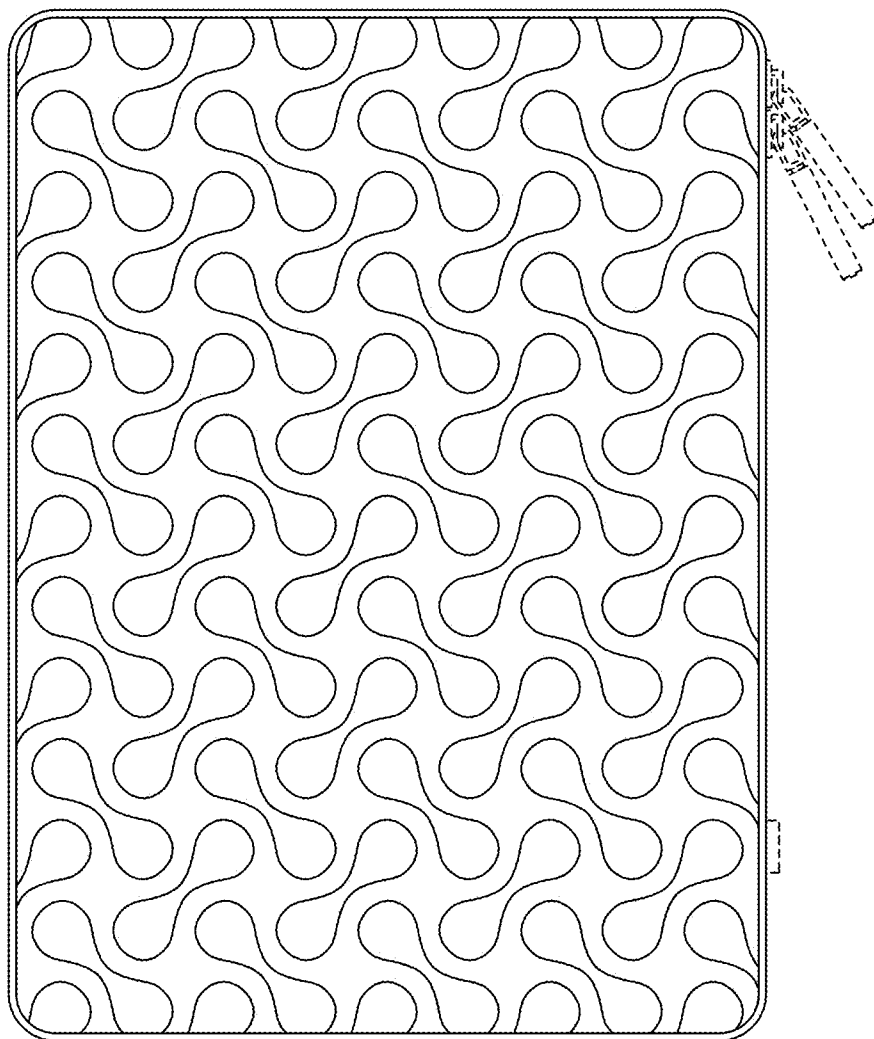

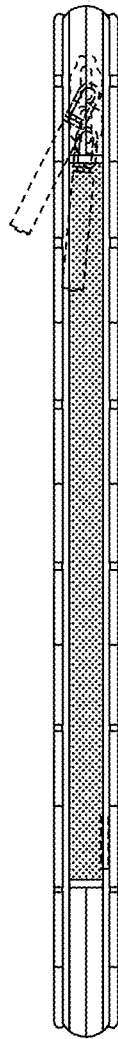

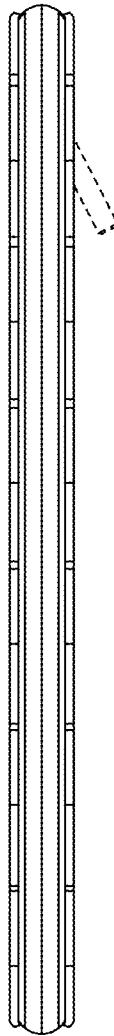

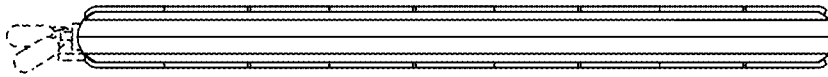

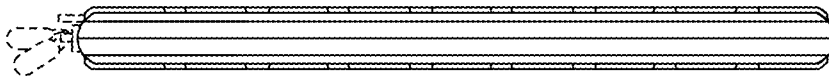

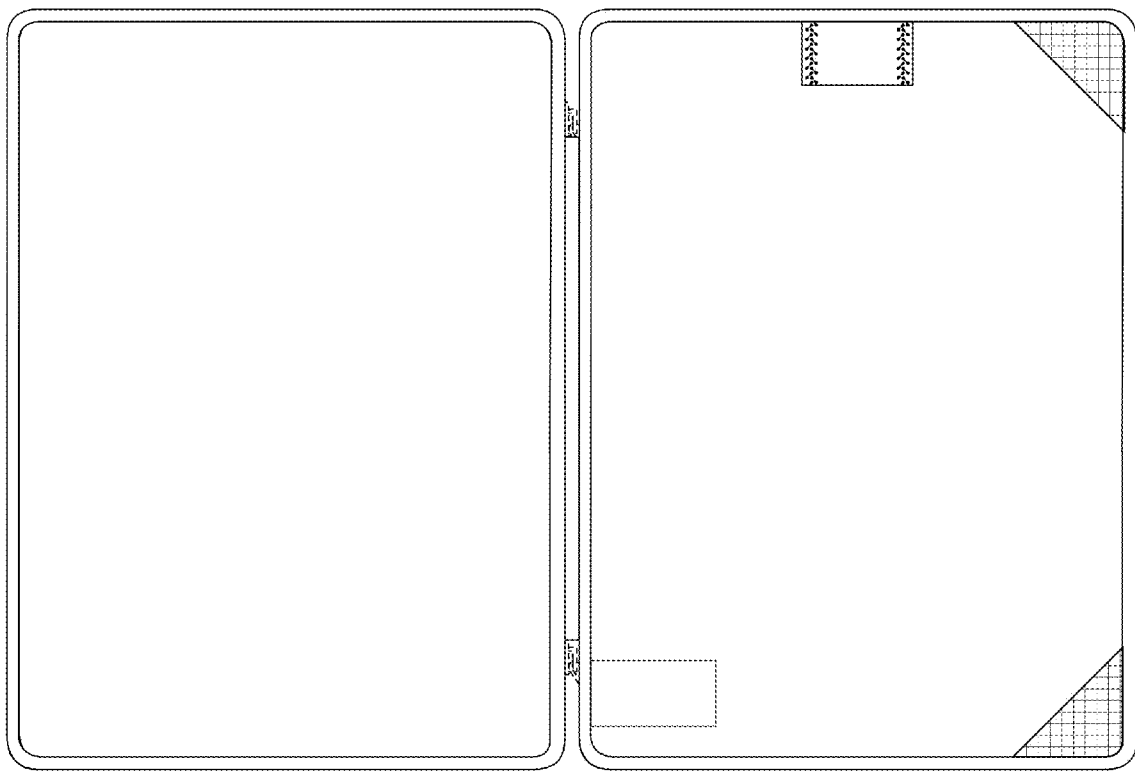

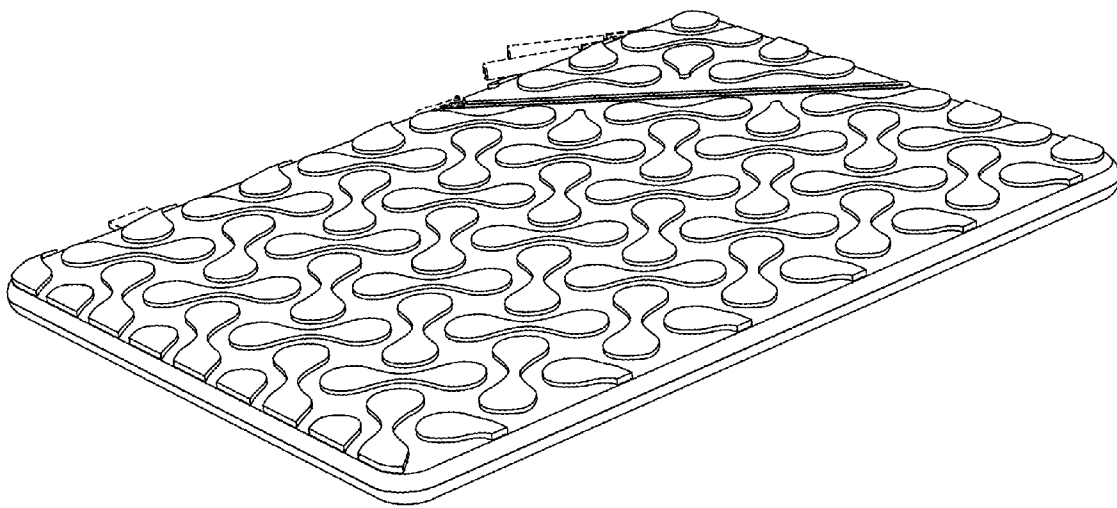
