(57) **CLAIM**
The ornamental design of a magnetic display holding channel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front, top, right side of the magnetic display holding channel showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof, the back elevational view being identical;
FIG. 5 is a left side elevational view thereof; and,
FIG. 6 is a right side elevational view thereof.

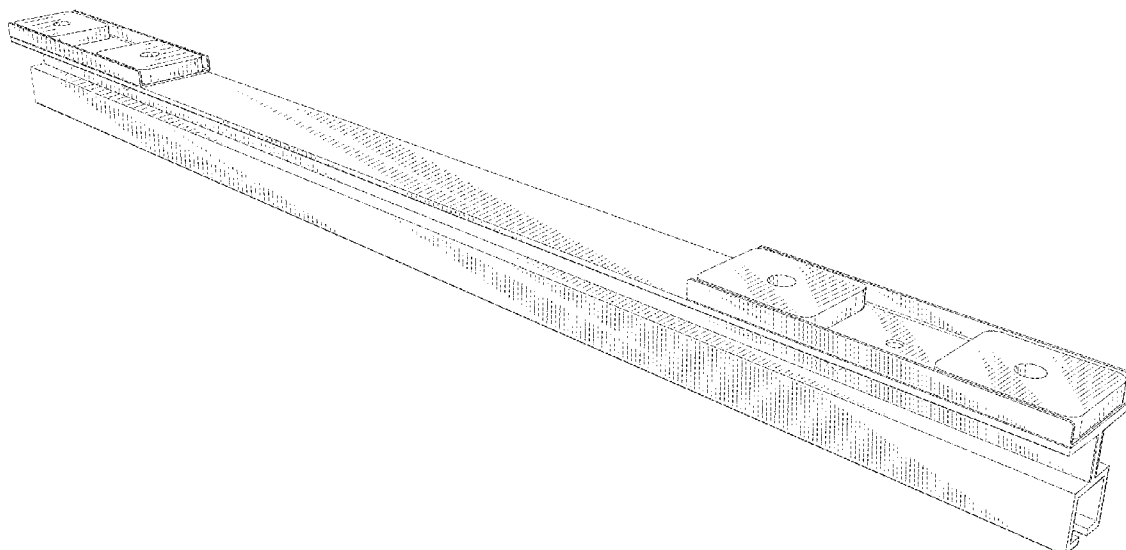

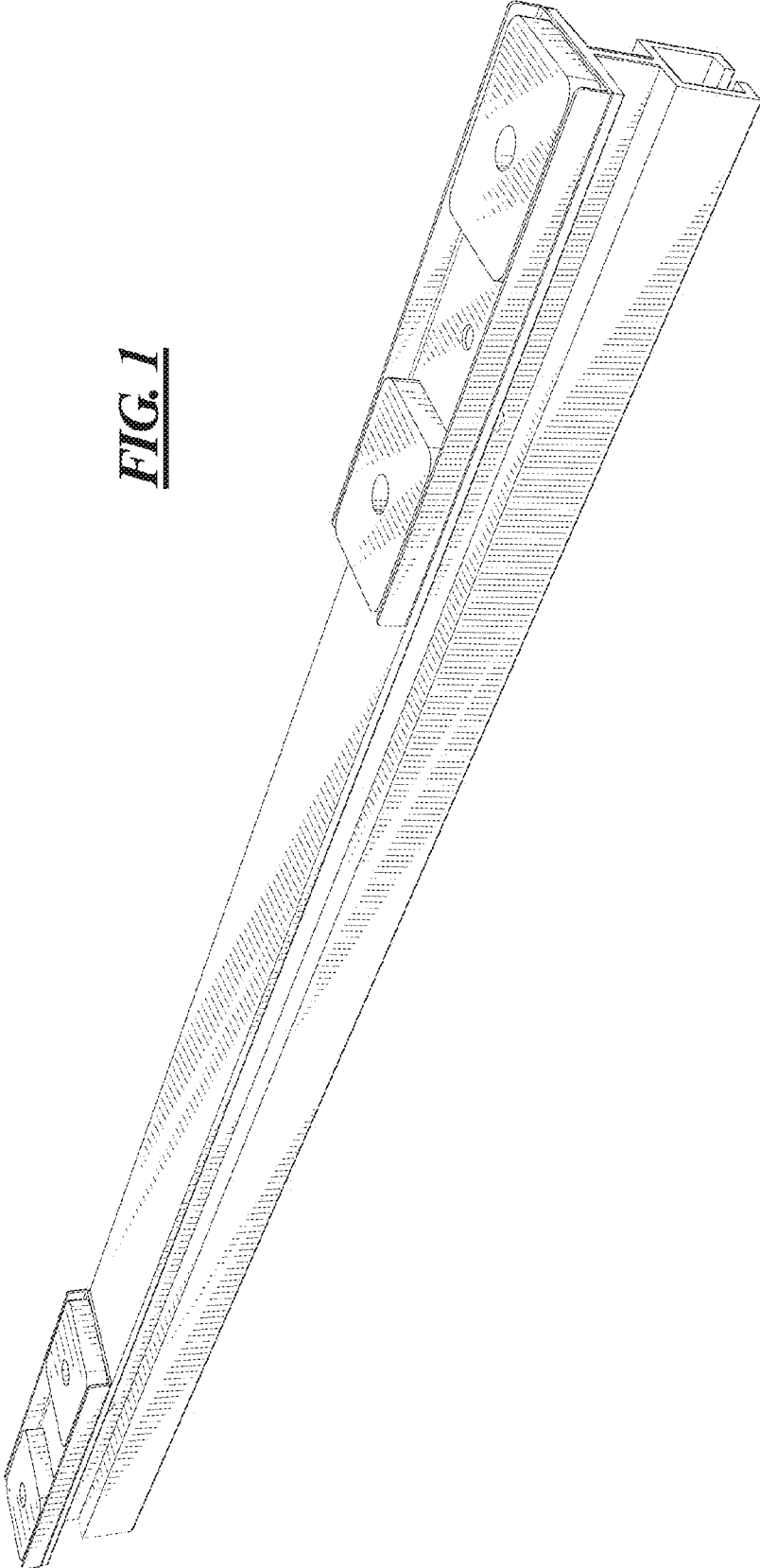

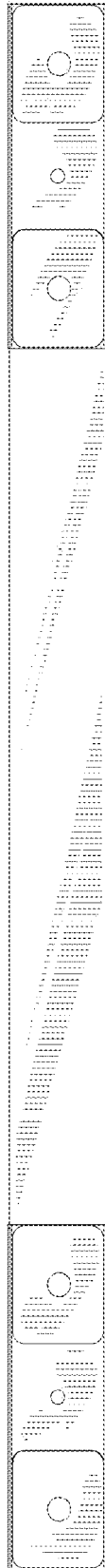

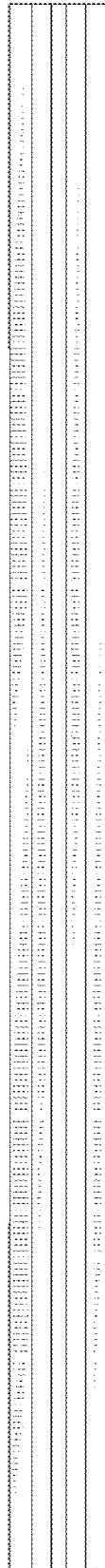

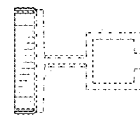
