The ornamental design for a shirt, as shown and described.

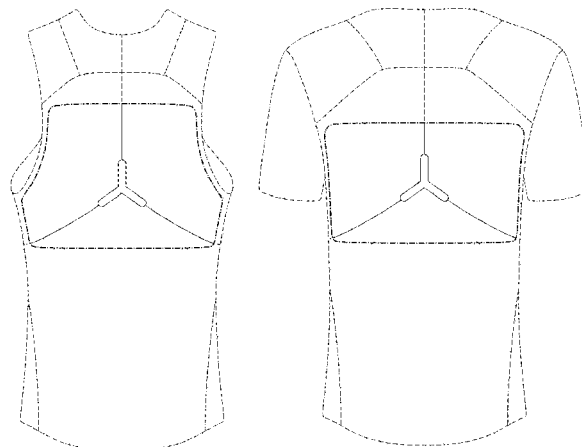
DESCRIPTION

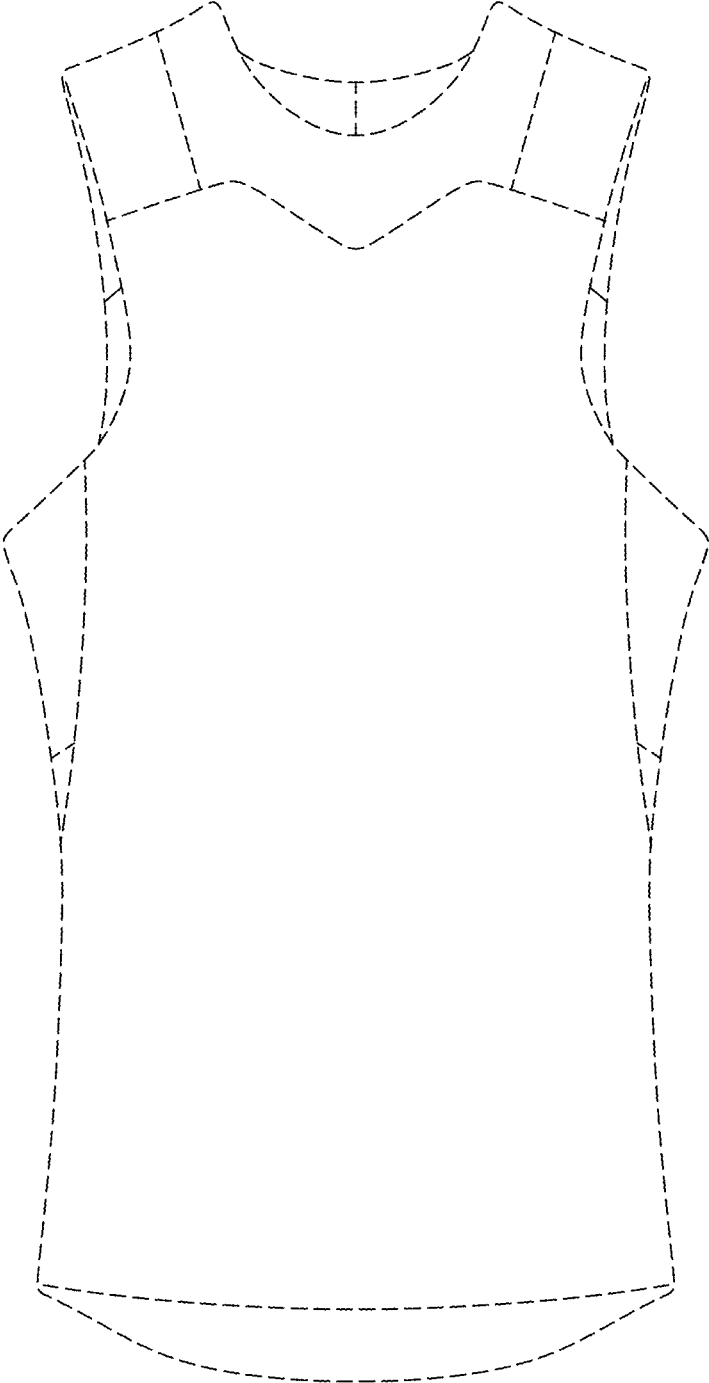

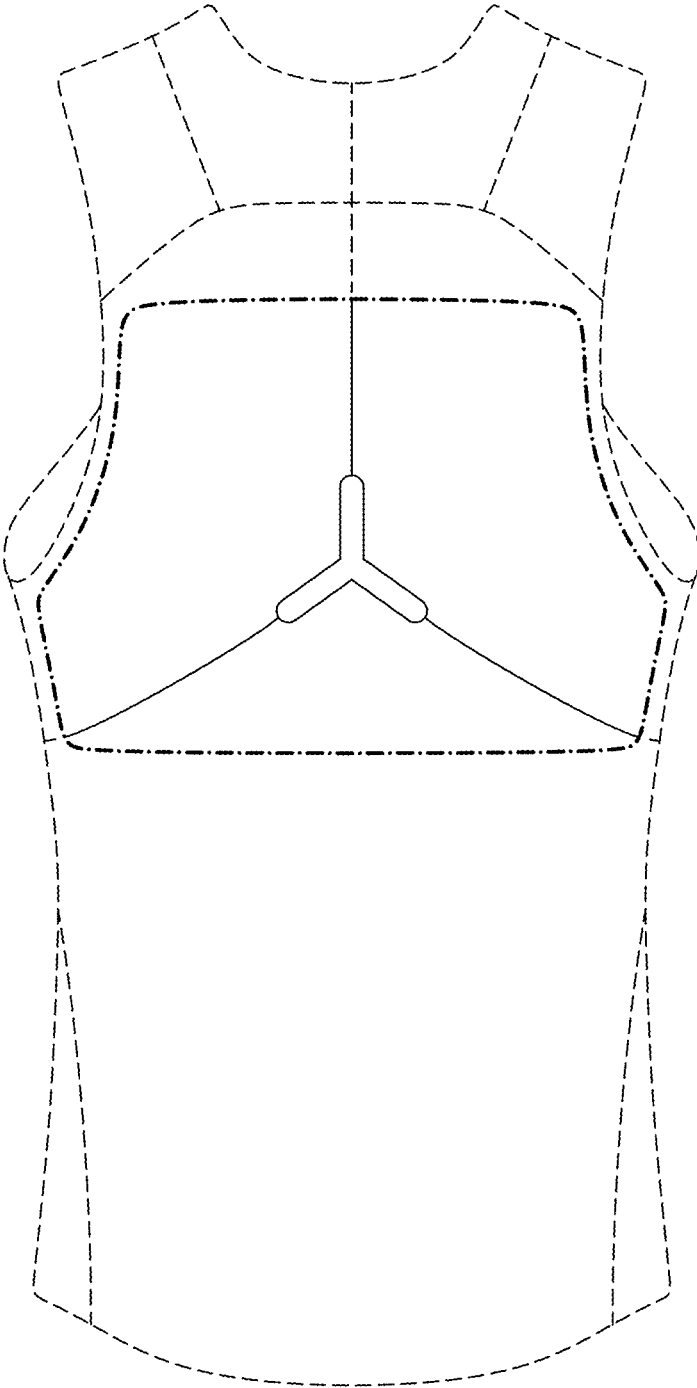

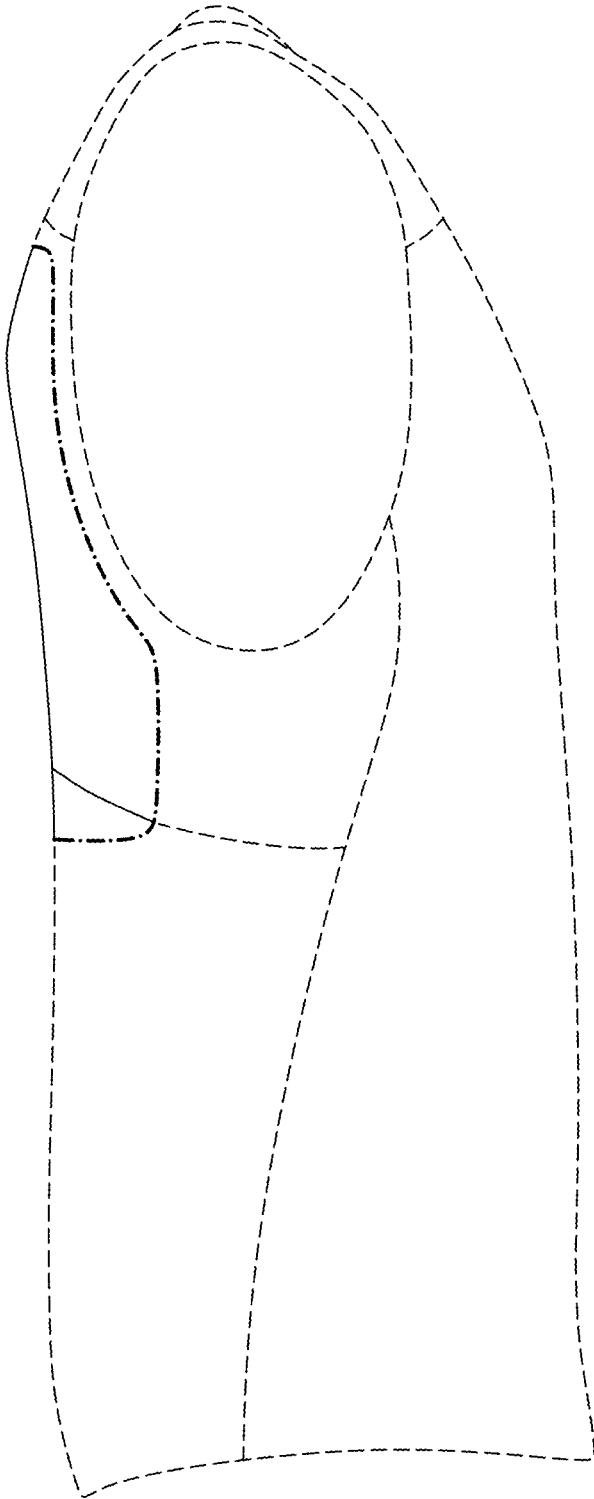
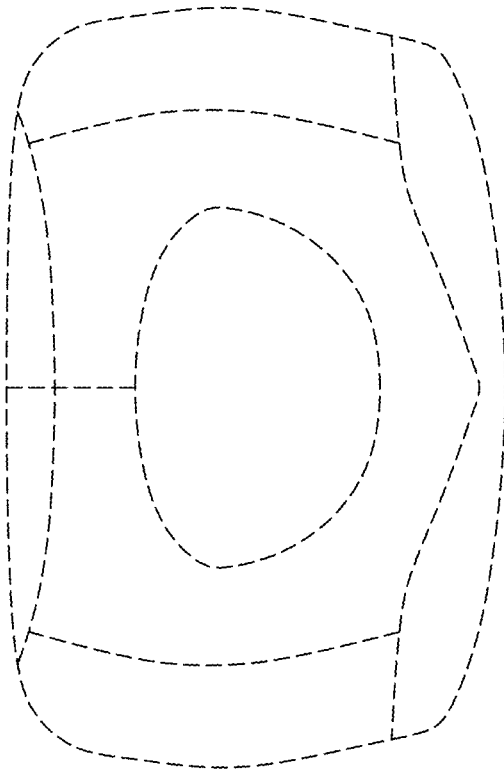

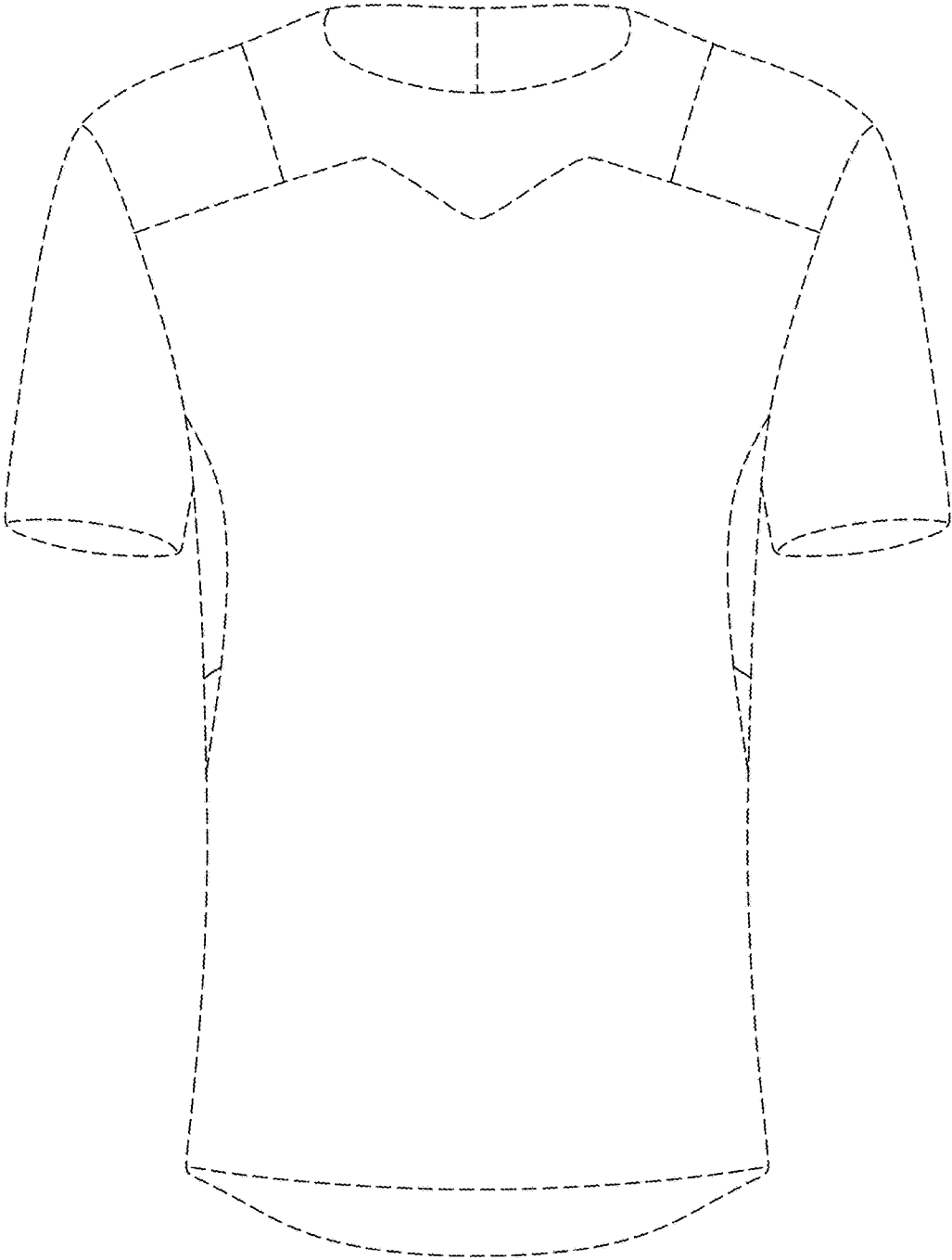

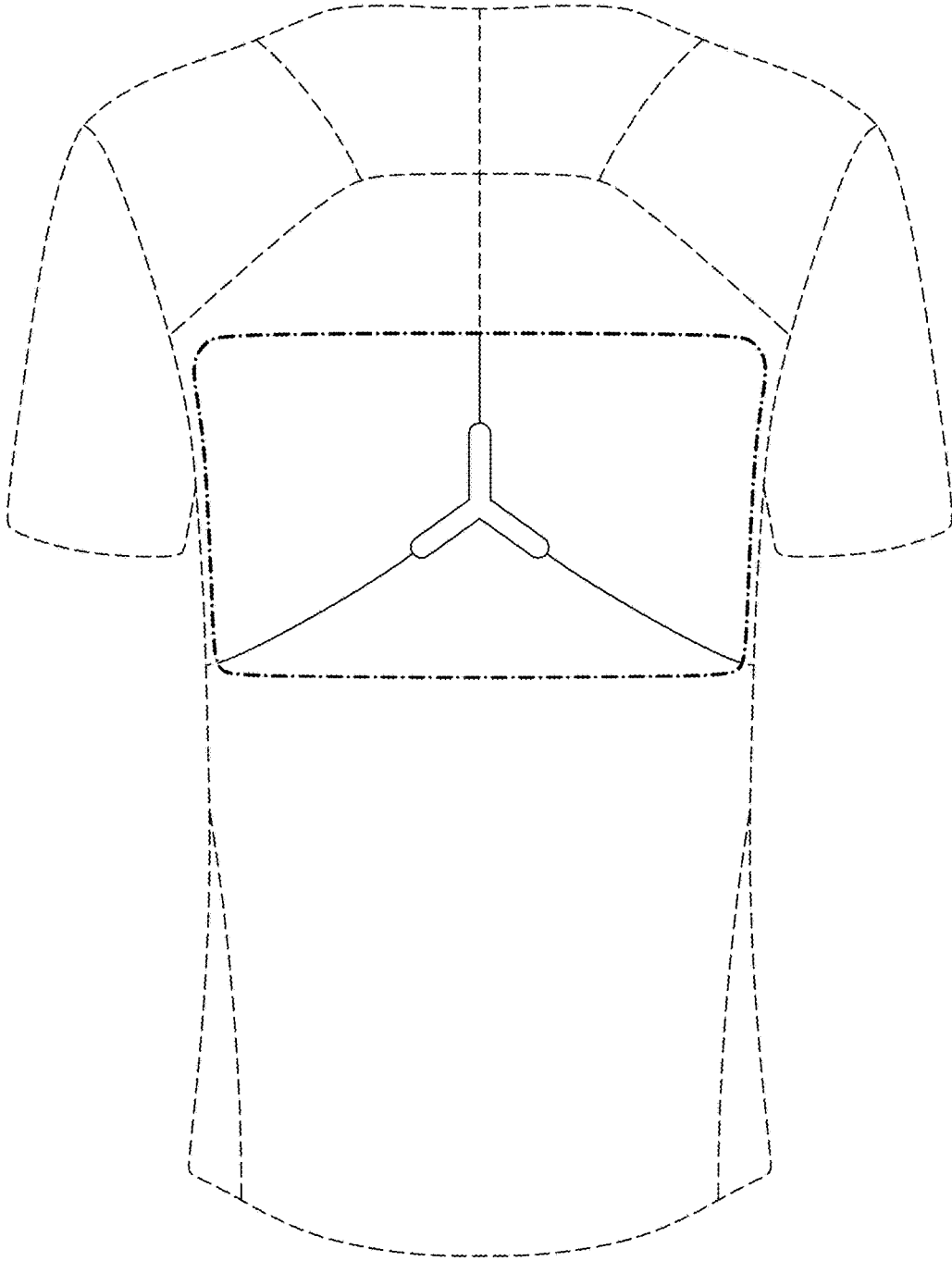

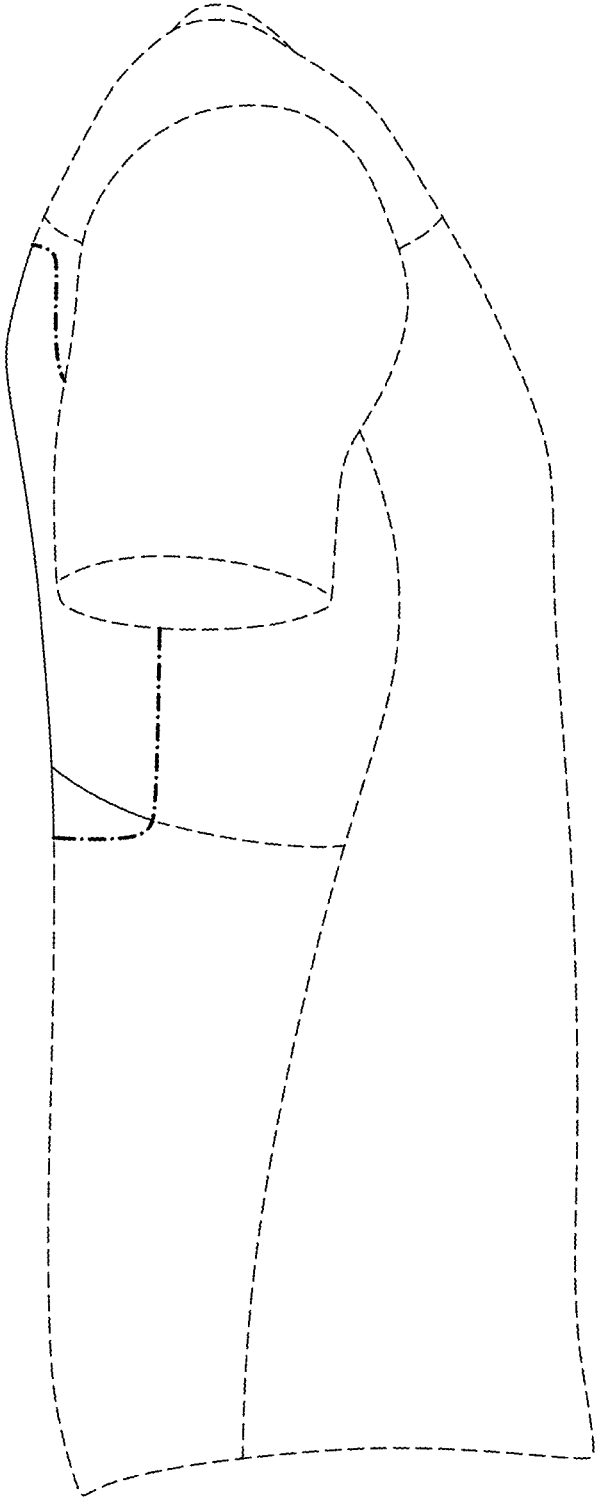
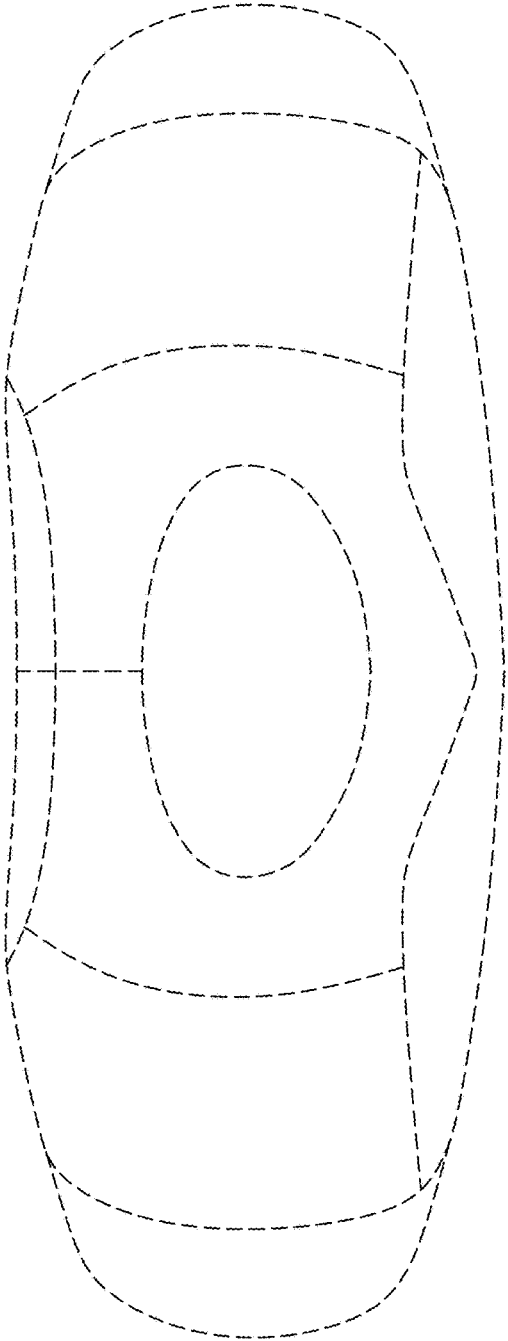

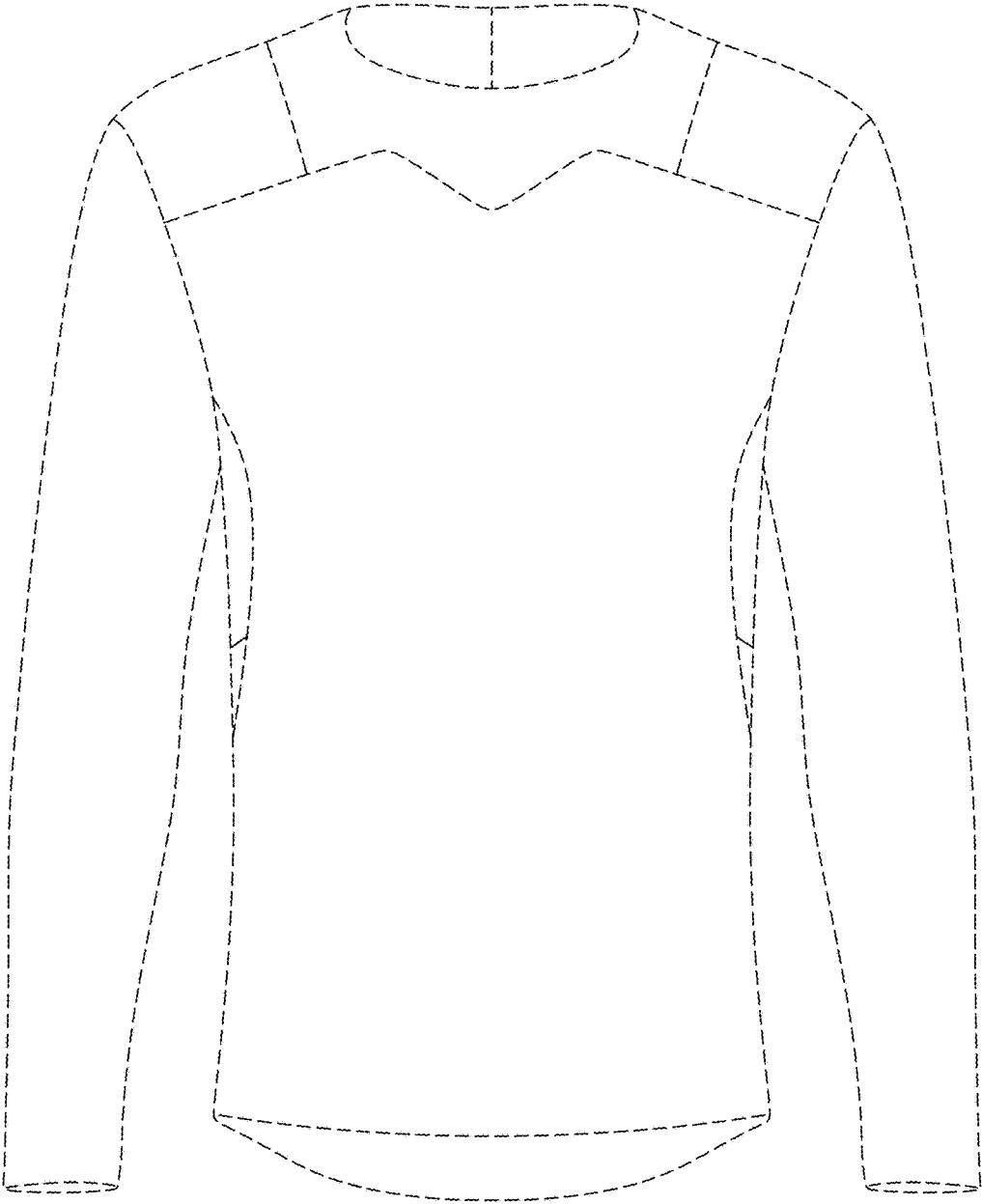

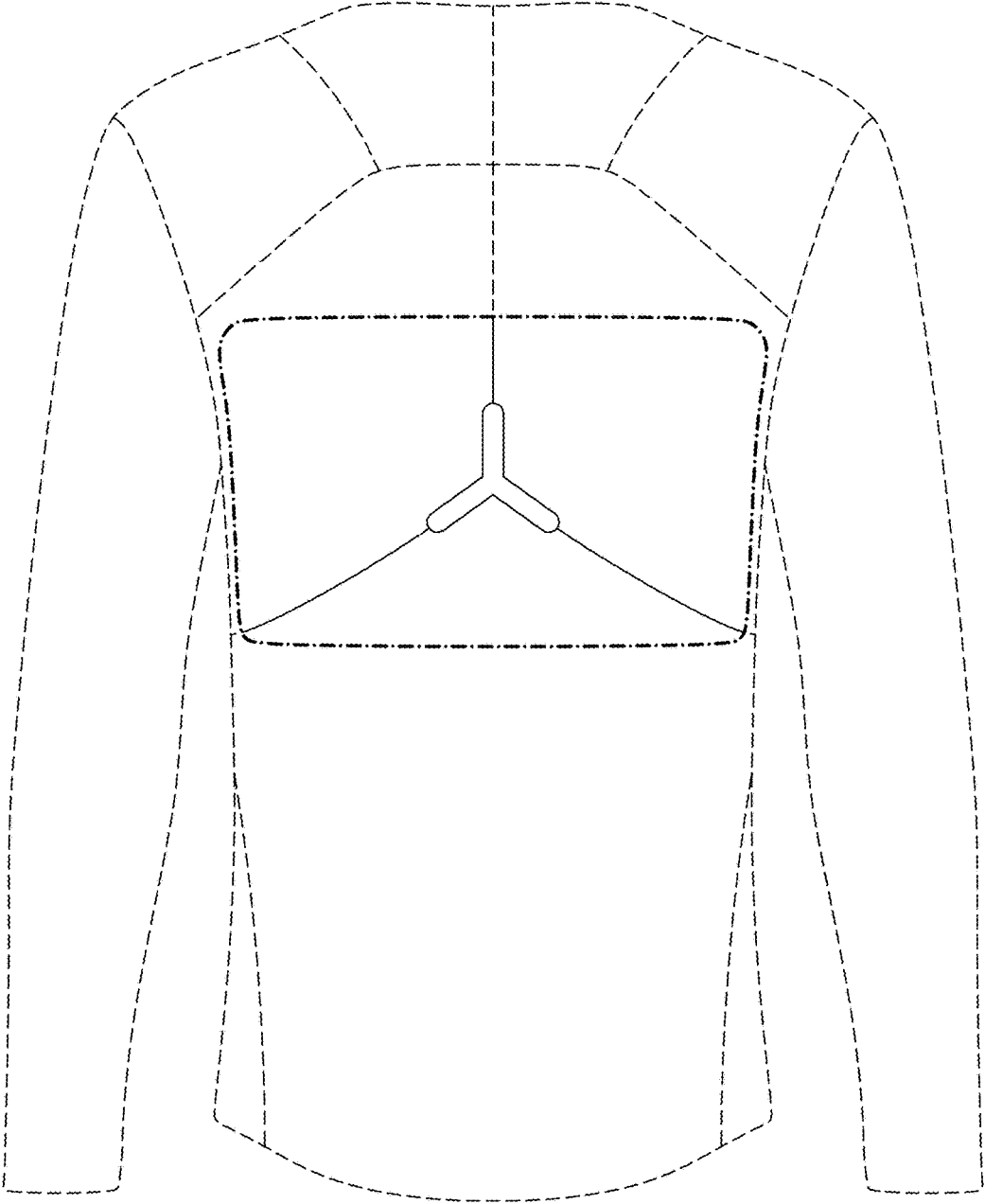

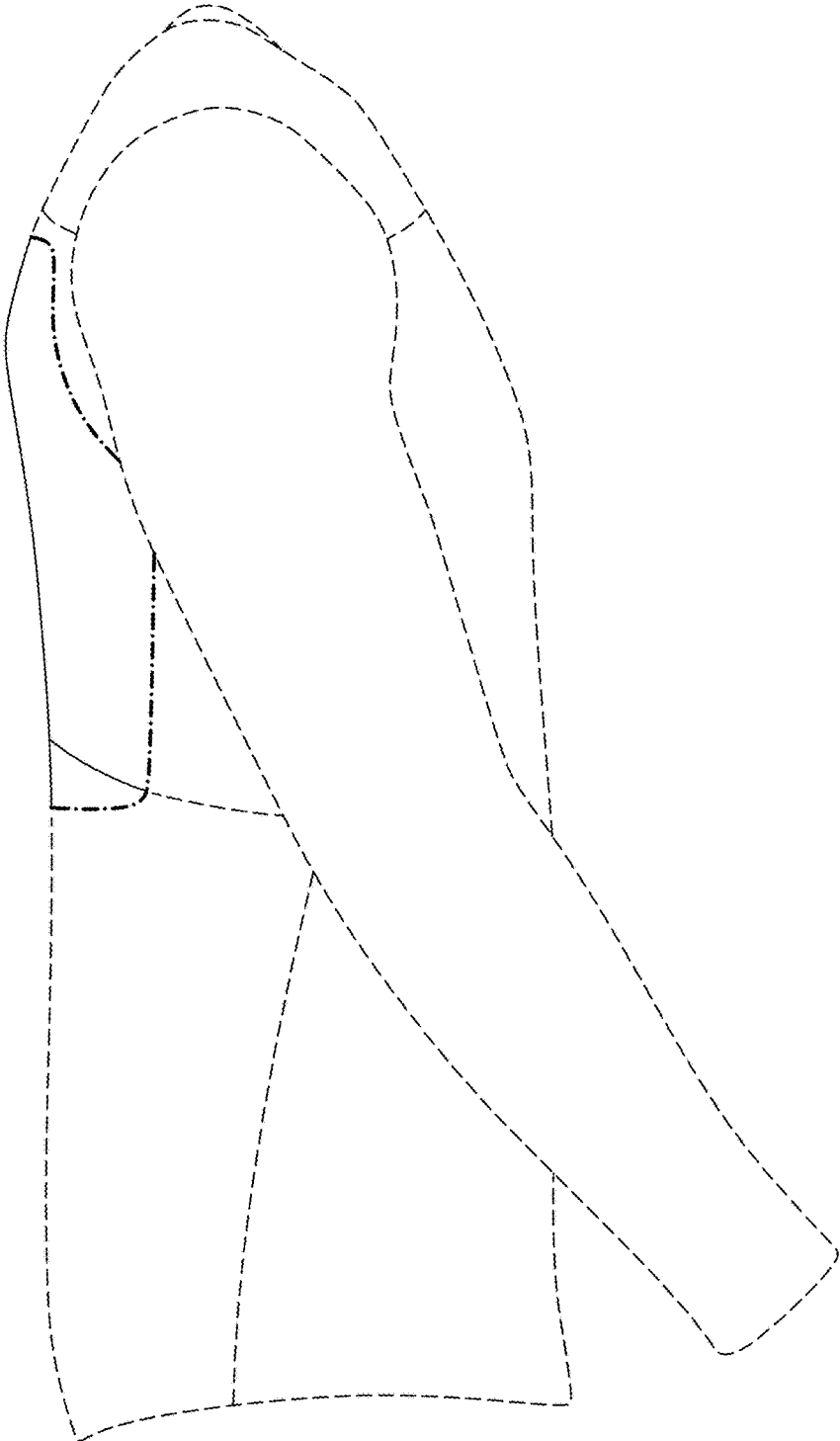
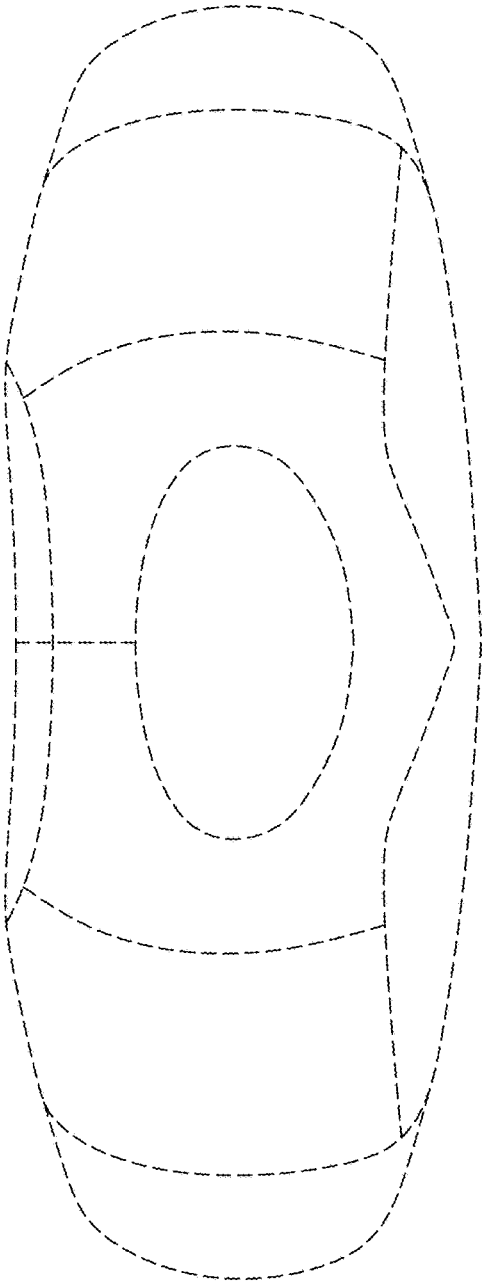

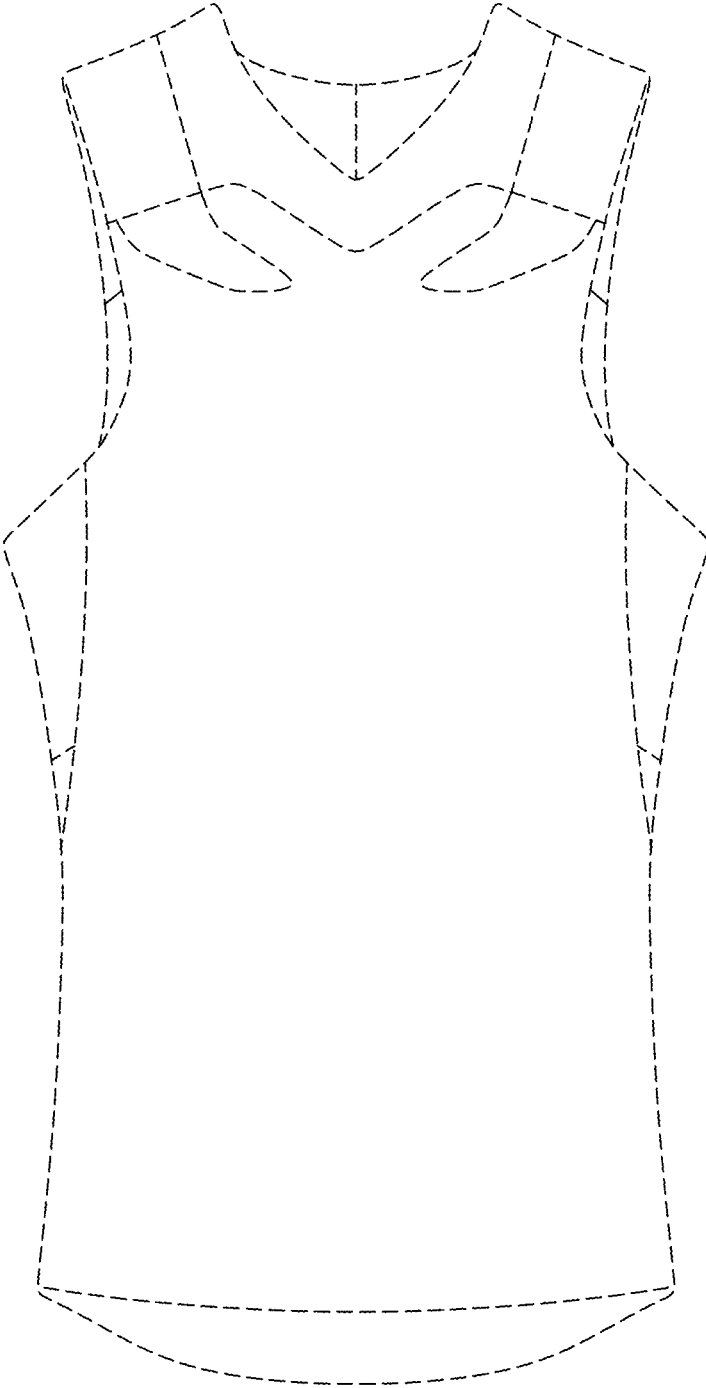

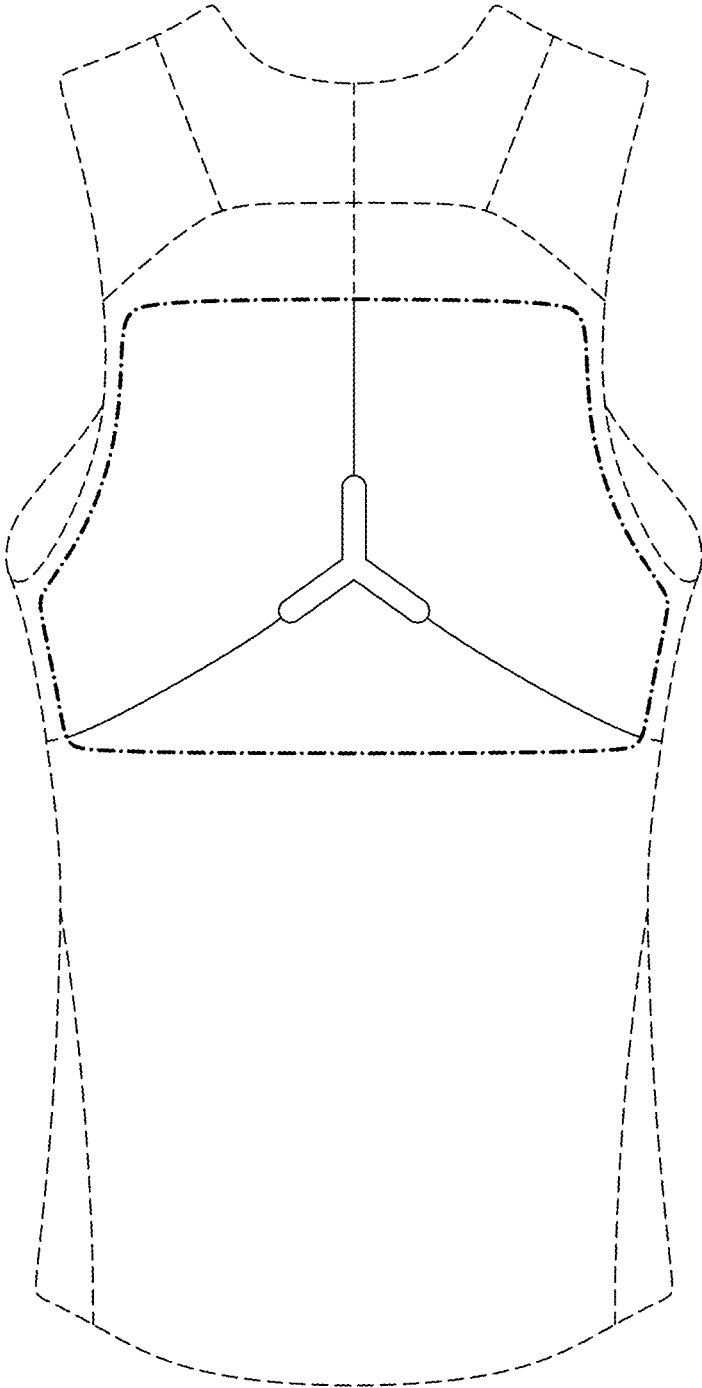

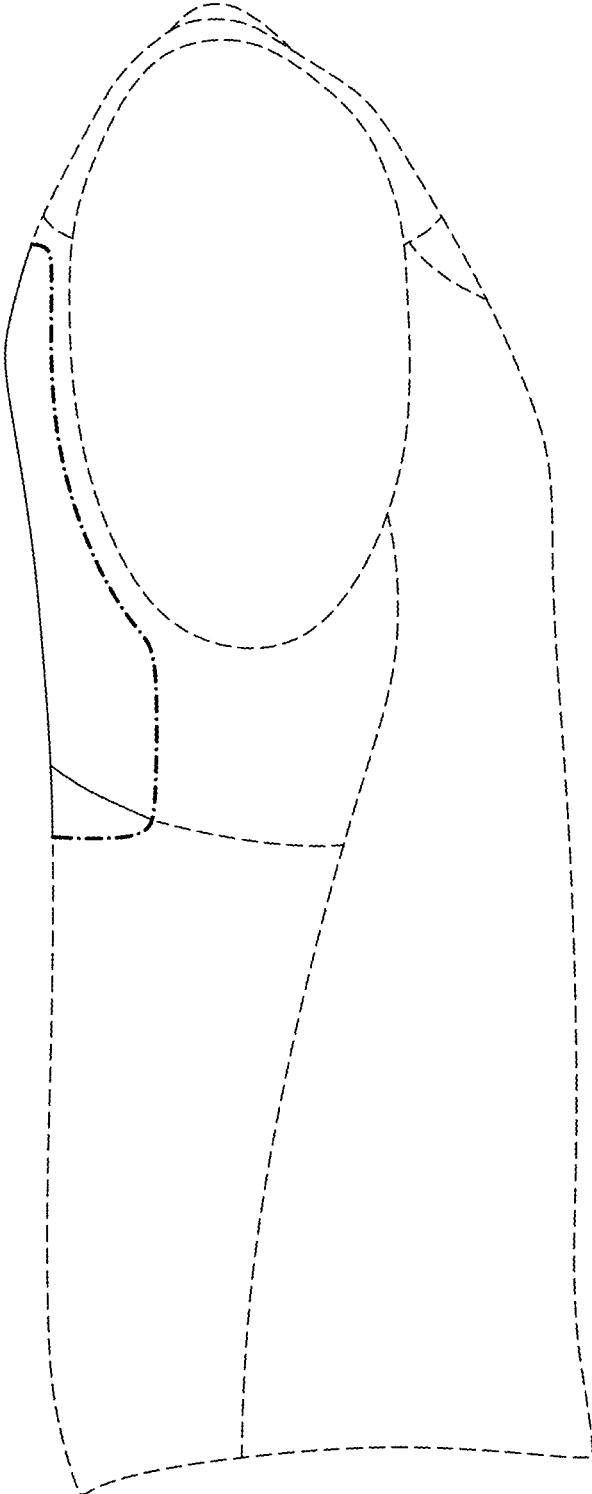
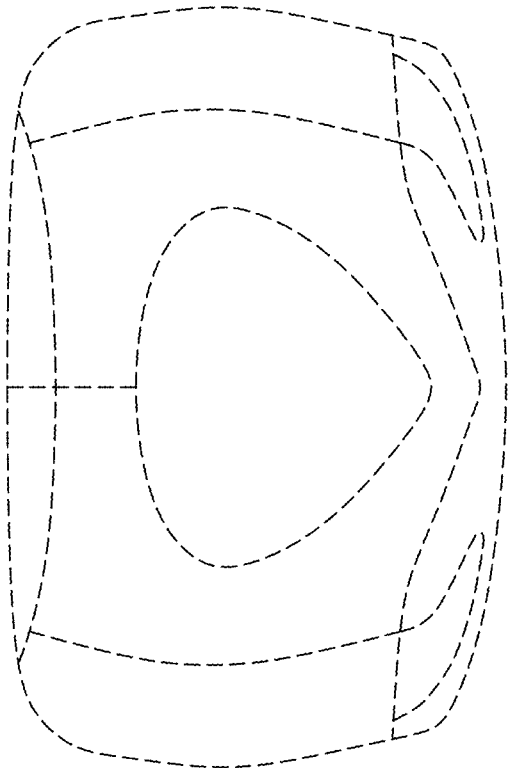

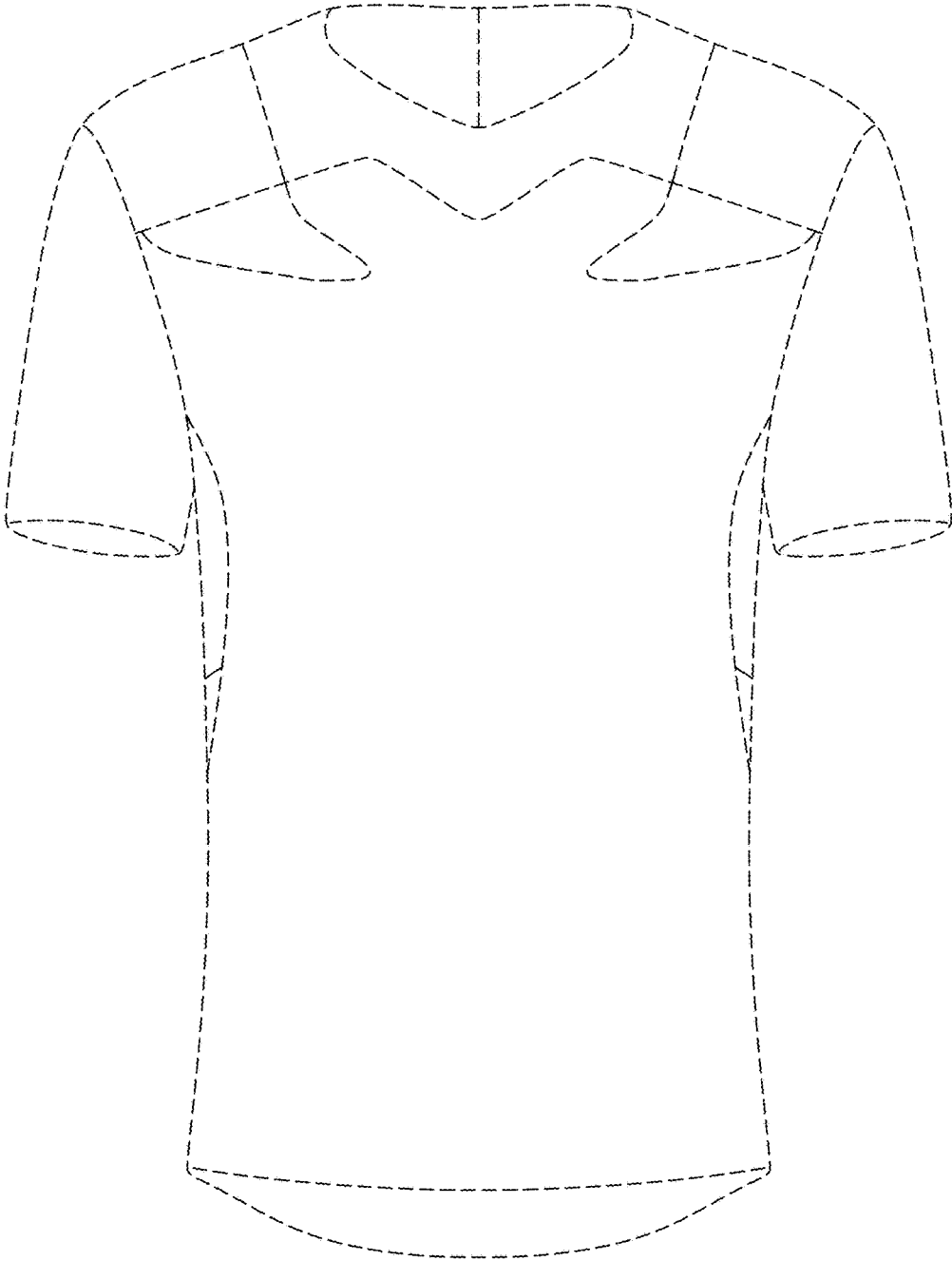

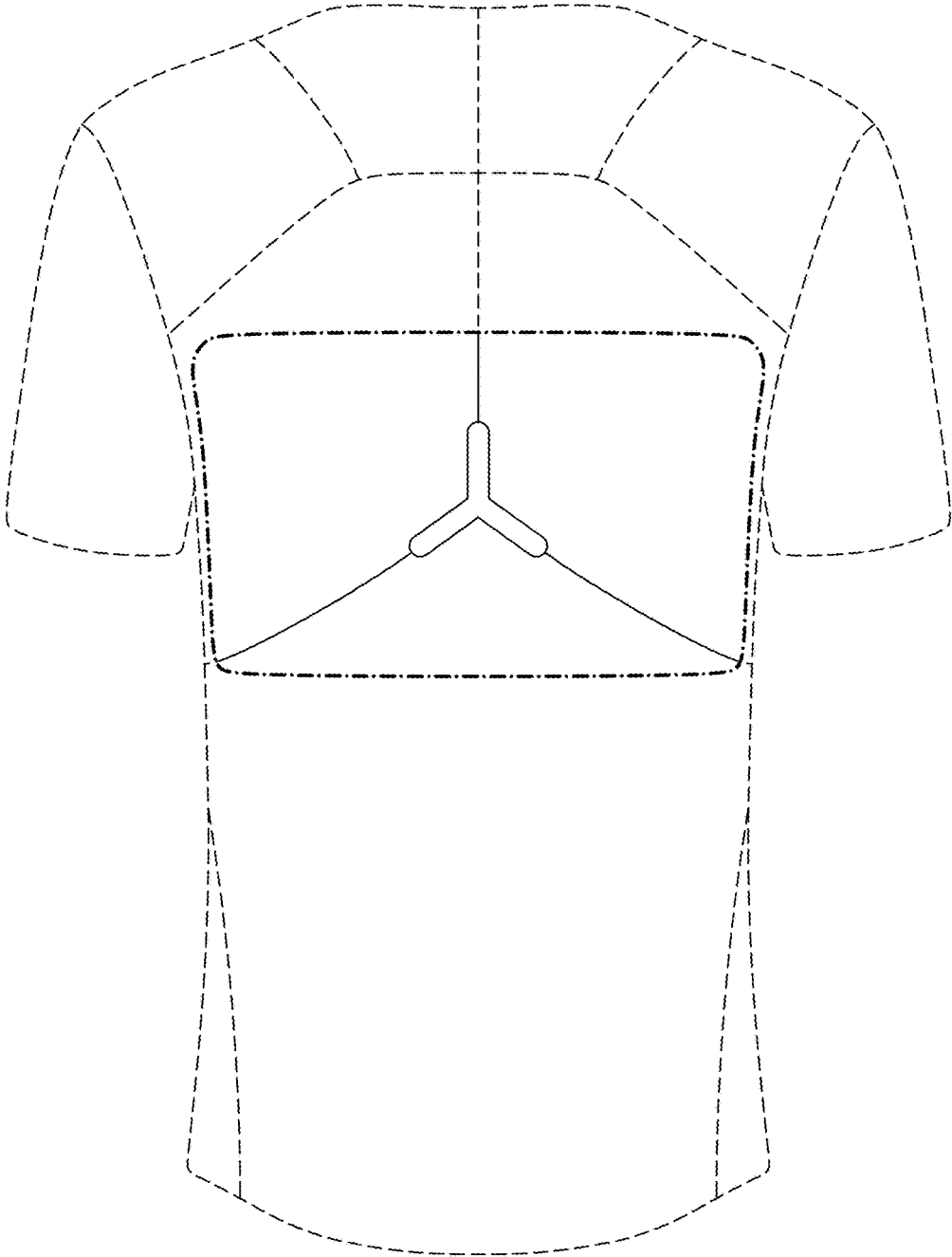

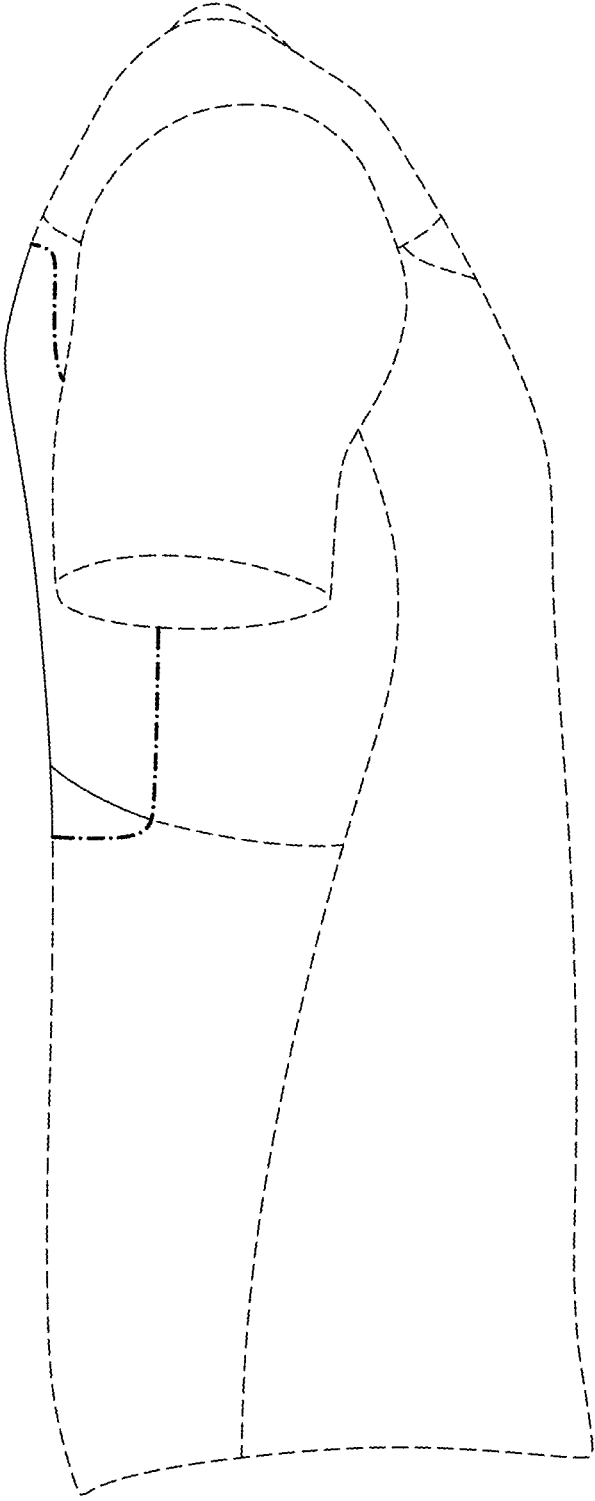
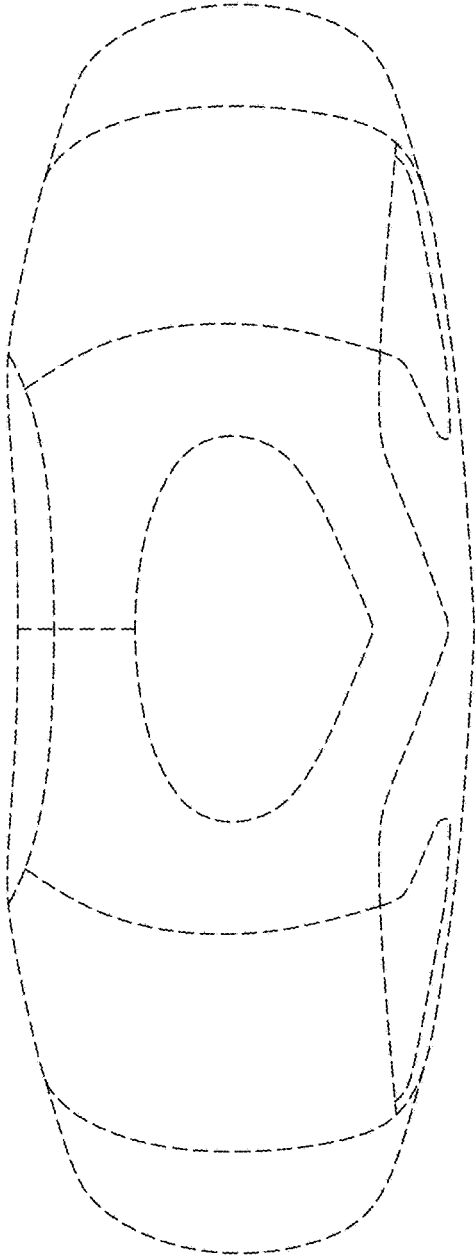

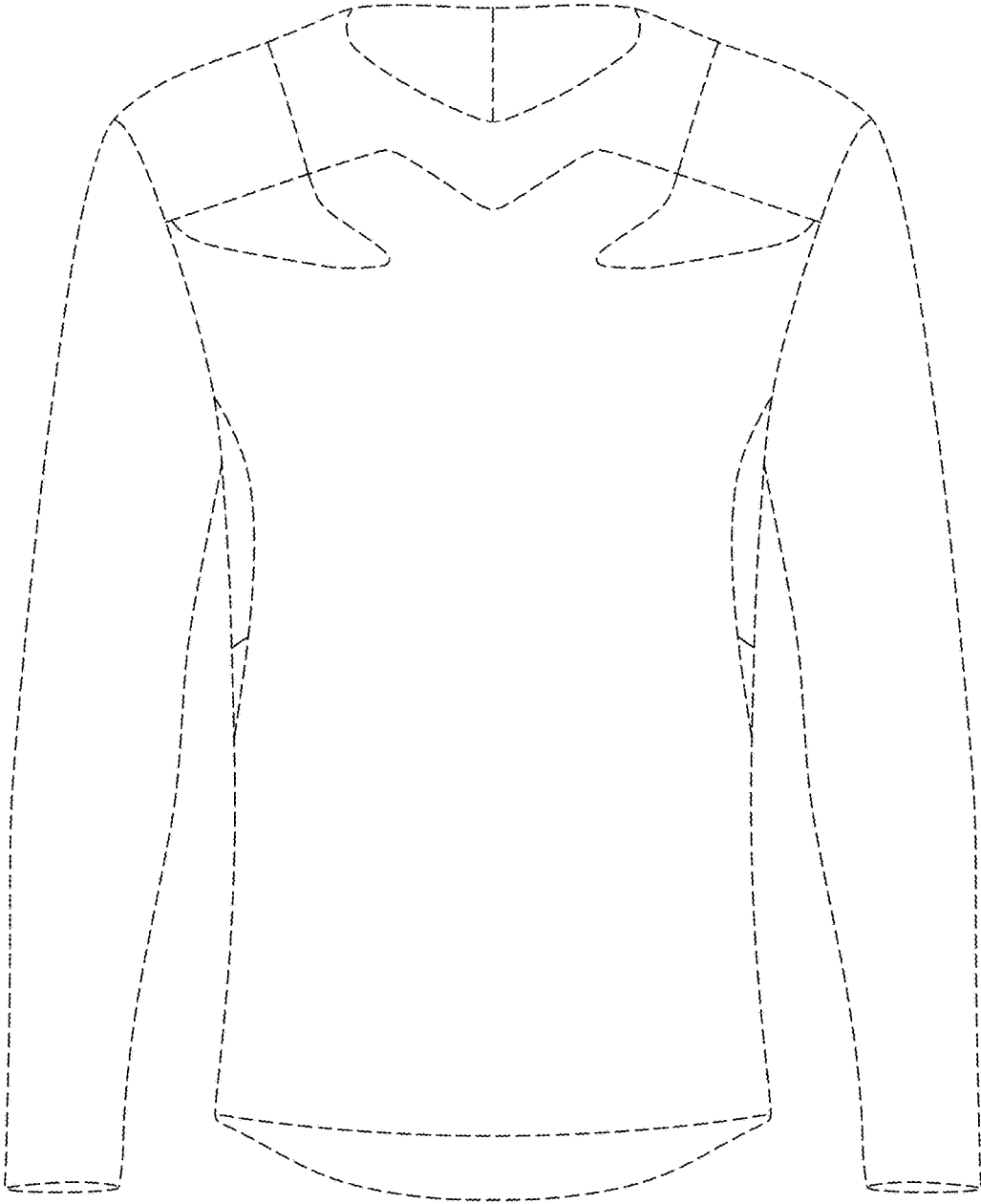

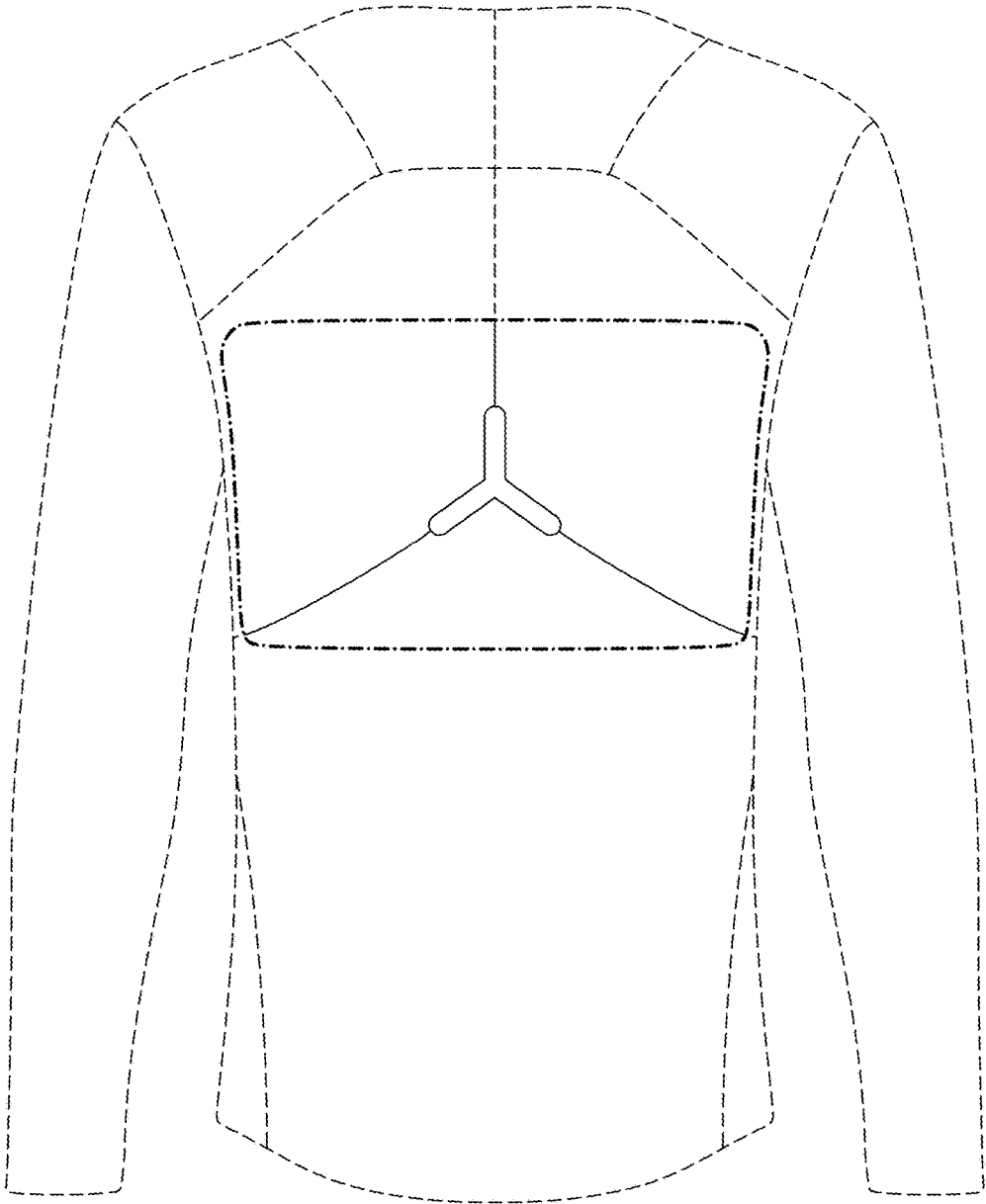

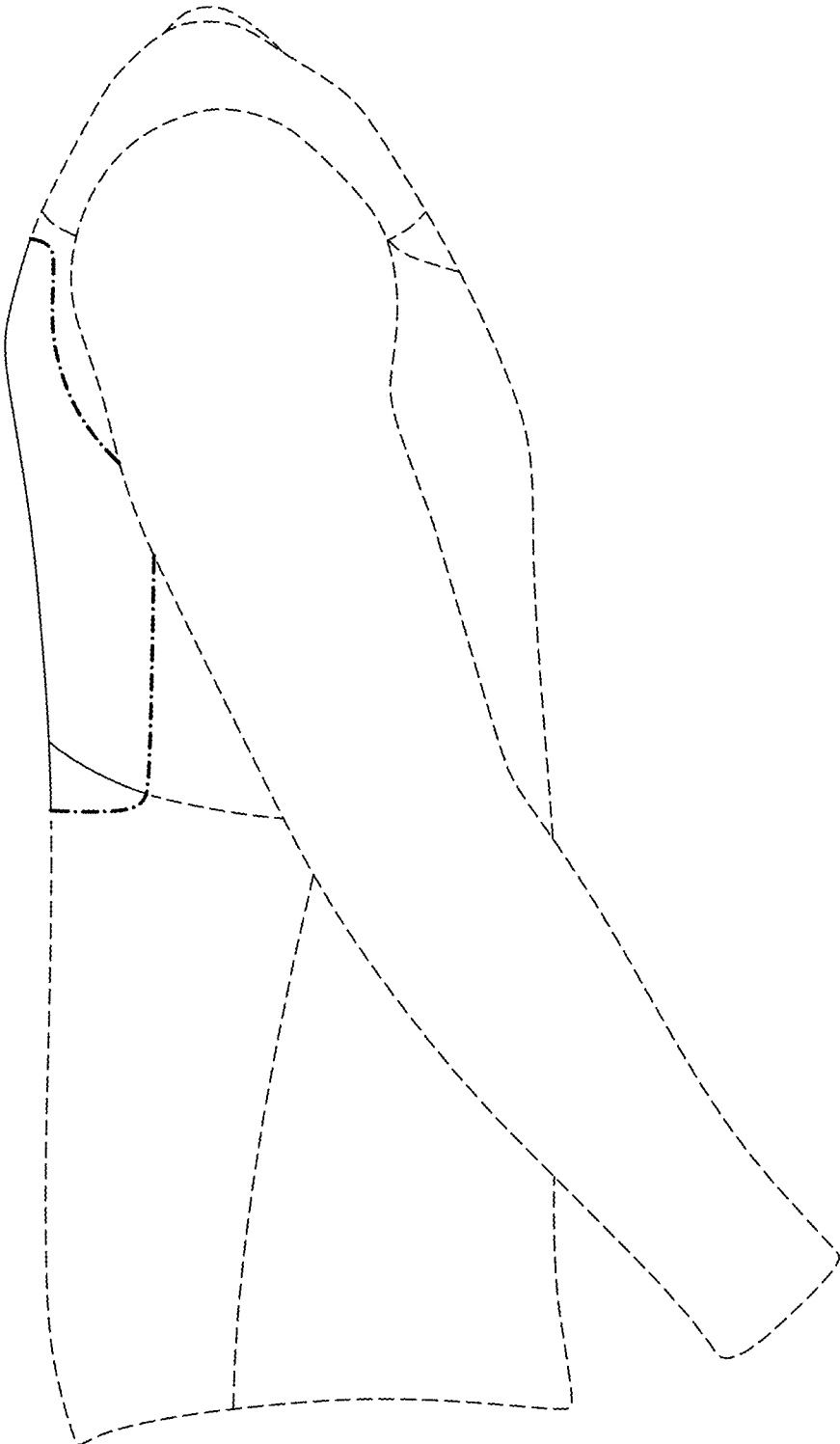
