

DESCRIPTION

FIG. 1 is a top front right perspective view of a charger for powered brush handle in accordance with our new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a left side elevation view thereof; and, FIG. 7 is a right side elevation view thereof. 












