

(57) Abstract: A fraud rule can be applied to a transaction according to a first authorization parameter. The transaction is passed to a filtering rule which is applied to the transaction according to a second authorization parameter. The fraud and filtering rules can apply the same analysis to the transaction with the exception of the authorization parameters.
