
(57) **CLAIM**

The ornamental design for a base plate of a mobile stackable tower, as shown and described.

DESCRIPTION

FIG. 1 is a front, top perspective view of a base plate of a mobile stackable tower;
 FIG. 2 is a back, bottom perspective view thereof;
 FIG. 3 is a top plan view thereof;
 FIG. 4 is a bottom plan view thereof;
 FIG. 5 is a front elevation view thereof;
 FIG. 6 is a back elevation view thereof;
 FIG. 7 is a left-side elevation view thereof;
 FIG. 8 is a right-side elevation view thereof; and,
 FIG. 9 is a front, top perspective view showing unclaimed environment of the base plate of the mobile stackable tower according to the present design.
 The broken line showing of the circular features in FIGS. 1-9 is included for the purpose of illustrating portions of the base plate of a mobile stackable tower and forms no part of the claimed design. The broken line showing of a stackable tower in FIG. 9 is included for the purpose of illustrating environmental use only and forms no part of the claimed design.










