

(57) **Abstract:** The present invention provides a pharmaceutical composition comprising lipid microparticles comprising a lipid layer and at least one active pharmaceutical ingredient, wherein the at least one active pharmaceutical ingredient is adsorbed on the lipid microparticle. The present invention also provides a process for preparing the lipid microparticles and the associated pharmaceutical compositions. The pharmaceutical composition may be used in the treatment and/or prophylaxis of lung disease.
