
(57) **CLAIM**

The ornamental design for an electrical connector housing, as shown and described.

DESCRIPTION

FIG. 1 is a rear, bottom and left side perspective view of an electrical connector housing showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a cross sectional view taken along line 6-6 in FIG. 2; FIG. 7 is a cross sectional view taken along line 7-7 in FIG. 2; FIG. 8 is a cross sectional view taken along line 8-8 in FIG. 2; and, FIG. 9 is a cross sectional view taken along line 9-9 in FIG. 2. The features shown in broken lines in the drawings depict environmental subject matter only and form no part of the claimed design. The dash-dotted lines denote the boundary of the claim and form no part of the claimed design.
















