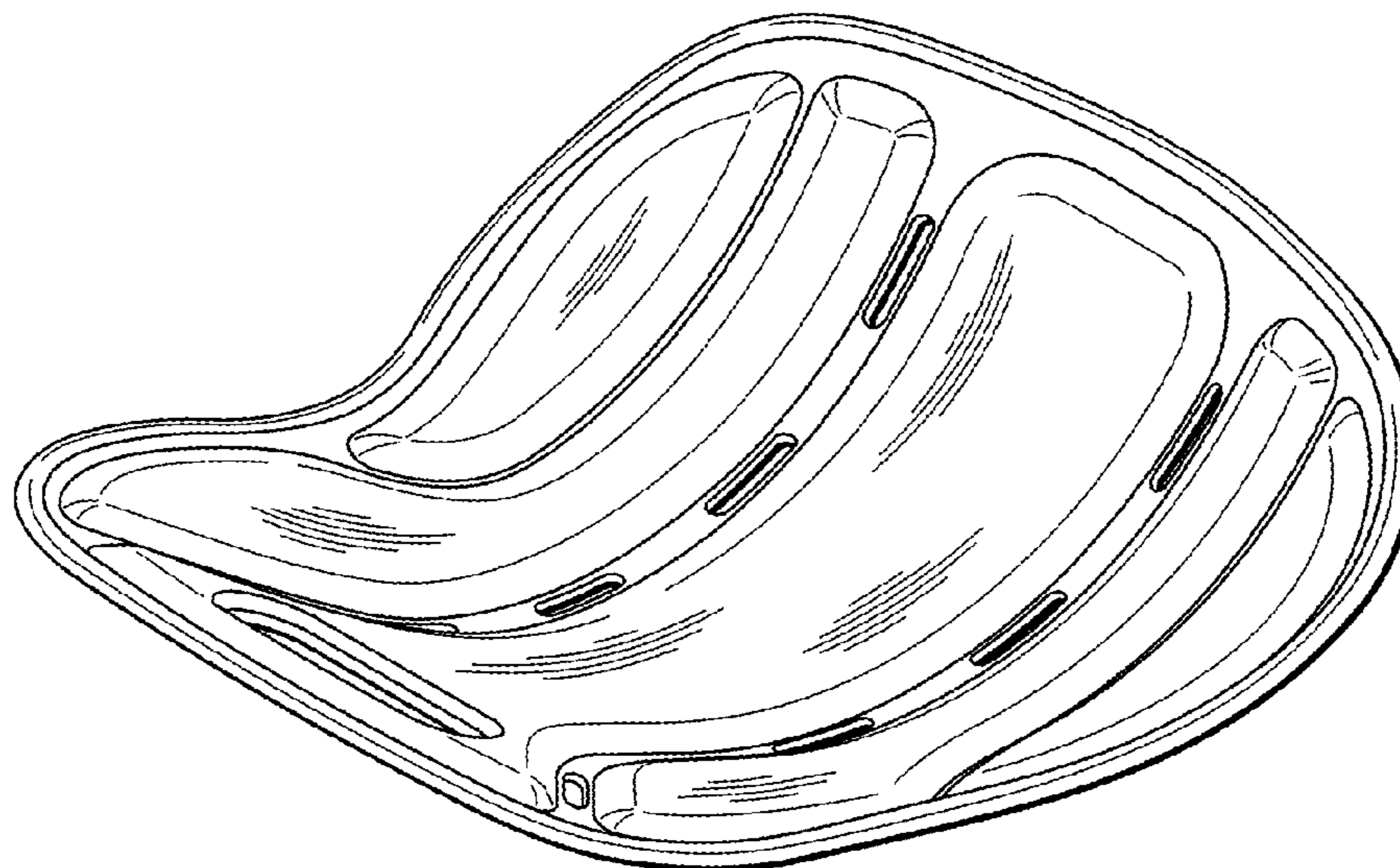
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a support cushion according to an embodiment;

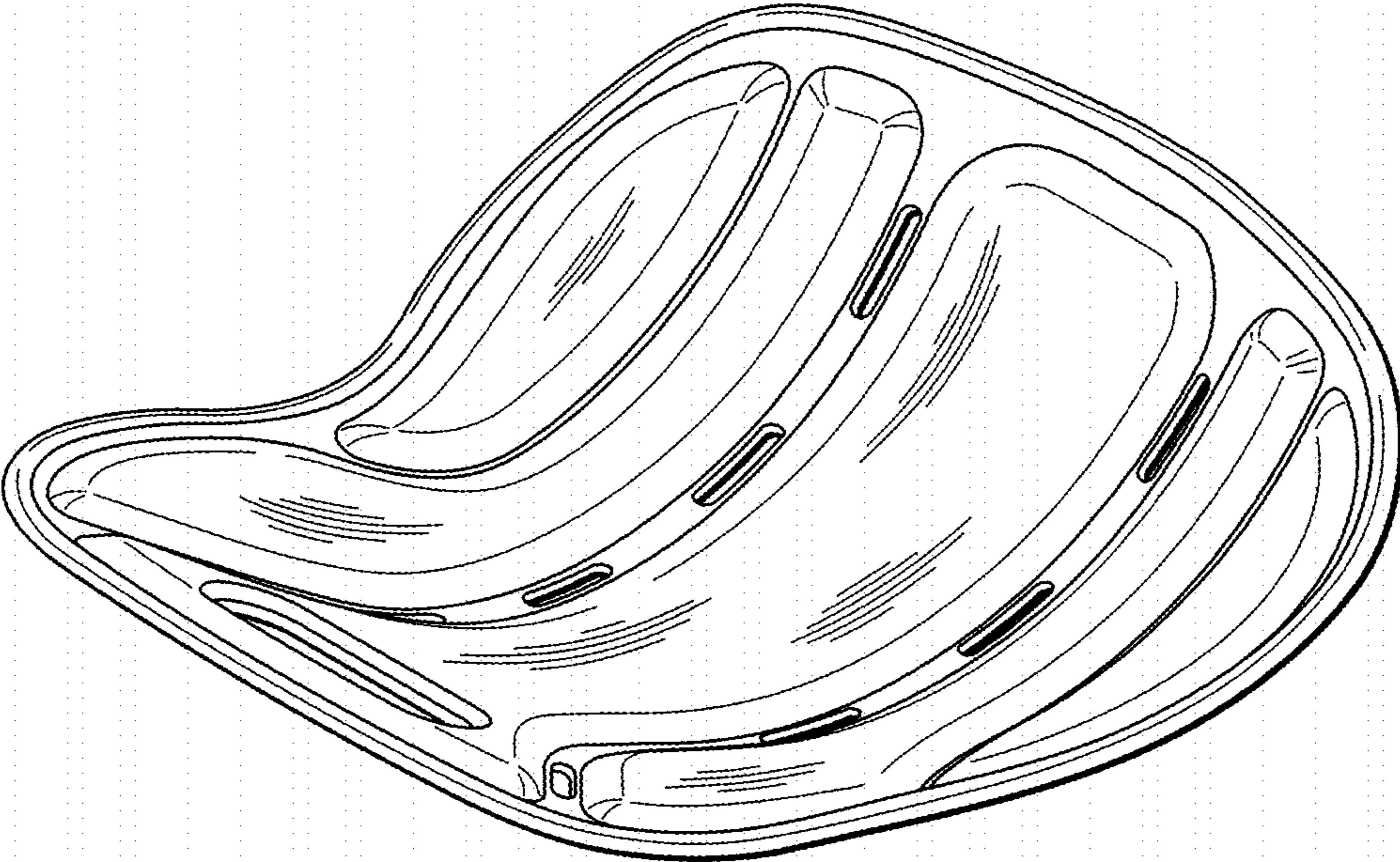

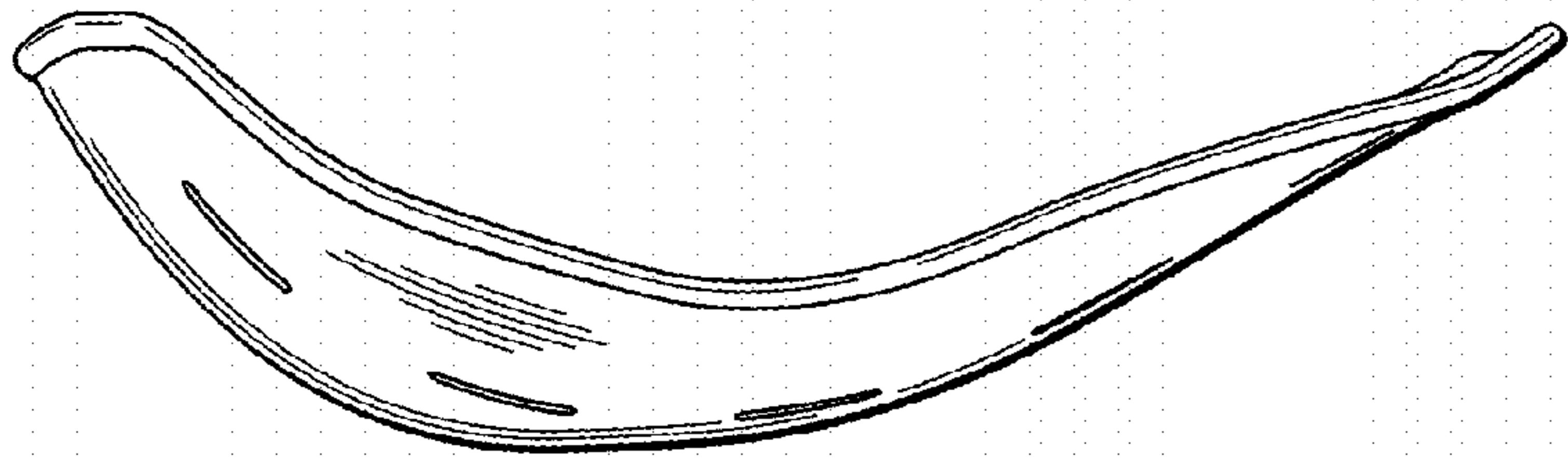

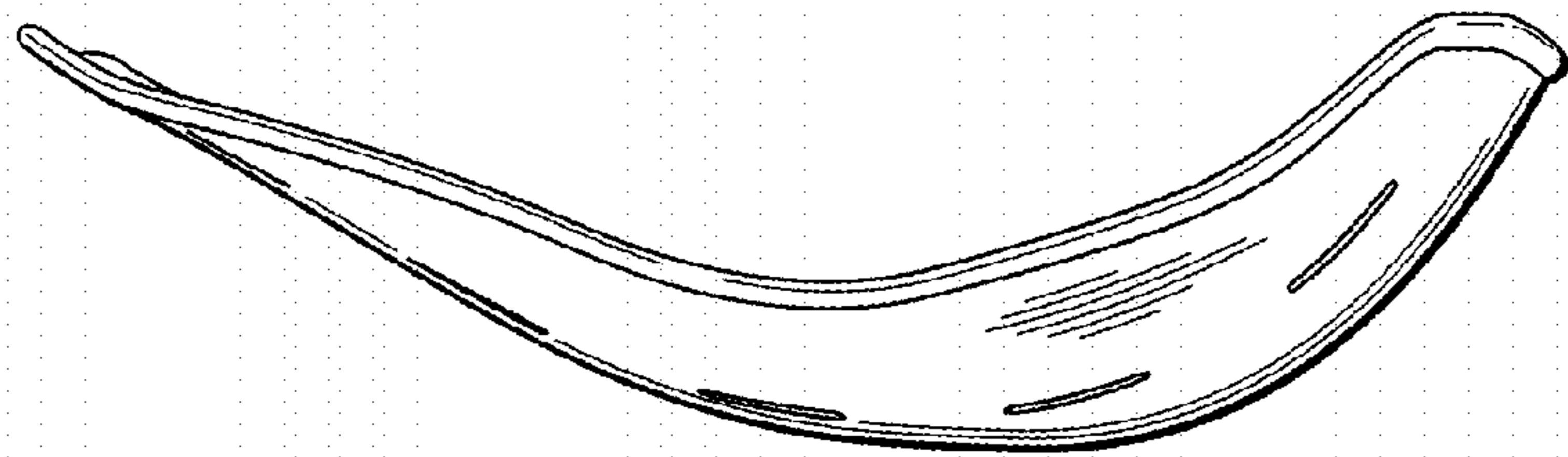

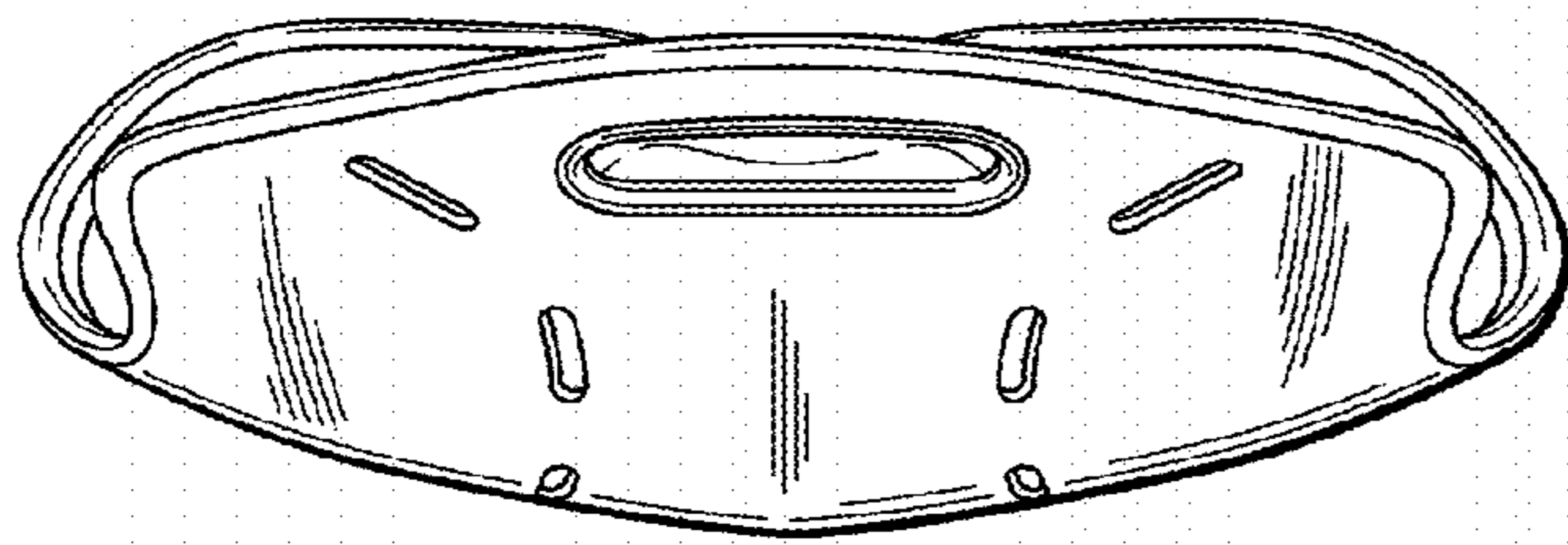

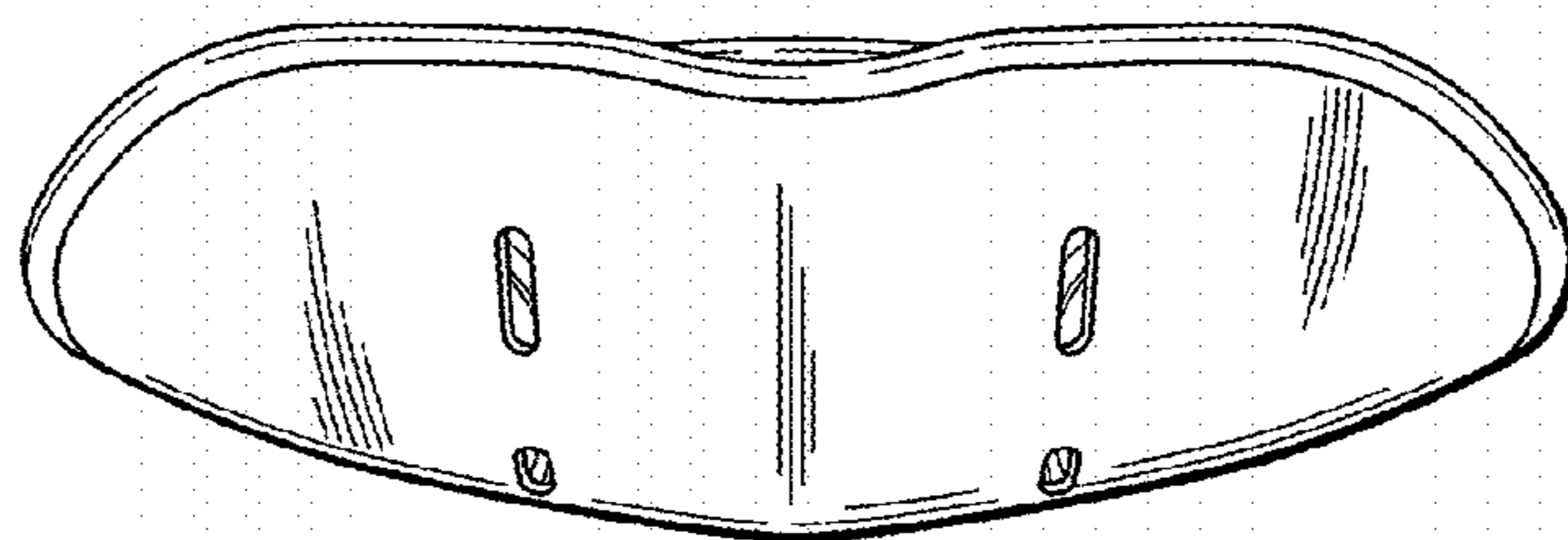

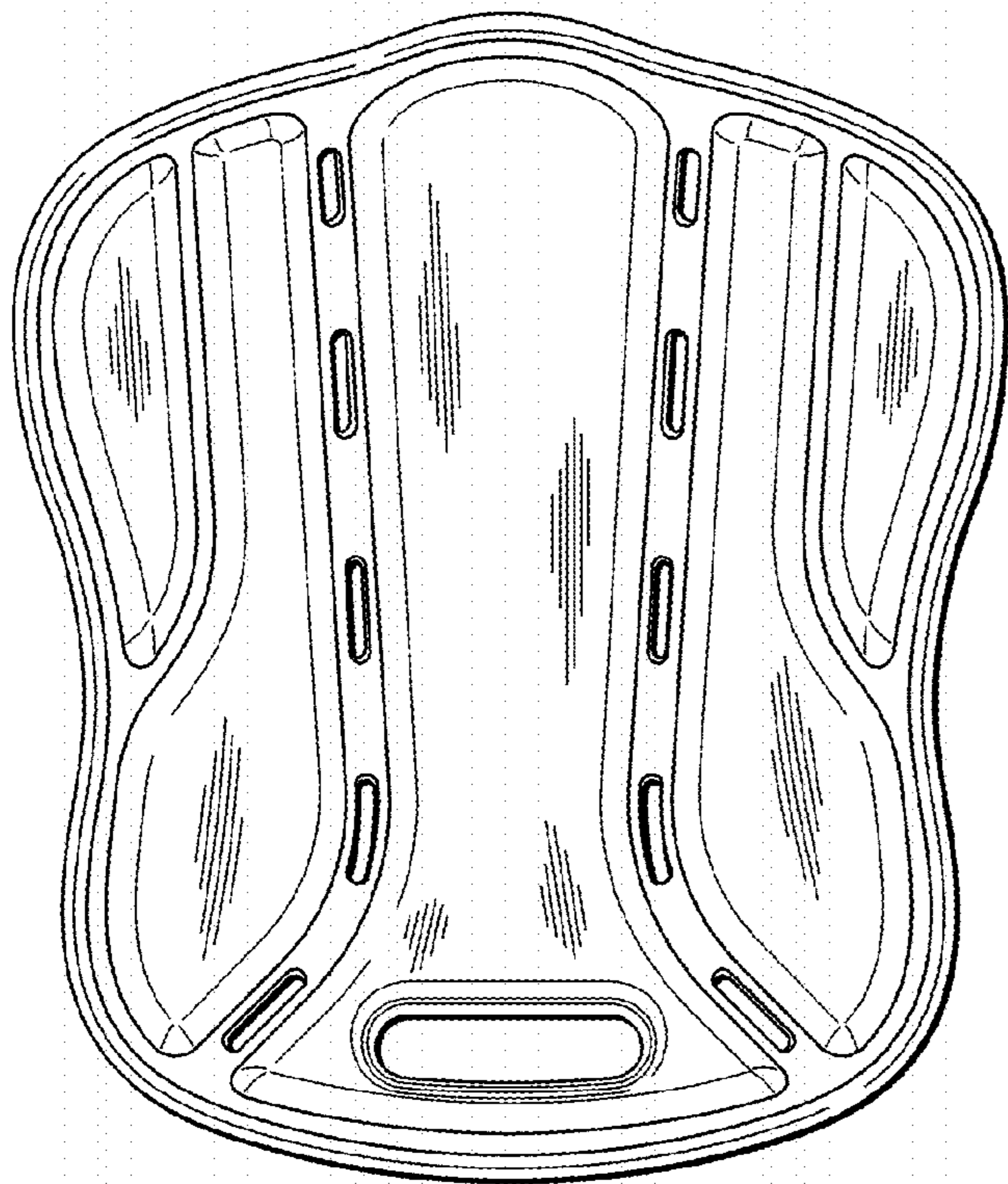

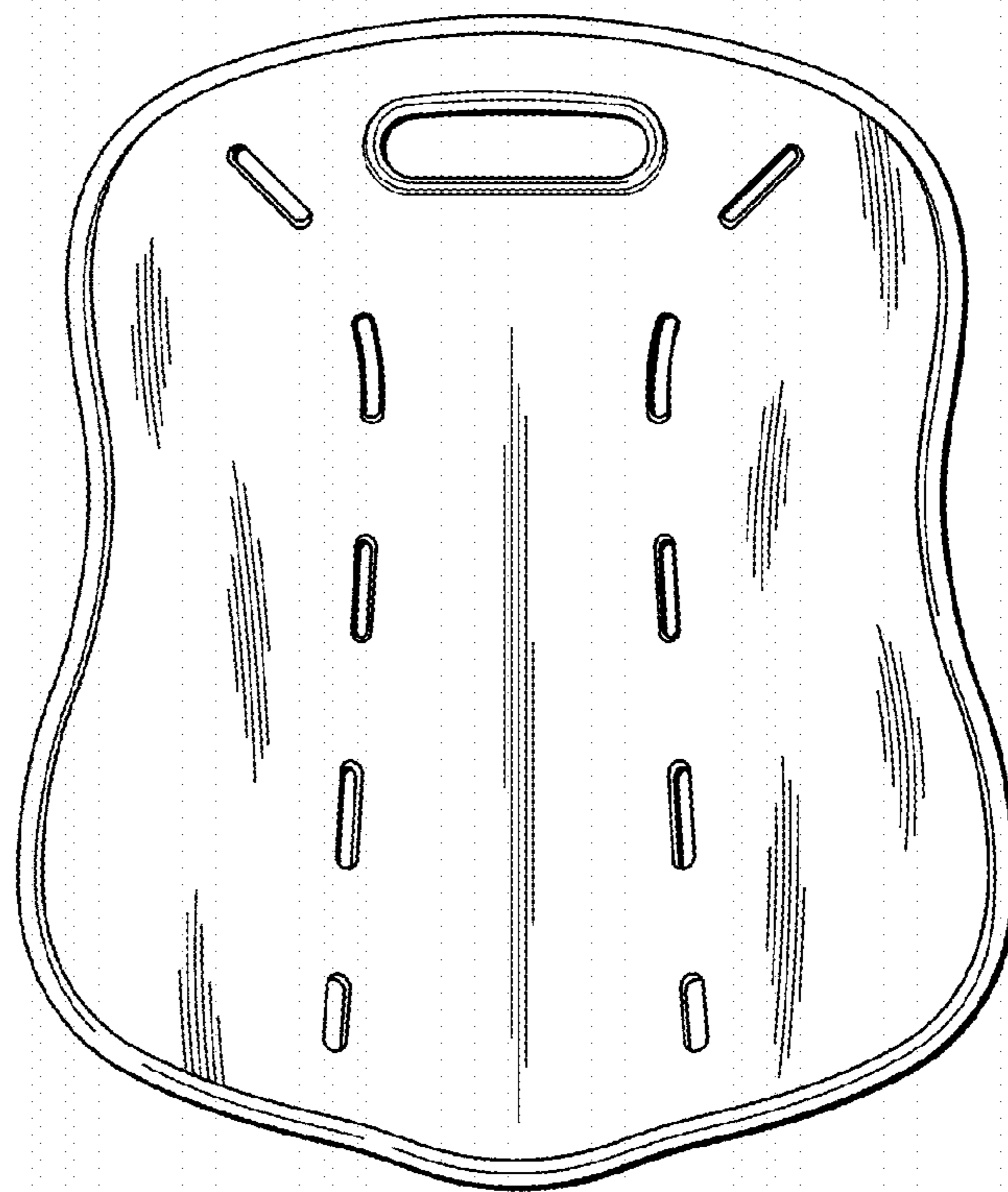

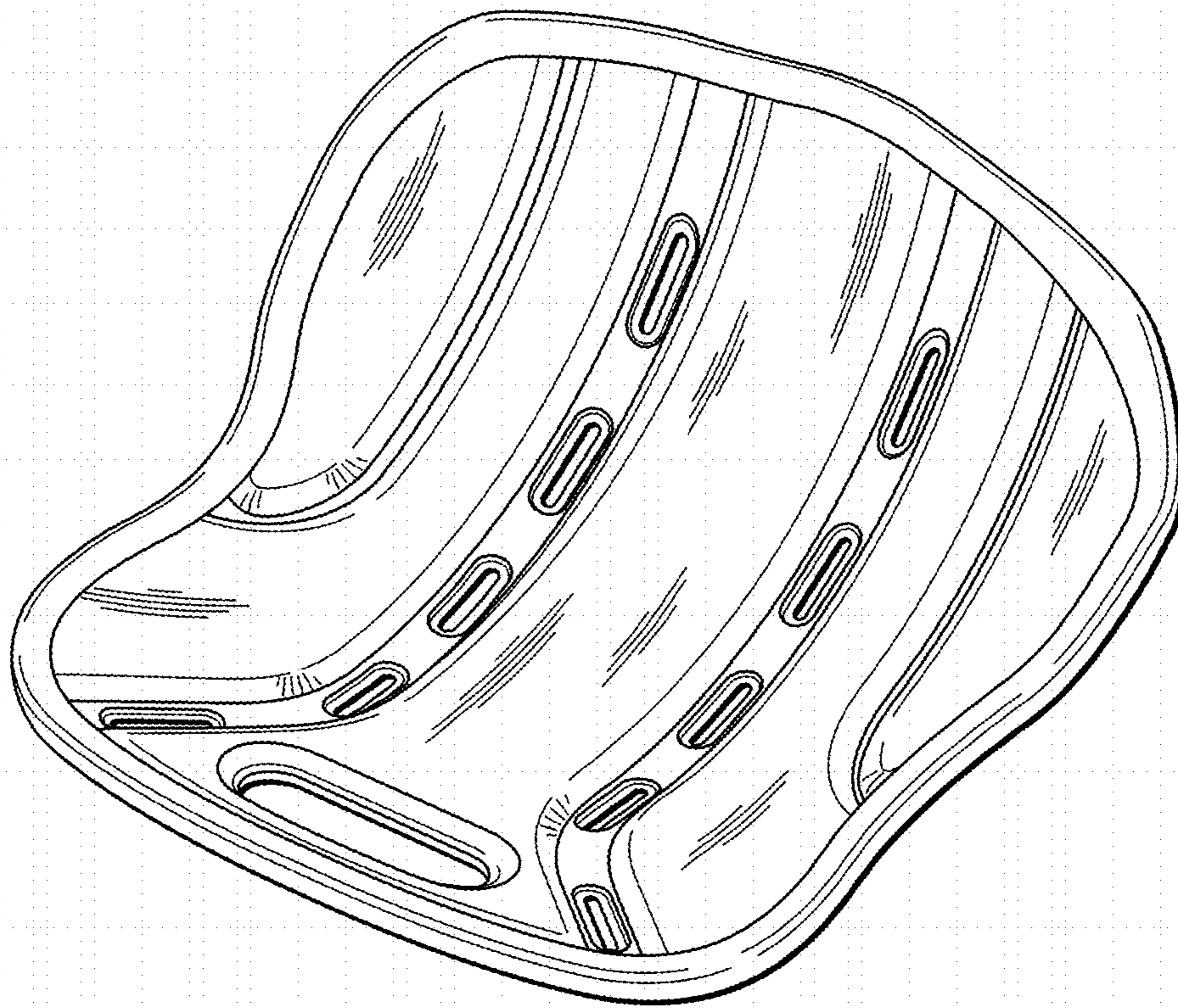

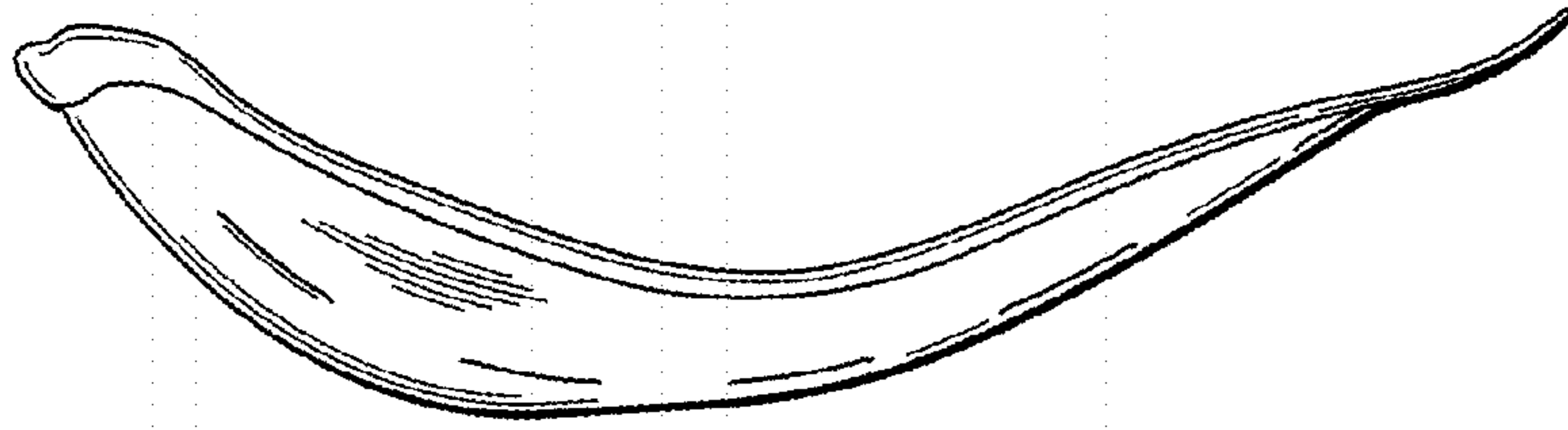

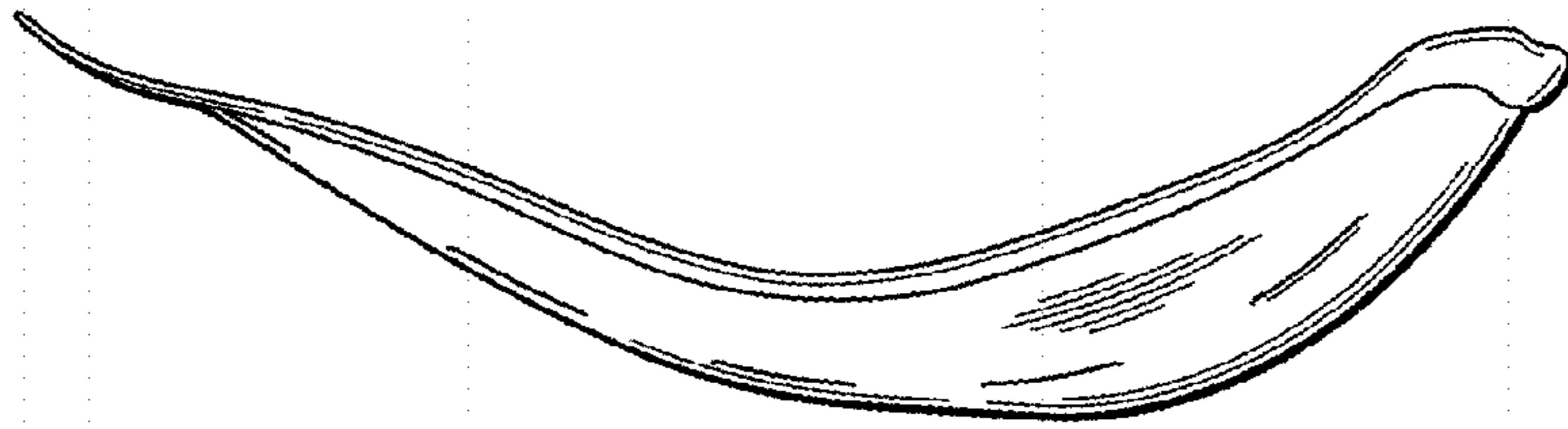

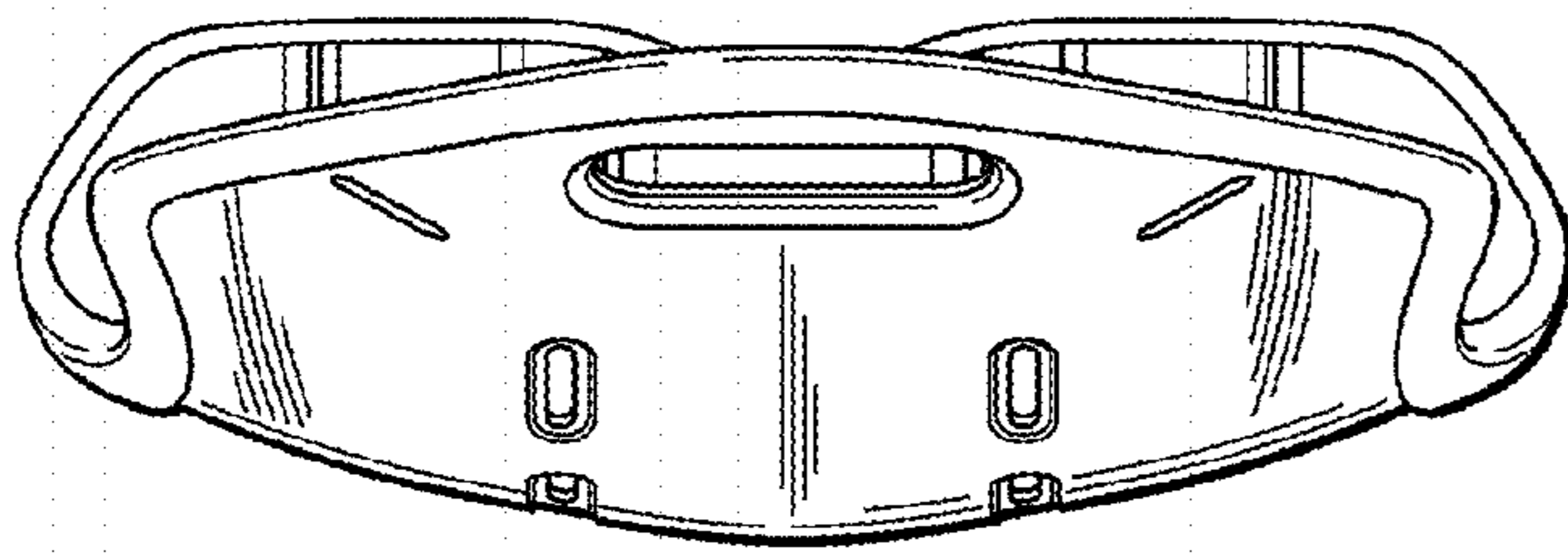

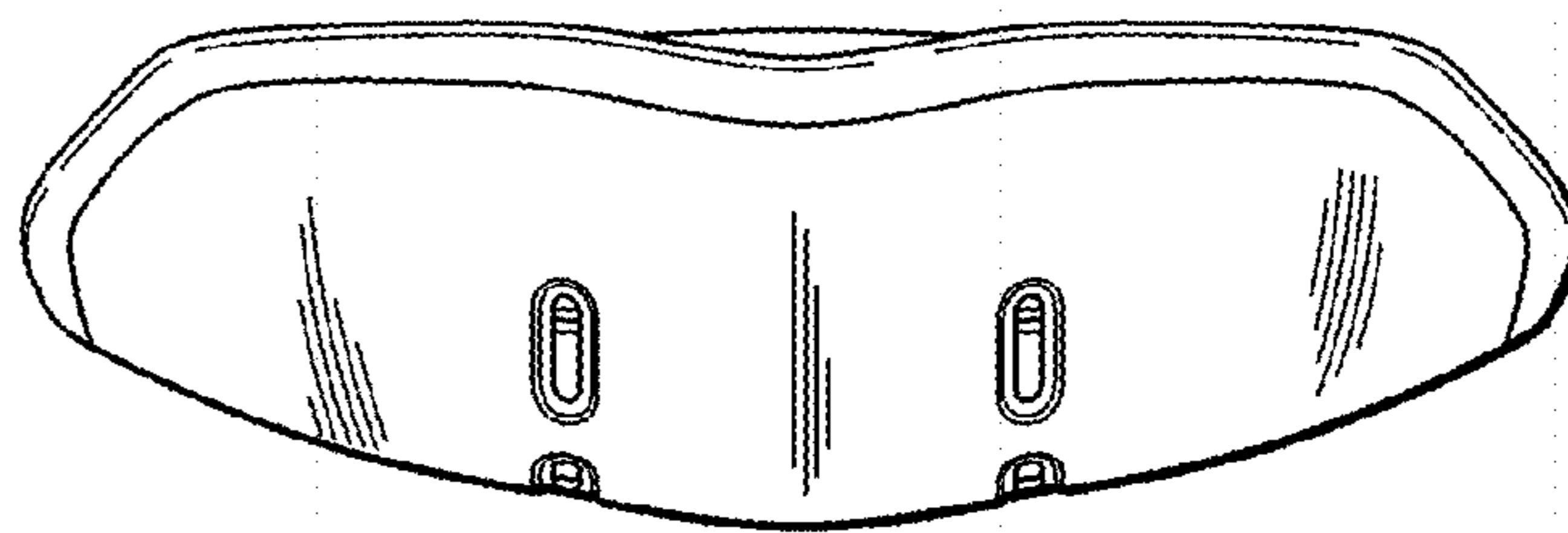

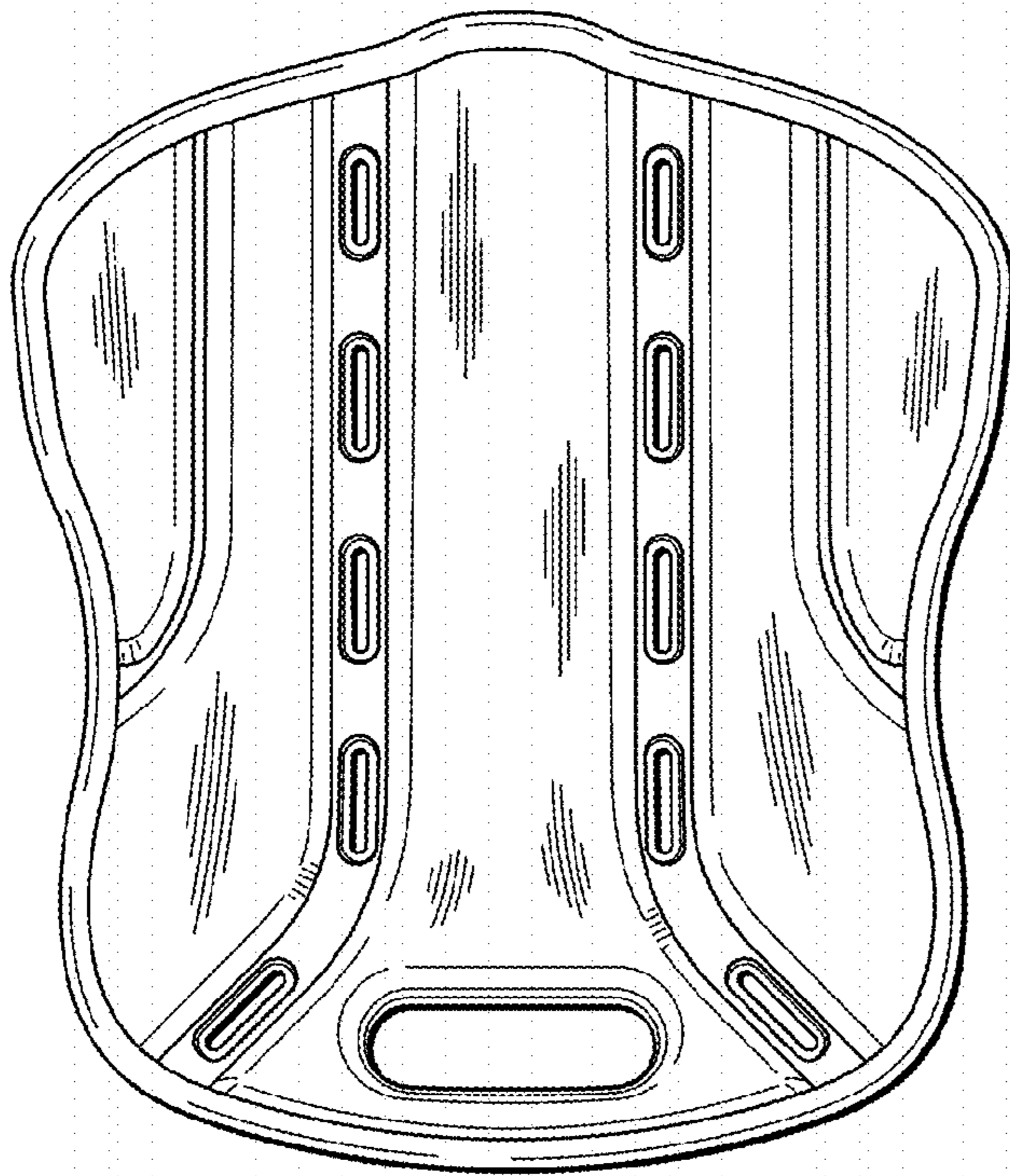

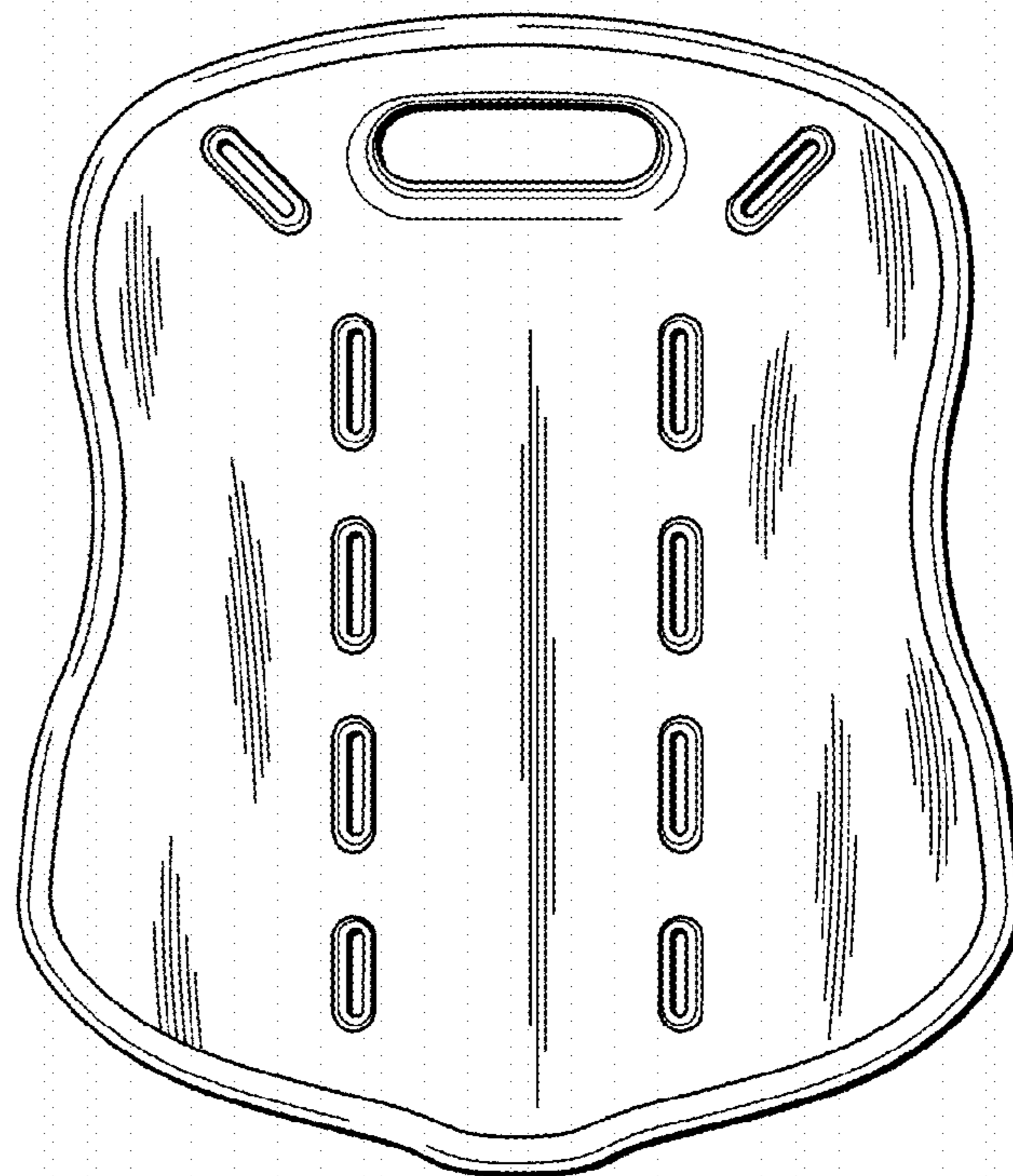
