(57) **CLAIM**

The ornamental design for a hose and a flexible hose guard, as shown and described.

DESCRIPTION

The present application is related to U.S. patent application Ser. No. 13/308,070 filed Nov. 30, 2011. The aforementioned patent application is incorporated by reference herein in its entirety for any purpose whatsoever.

FIG. 1 is a perspective view of a flexible hose guard;


FIG. 2 is a side view thereof;










