

(54) Title: SYSTEM AND METHOD FOR AUTHENTICATING WIRELESS COMPONENT



(57) Abstract: A wireless component (14) is authenticated to an in-home wireless entertainment system server (12) by simultaneously or near-simultaneously holding down buttons on the component (14) and server (12) and transmitting a component ID (or encryption results generated from the key) to the server (12). The server (12) then indicates "authenticated", and the component (14) can subsequently access the system using its ID.
