(57) **CLAIM**

The ornamental design for the skin applique, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a skin applique according to my new design.

FIG. 2 is a front view of the skin applique as in FIG. 1.

FIG. 3 is a back view of the skin applique as in FIGS. 1-2.


FIG. 4 is a right-side view of the skin applique as in FIGS. 1-3; and,

FIG. 5 is a left-side view of the skin applique as in FIGS. 1-4.






