We claim the ornamental design for a suction cup grabber, as shown and described.

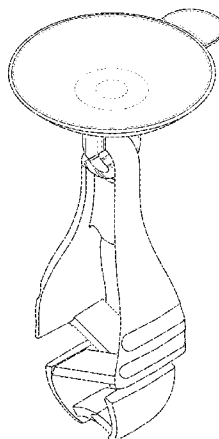
DESCRIPTION

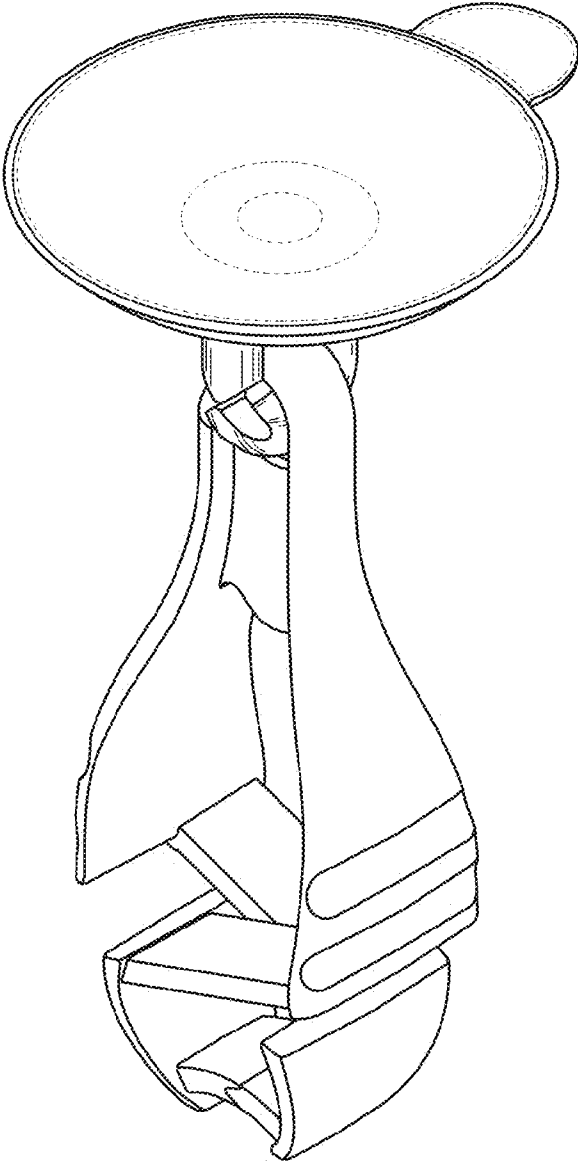

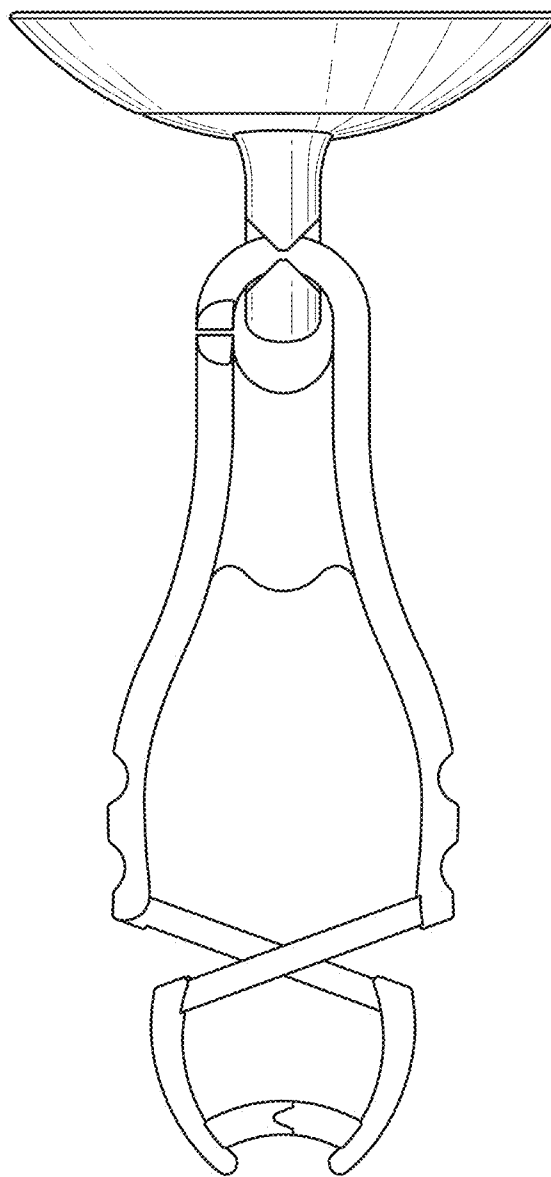

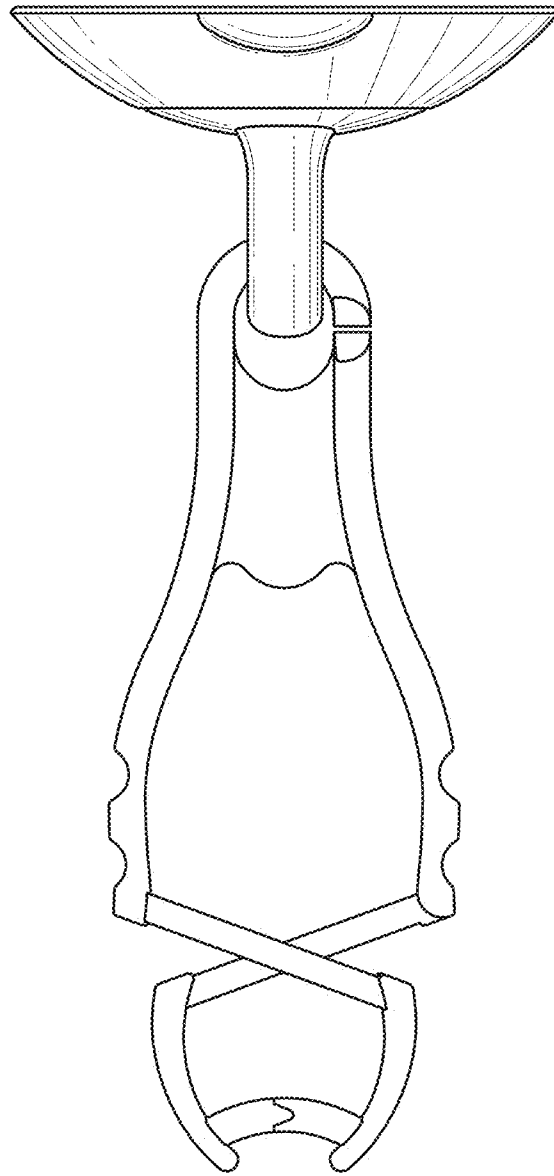

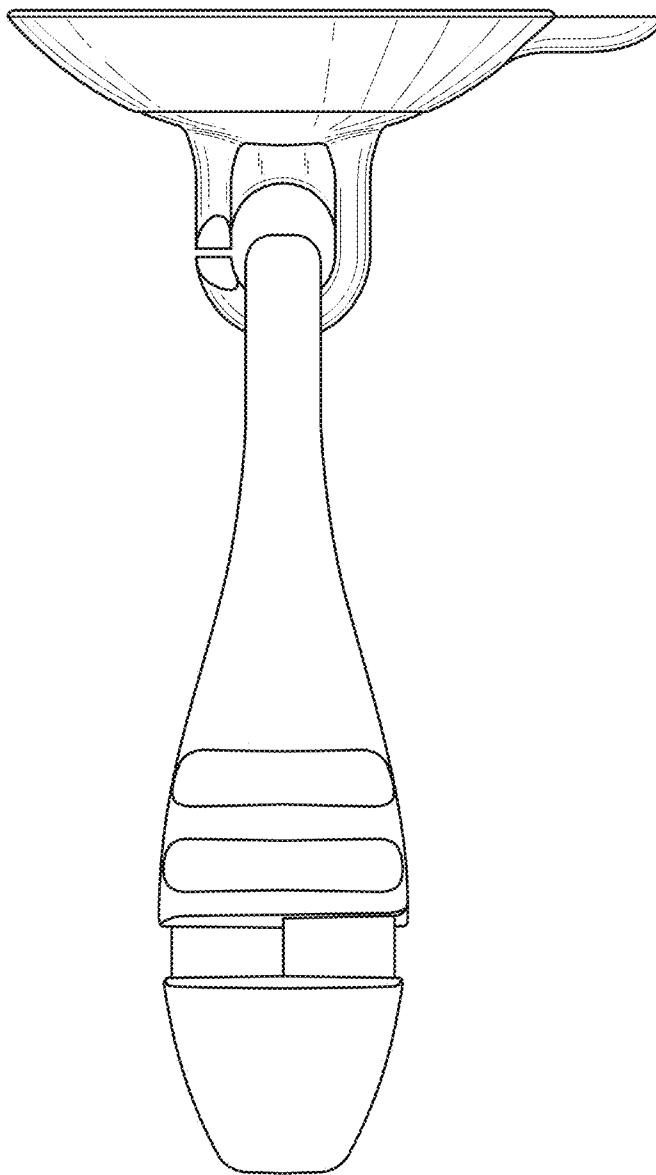

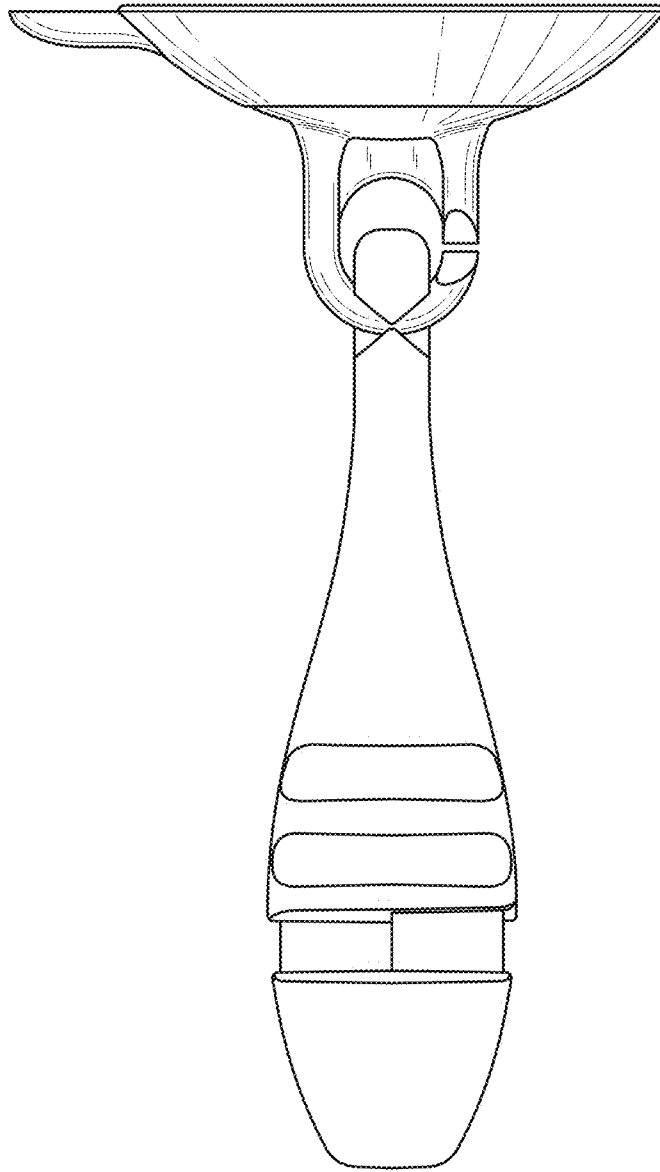

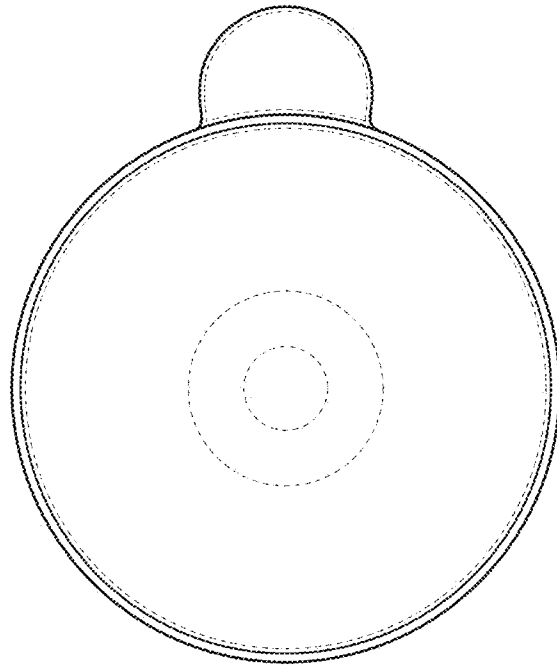

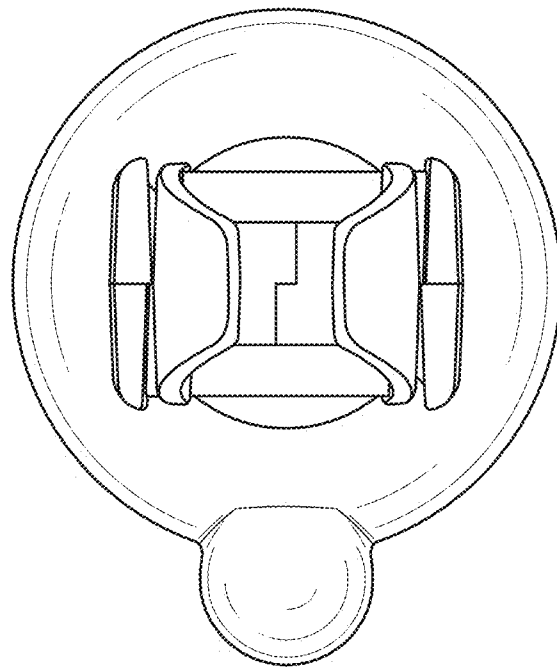
