(57) **CLAIM**

The ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a television receiver, showing our new design;

FIG. 2 is a front view thereof;

FIG. 4 is a side view thereof;

FIG. 5 is another side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 9 is a perspective view of the stand portion of the television receiver with the broken lines removed for clarity of illustration.

The broken lines are for environmental purpose only and form no part of the claimed design.

The shade lines in the figures show contour and not surface ornamentation.












