(57) **CLAIM**

The ornamental design for a helmet/head restraint with leg straps, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a helmet/head restraint with leg straps showing my new design;

FIG. 2 is a rear view thereof; and,







