
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front and left perspective view of a motor, showing our new design.
FIG. 2 is a front and right perspective view thereof.

FIG. 5 is a front elevation view thereof.
FIG. 6 is a rear elevation view thereof.

FIG. 10 is a bottom plan view thereof; and,




















