We claim the ornamental design for a device for attaching and detaching needle to/from syringe, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a device for attaching and detaching needle to/from syringe of the present invention;

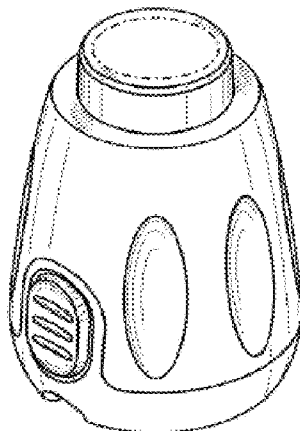

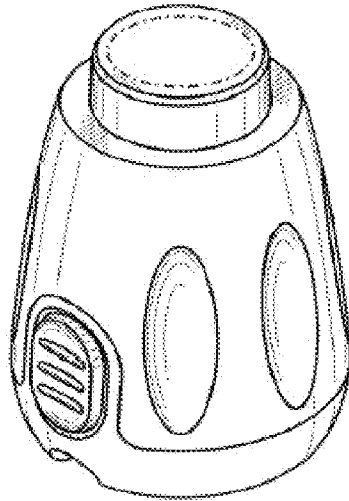

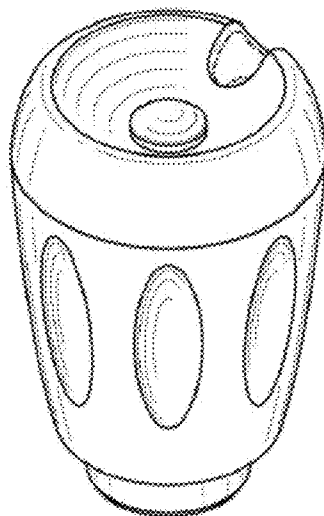

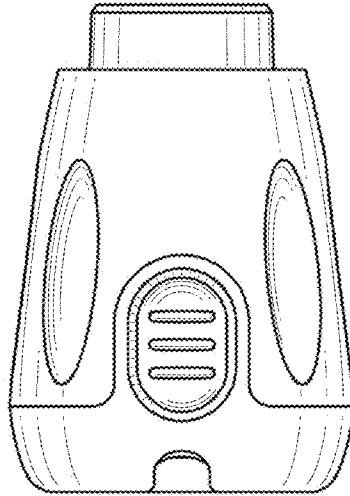

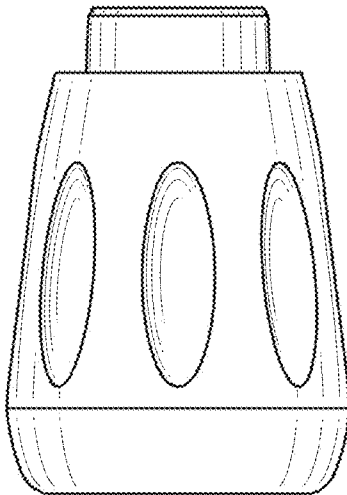

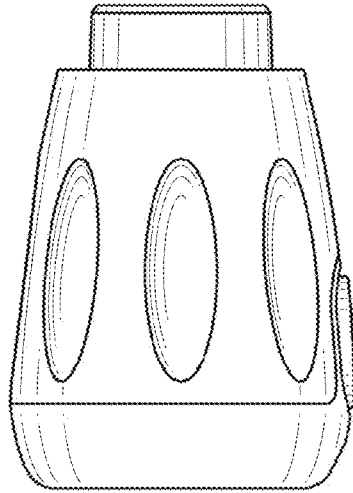

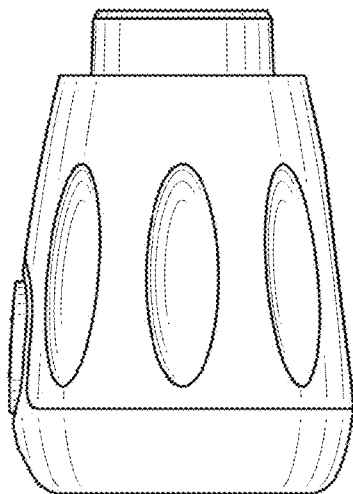

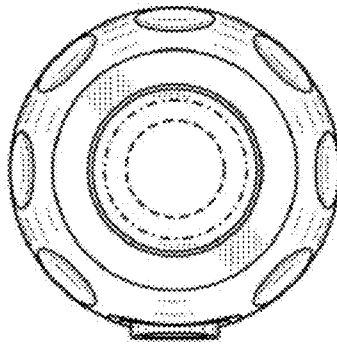
