
(57) **CLAIM**

The ornamental design for an outlet converter, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of an outlet converter, showing my new design;
FIG. 2 is a bottom, rear and left side perspective view;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The broken lines in the drawings illustrate the portions of the outlet converter, which form no part of the claimed design.
















