DESCRIPTION

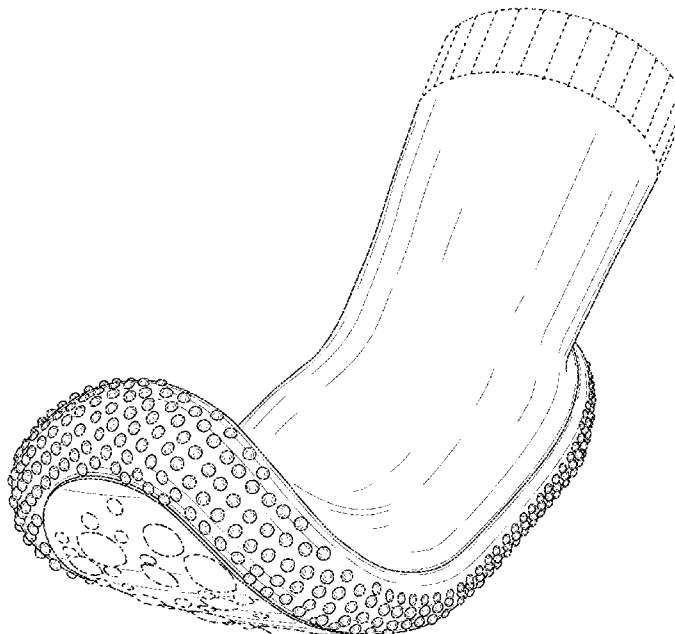
FIG. 1 is a perspective view of one side and the front of the shoe according to one embodiment of my new design;

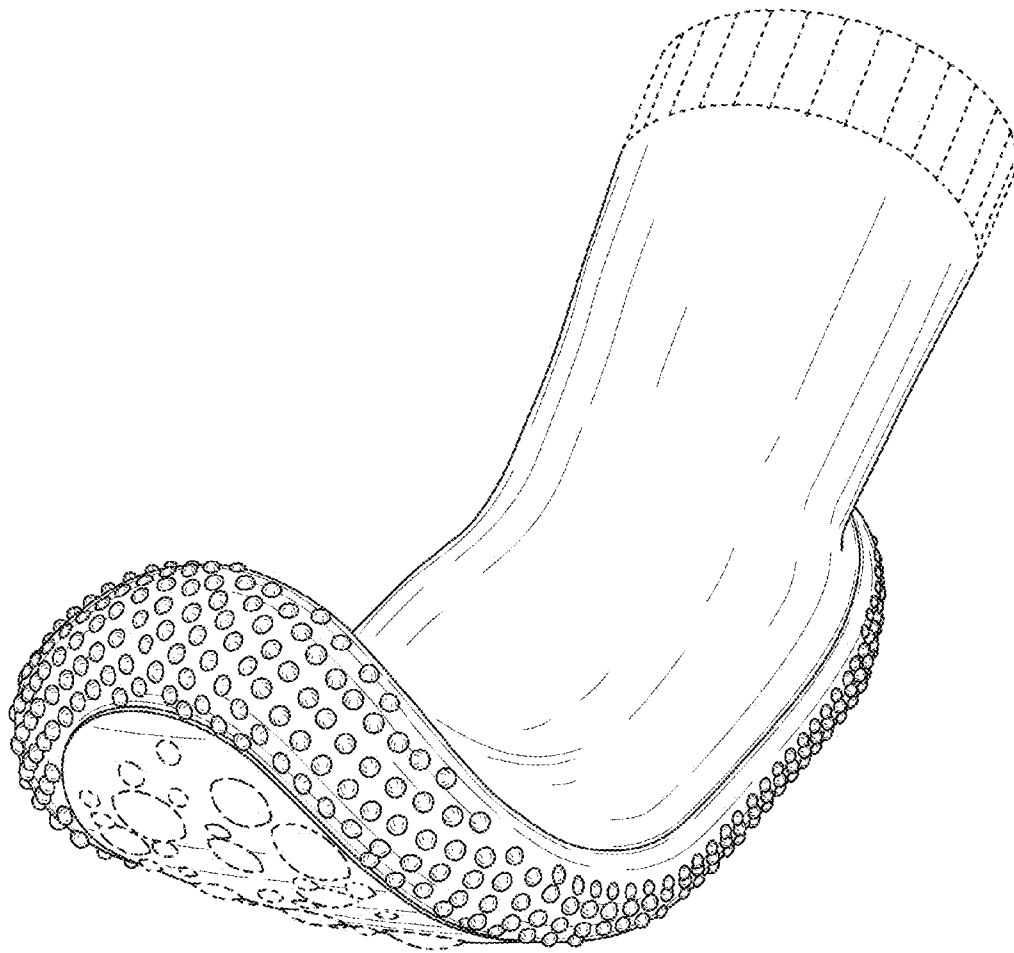

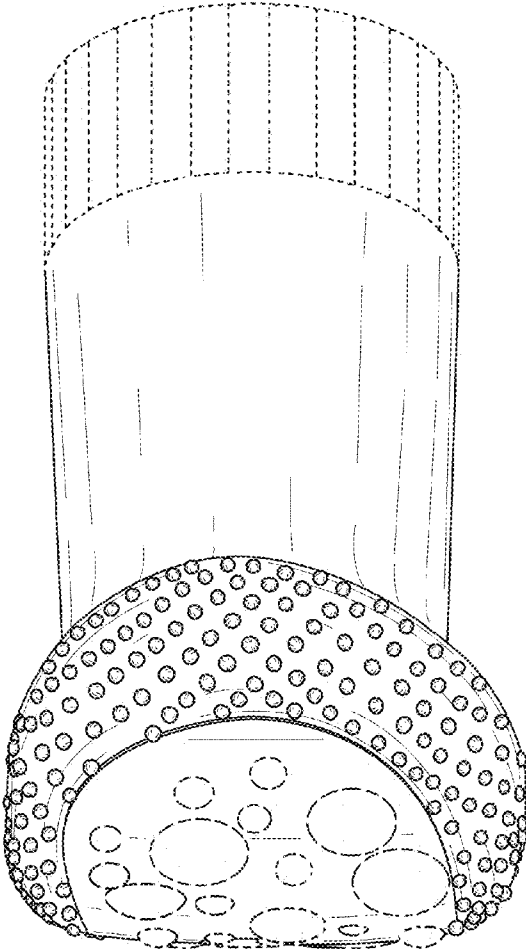

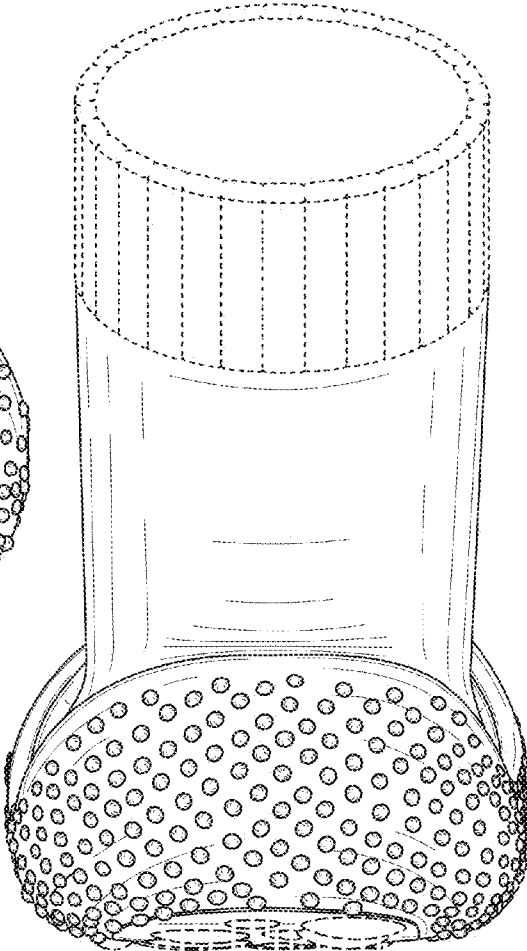

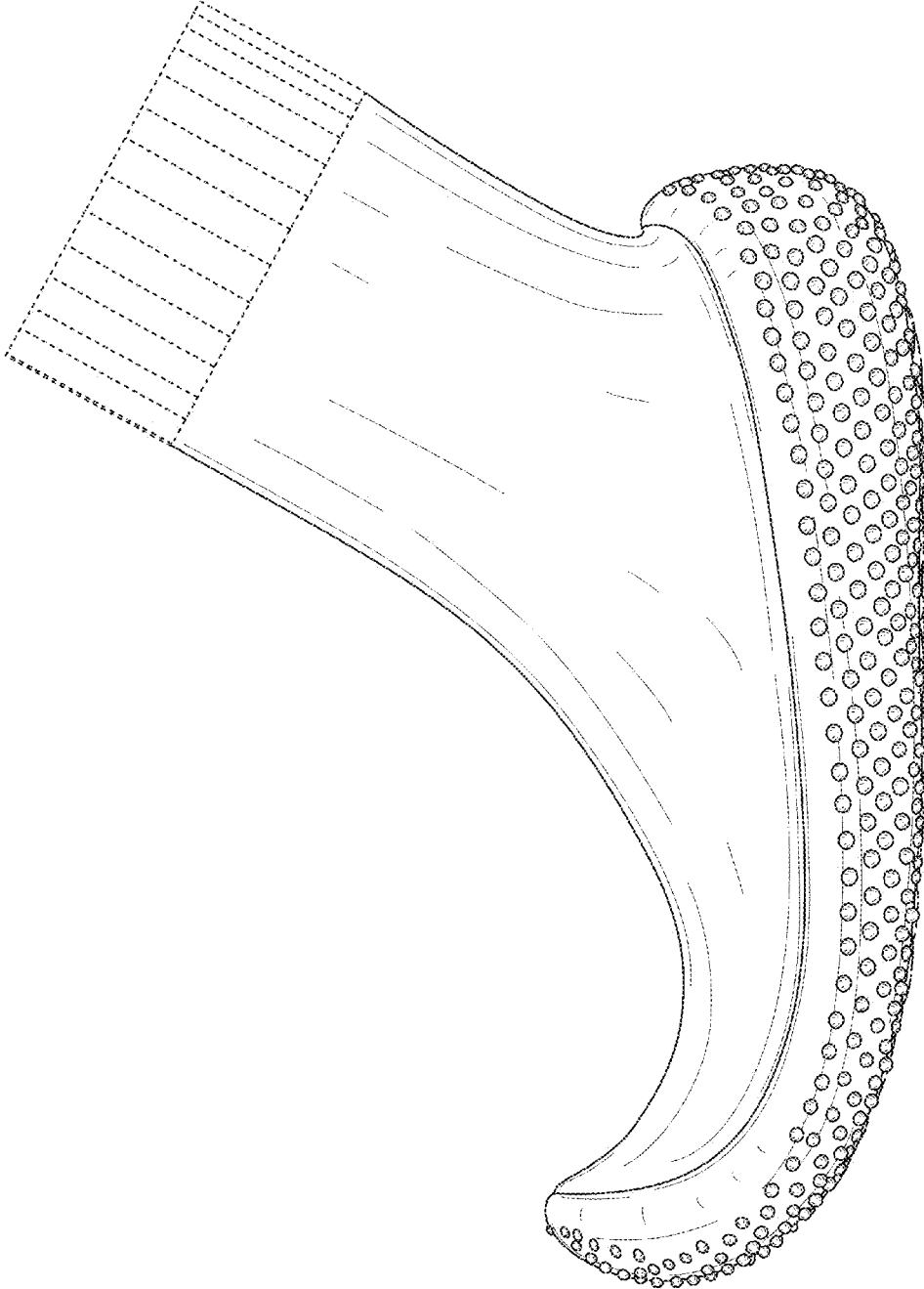

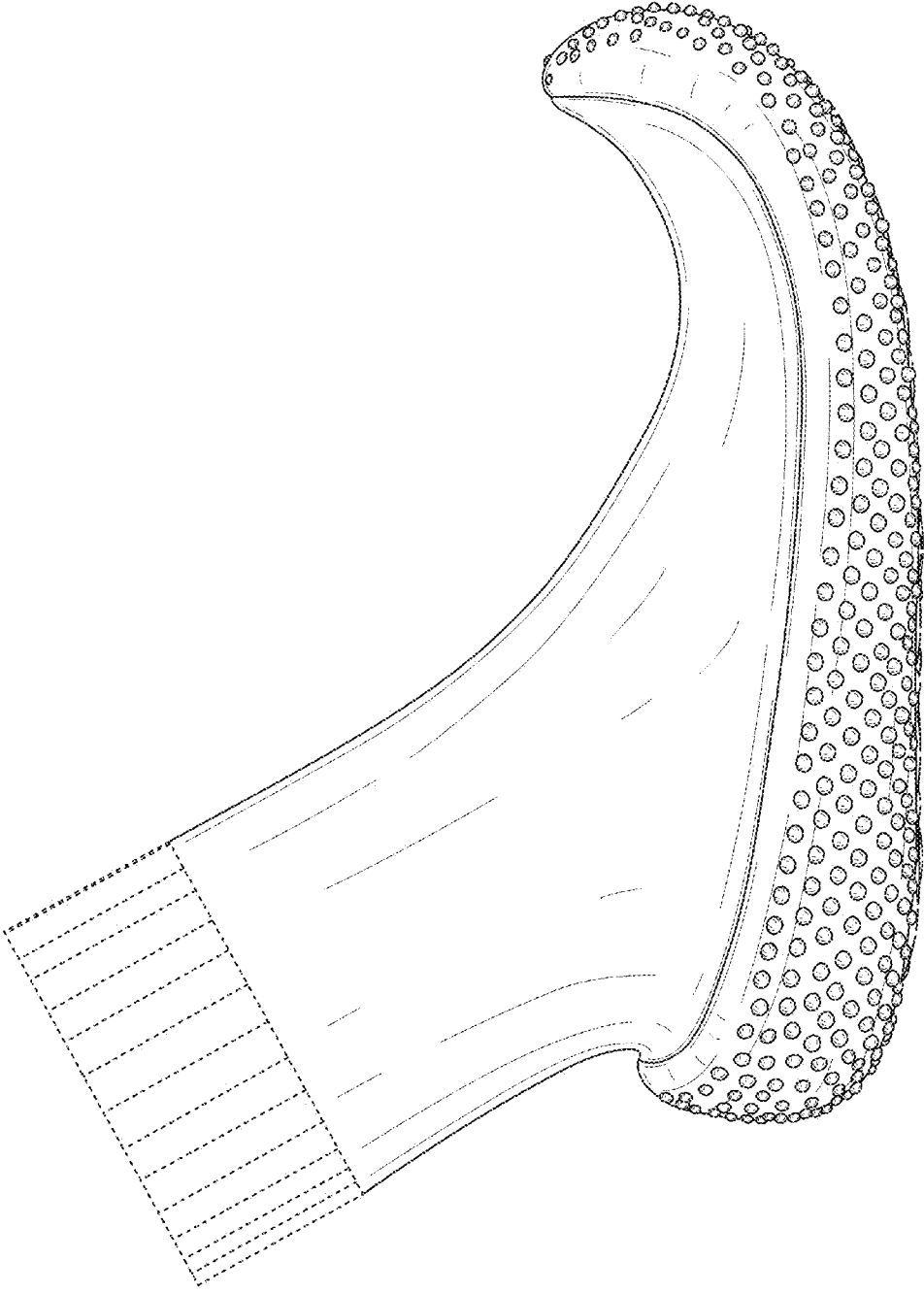

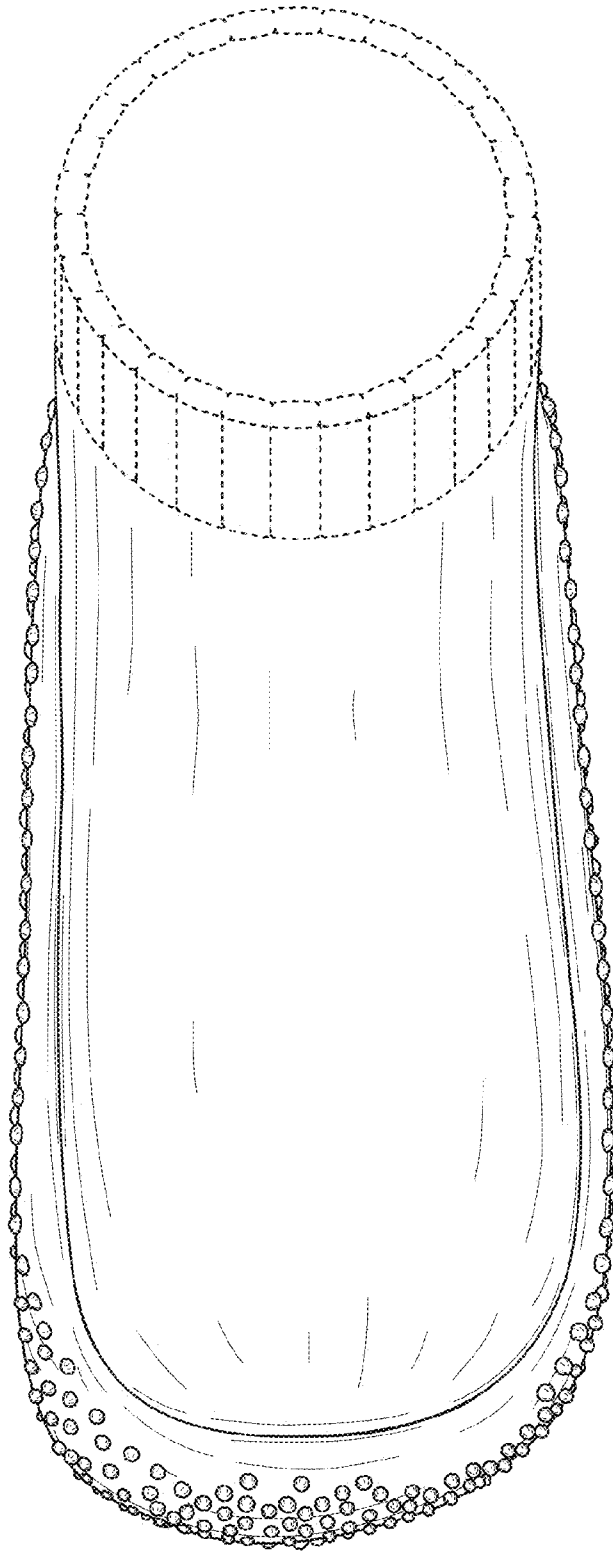

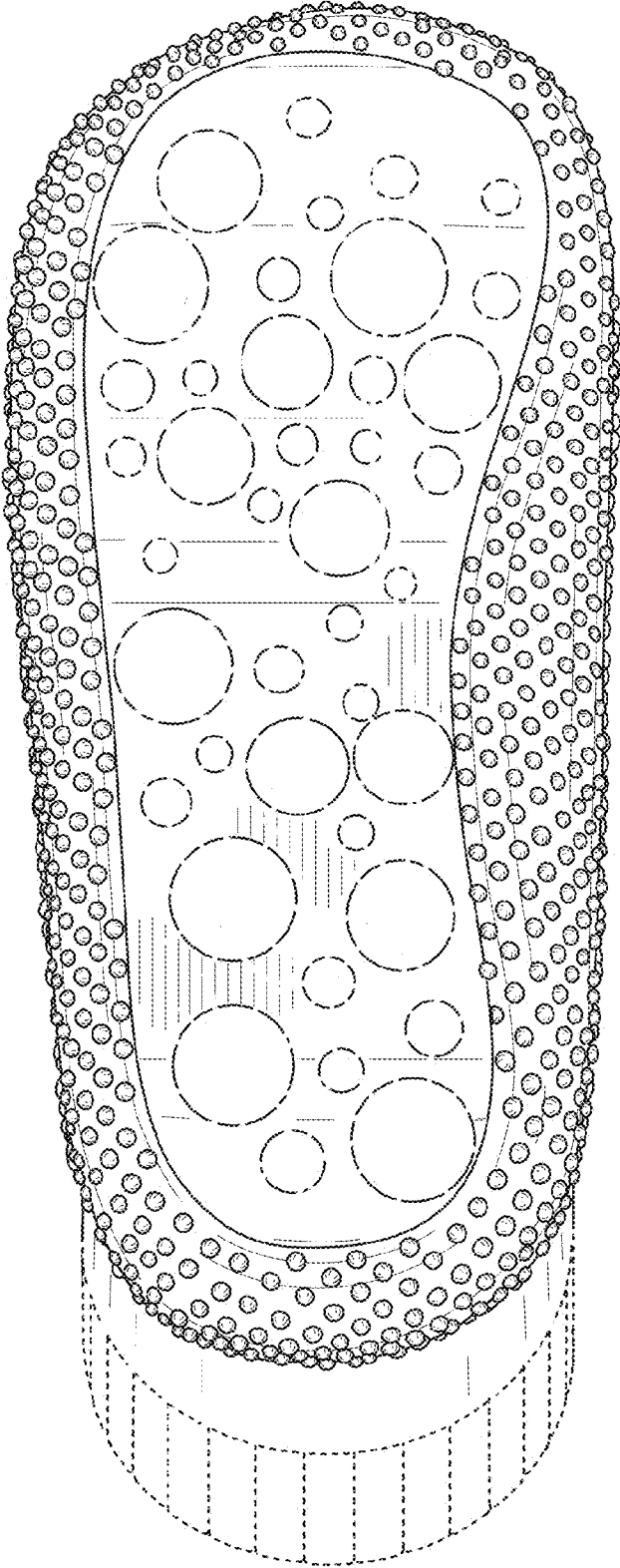
