DESCRIPTION

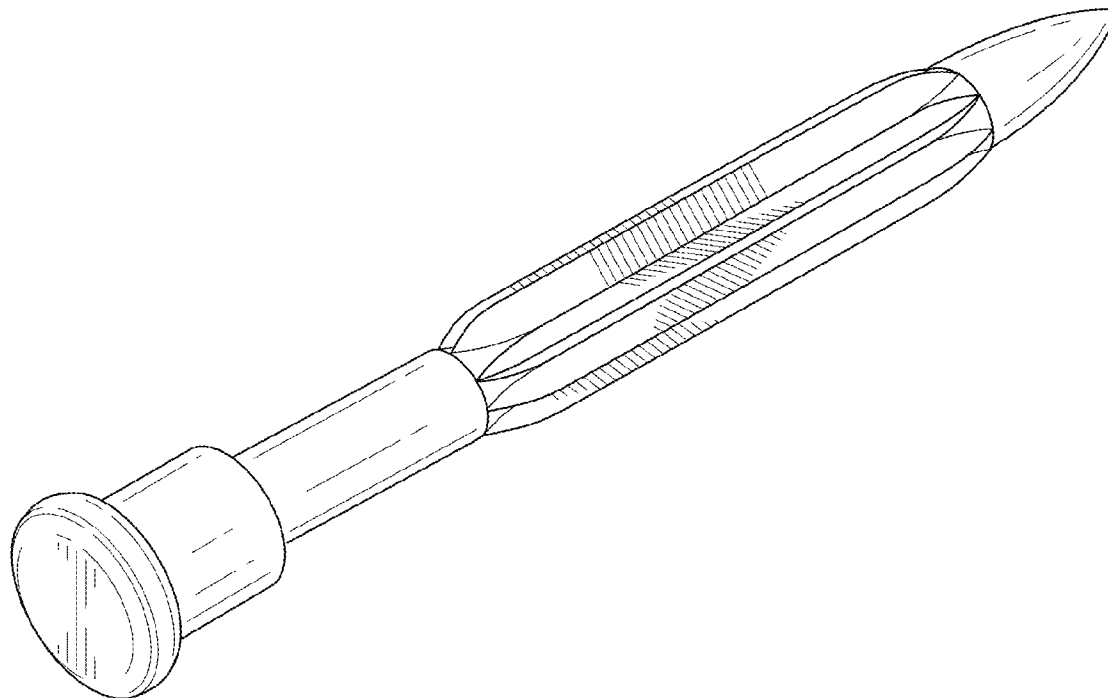
FIG. 1 is a perspective view of a fluted nail showing my design;

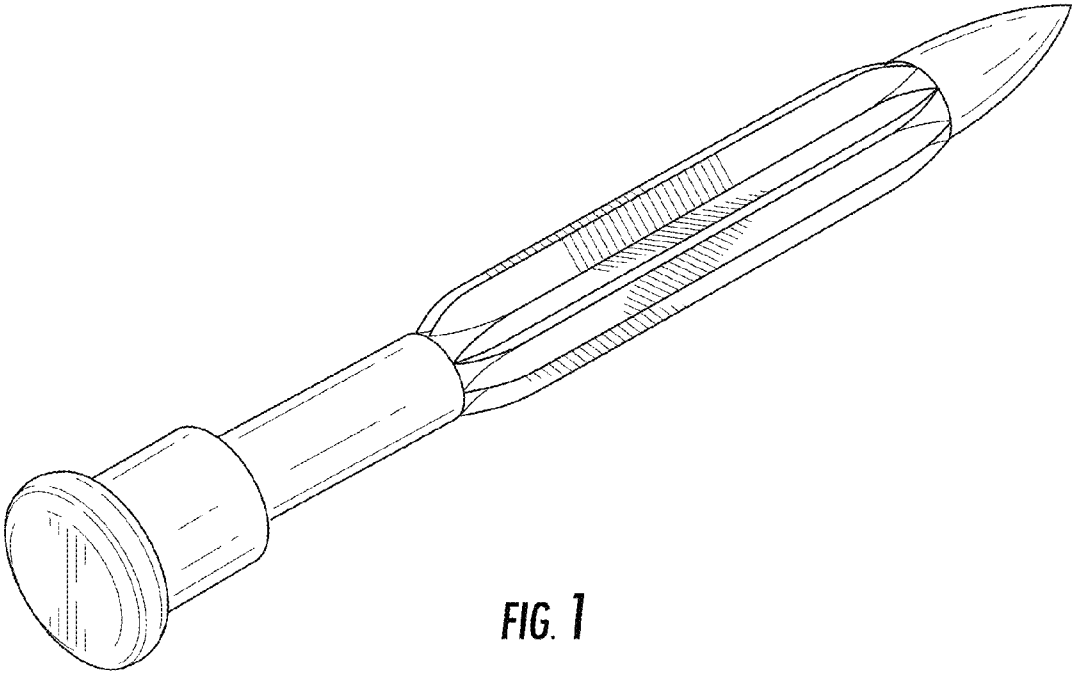

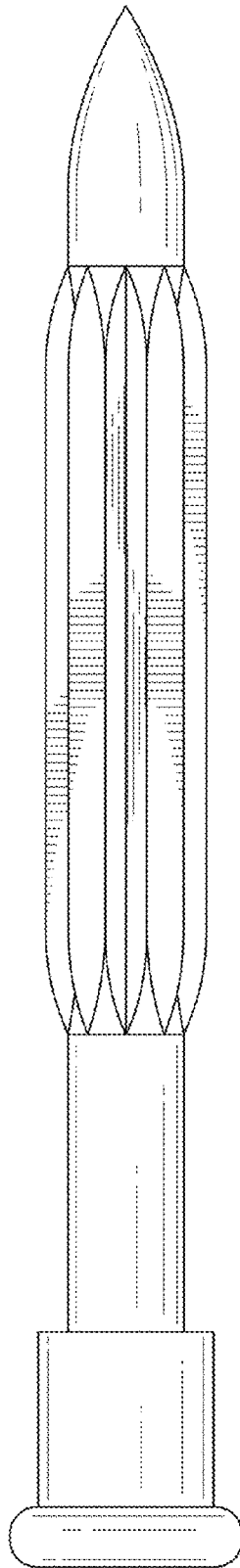

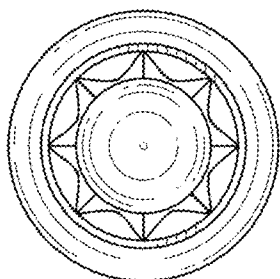

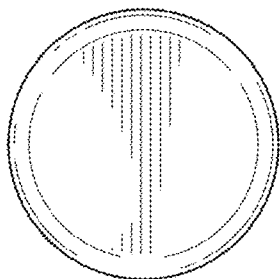
