(57) **CLAIM**

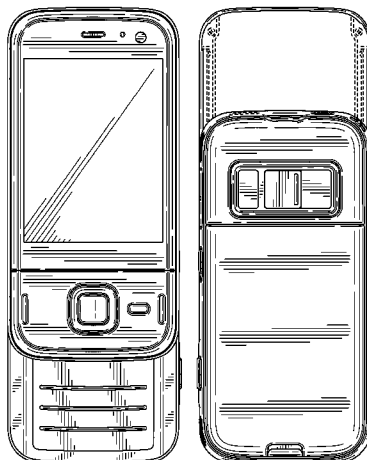
The ornamental design for a handset, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of a handset in a first embodiment showing my new design;
 FIG. 2 is a perspective rear view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a left side view thereof;
 FIG. 7 is a top plan view thereof; and,
 FIG. 8 is a bottom plan view thereof.

The broken lines shown in FIGS. 1–8 that are immediately adjacent to the shaded areas represent the bounds of the embodiment in which they are shown, while all other broken lines are directed to environment and are for illustrative purposes only; the broken lines, and the unshaded interior of the front cover shown in FIGS. 2 and 4, form no part of the embodiment in which they are shown.

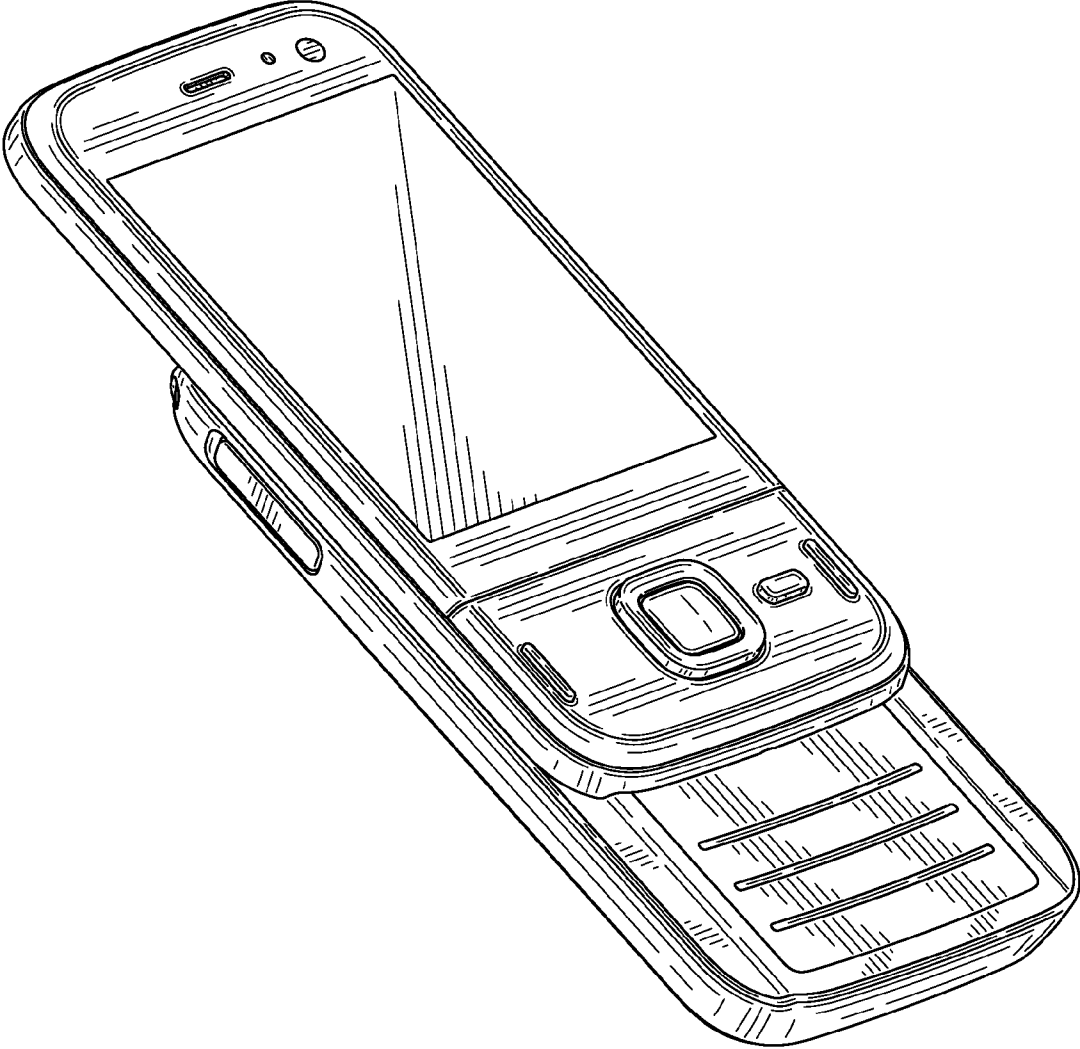

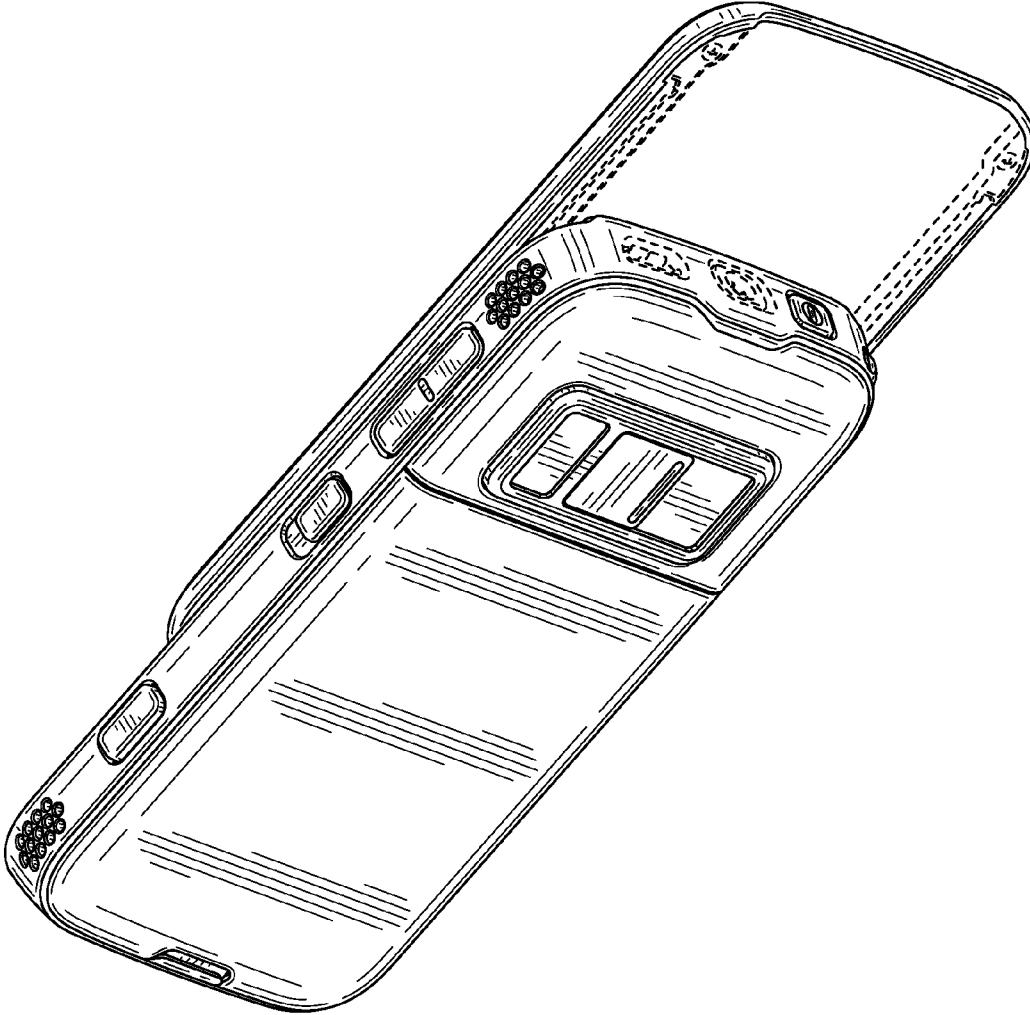

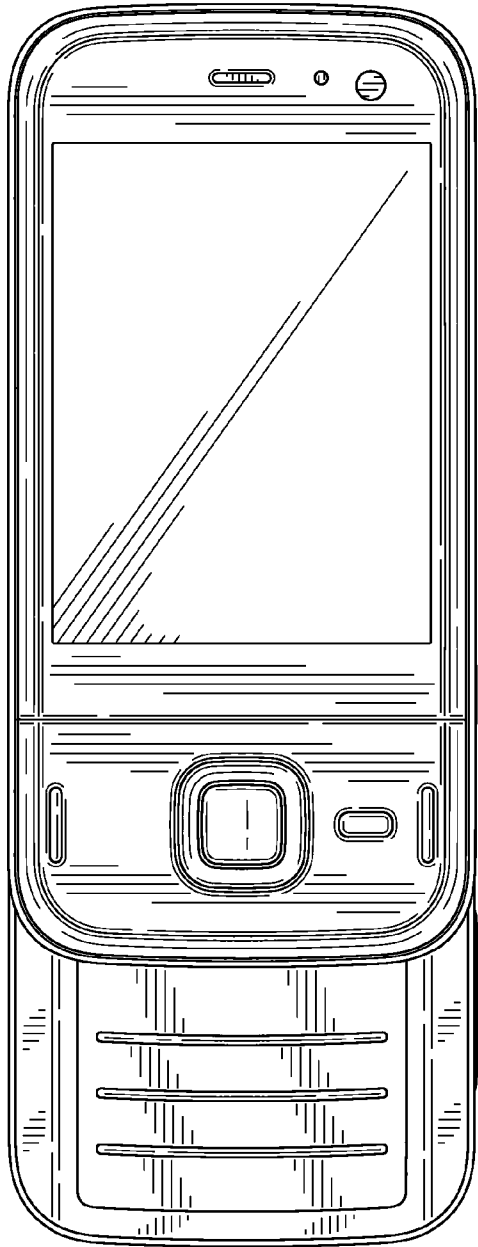

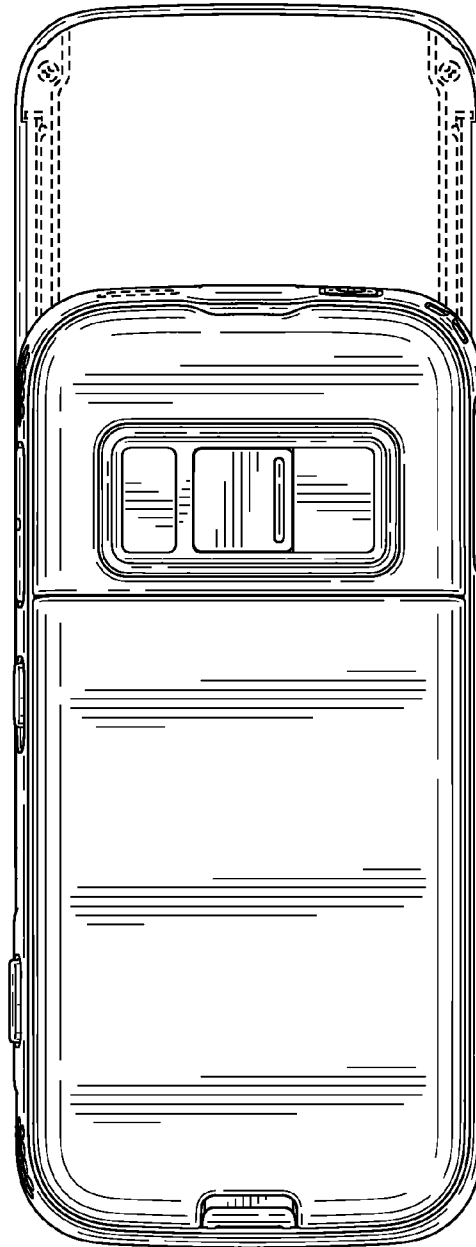

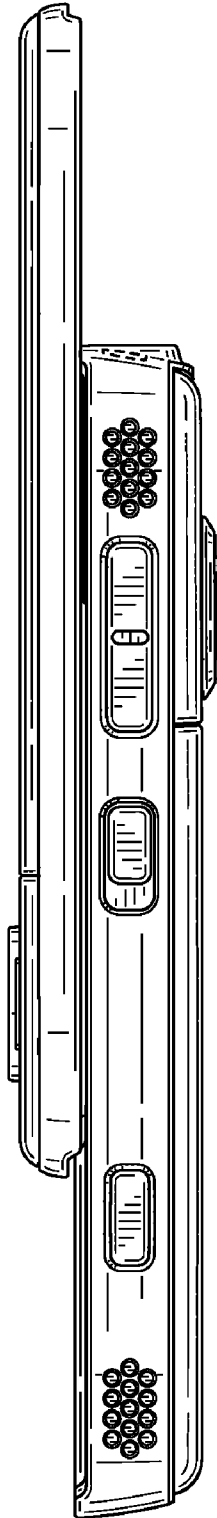

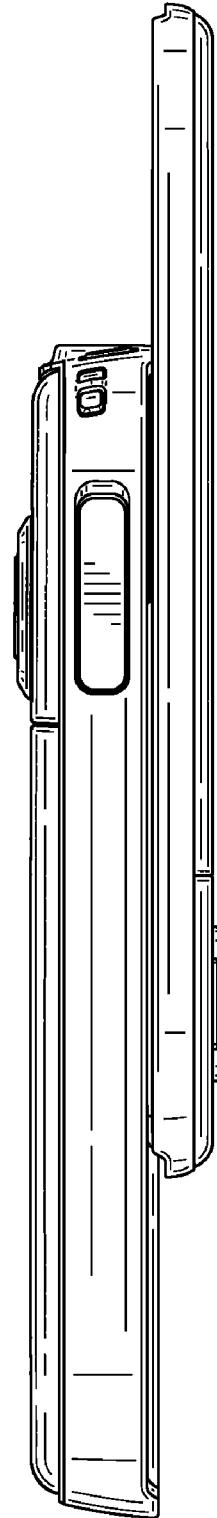

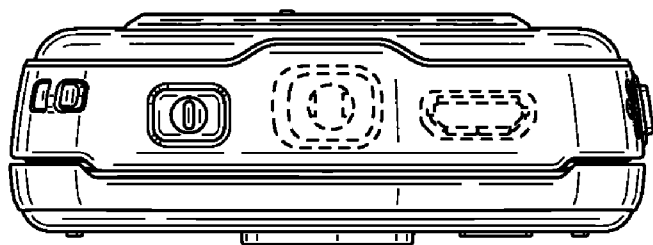

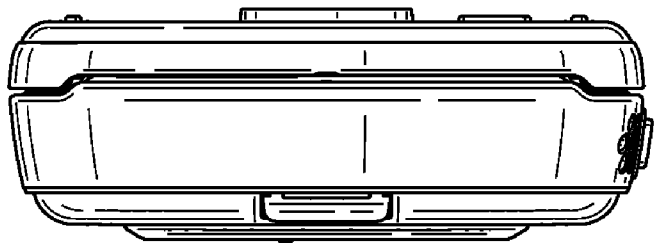
