

(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a rear bottom perspective view of a shoe, showing my new design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof; and,
FIG. 5 is rear view thereof.
The dot-dash broken line represents a boundary of the claimed design and forms no part of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.










