

(54) Title: CHARITABLE TRANSACTION RISK MANAGEMENT CLEARINGHOUSE



(57) Abstract: A computerized risk management method and system for facilitating analysis and quantification of risk associated with a Charitable Transaction (Figure 1A). An automated risk management clearinghouse (CTRMC) system maintains a database relating risk variables (112) including world event government advisories, and other information sources (113) with potential risk for a Financial Institution. The CTRMC (106) system can be accessed directly or tied into front end or back end systems to automatically monitor transactions. A rating system (111) is used to access risk based upon criteria such as risk advisories, historical data, interpretation of world events or other variables that can effect risk (Figure 1A).
