(57) **CLAIM**

I claim the ornamental design for a plastic bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a plastic bottle according to the present design;


FIG. 2 is a front elevational view of the plastic bottle of FIG. 1;

FIG. 3 is a top view of the plastic bottle of FIG. 1; and,








