(57) **CLAIM**

We claim the ornamental design for a toy ride-on karaoke car, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a toy ride-on karaoke car embodying the invention.

FIG. 2 is a left side elevation view of a toy ride-on karaoke car shown in FIG. 1.

FIG. 3 is a right side elevation view of a toy ride-on karaoke car shown in FIG. 1.

FIG. 4 is a front elevation view of a toy ride-on karaoke car shown in FIG. 1.


FIG. 5 is a rear elevation view of a toy ride-on karaoke car shown in FIG. 1.













