


DESCRIPTION

FIG. 1 is a perspective view of a tiled light cover, showing my new design;
 FIG. 2 is a top plan view thereof, the bottom plan view being a mirror image thereof;
 FIG. 3 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;
 FIG. 4 is a front elevational view thereof; and,
 FIG. 5 is a rear elevational view thereof.
 The broken lines showing a mounting aperture in the rear surface of the design form no part of the claimed design.










