
(57) **CLAIM**

The ornamental design for a dual wall mug for retaining coffee or tea, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view showing my new design for the dual wall mug for retaining coffee or tea; FIG. 2 is a top perspective view thereof; FIG. 3 is front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top view thereof; and, FIG. 8 is a bottom view thereof.














