(57) **CLAIM**

We claim the ornamental design for a pick holder, as shown and described in FIGS. 1-8.

**DESCRIPTION**

FIG. 1 is a perspective view of a pick holder.  
FIG. 2 is a left side view of the pick holder shown in FIG. 1.  
FIG. 3 is a right side view of the pick holder shown in FIG. 1.  
FIG. 4 is a front view of the pick holder shown in FIG. 1.  
FIG. 5 is a back view of the pick holder shown in FIG. 1.  
FIG. 6 is a top view of the pick holder shown in FIG. 1.  
FIG. 7 is a bottom view of the pick holder shown in FIG. 1; and,  
FIG. 8 is a perspective view of a portion of the pick holder shown in FIG. 1 in a position of use to hold a pick.  
The elements shown in broken lines are included for the purpose of illustrating environment and form no part of the claimed design.














