(57) **CLAIM**

The ornamental design for a mobile phone case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and right side perspective view of a mobile phone case showing my new design;  
FIG. 2 is a bottom, rear and left side perspective view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof;  
FIG. 7 is a top plan view thereof;  
FIG. 8 is a bottom plan view thereof; and,  
FIG. 9 is an enlarged view of the portion of the mobile phone case shown in the area designated as 9 in FIG. 1.  
The broken lines in the drawings illustrate portions of the mobile phone case that form no part of the claimed design. The broken lines encircling enlargement portions of the mobile phone case in FIG. 1 and illustrated in the enlarged view in FIG. 9 form no part of the claimed design.

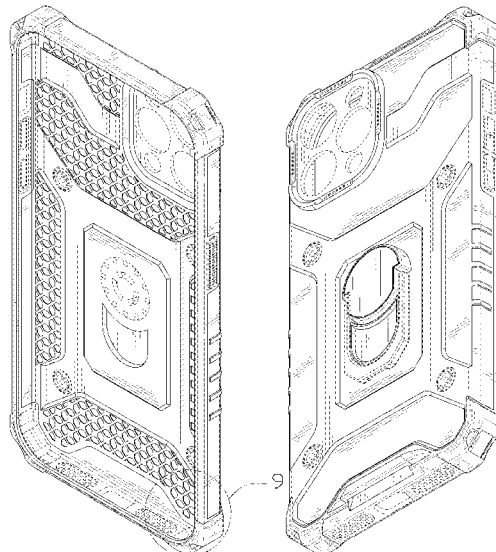

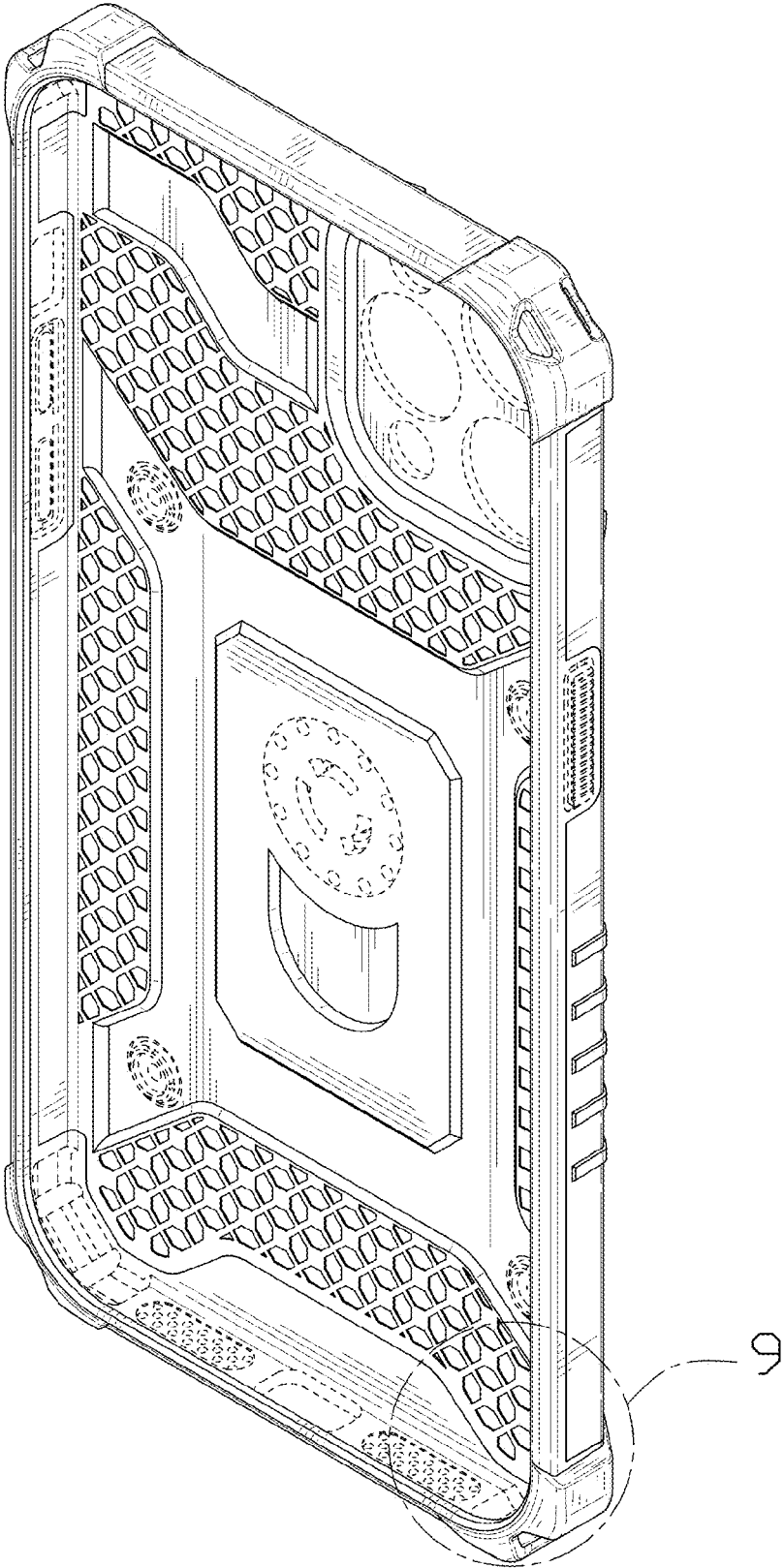

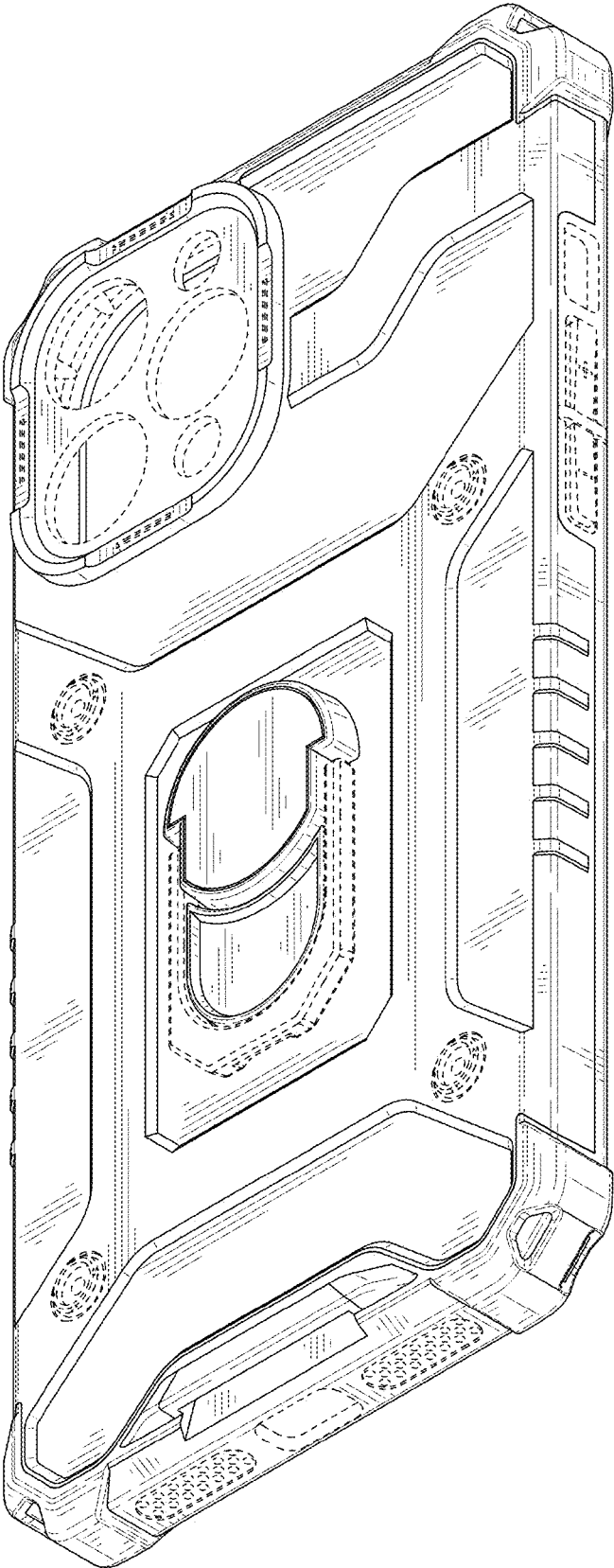

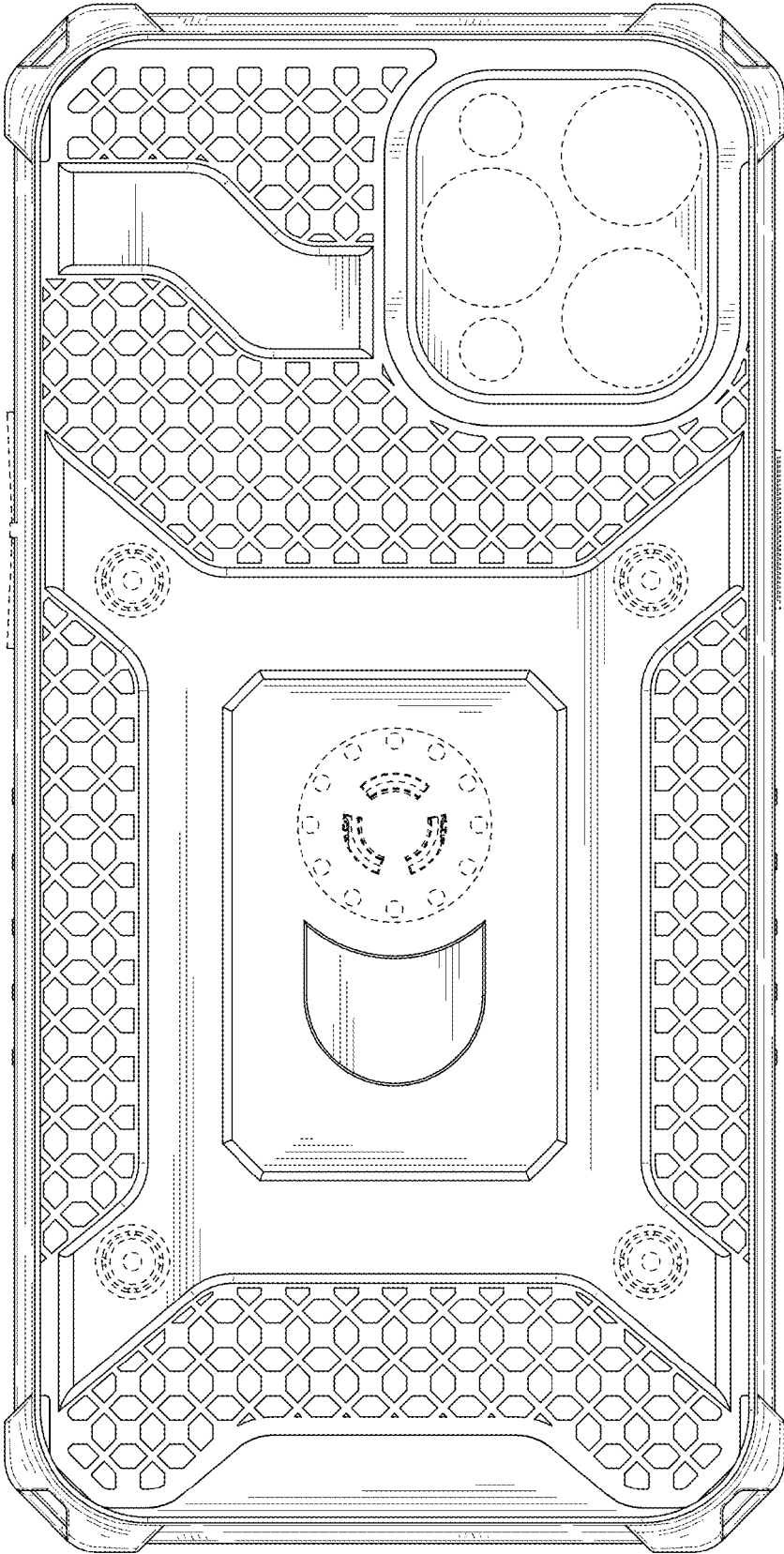

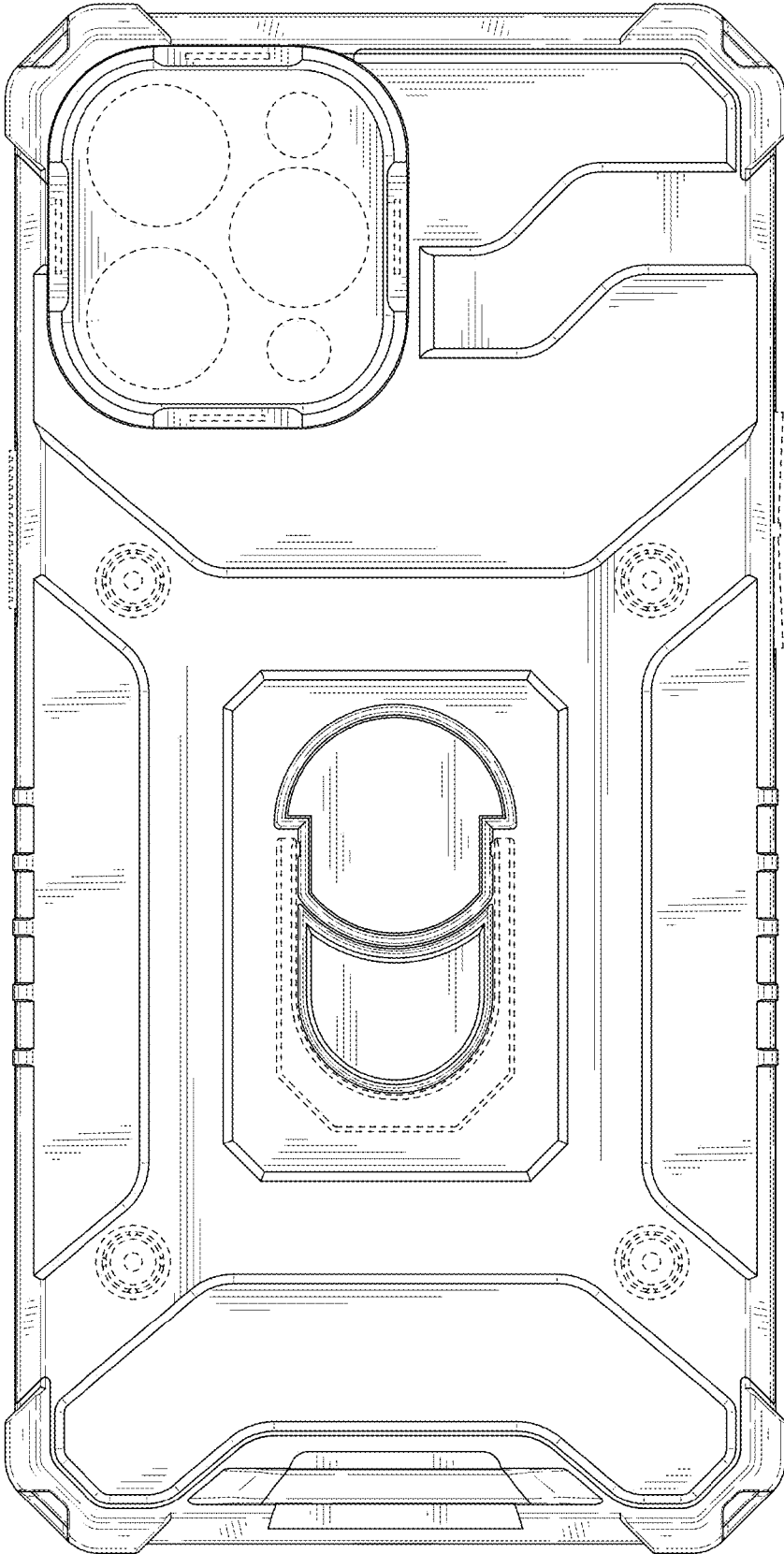

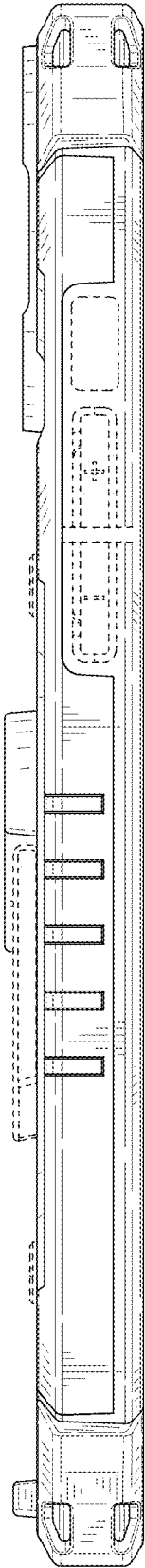

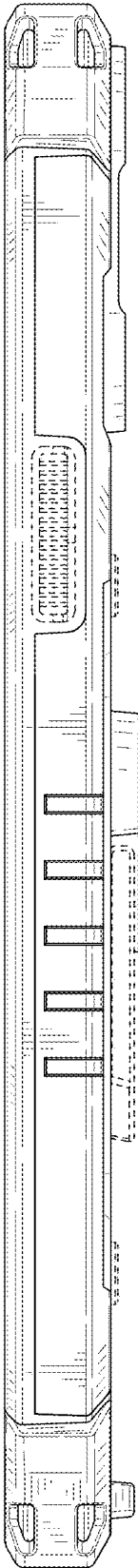

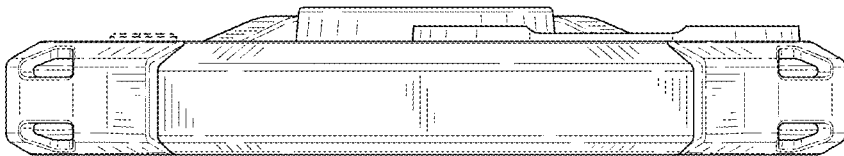

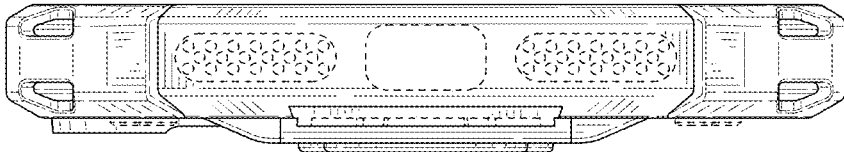

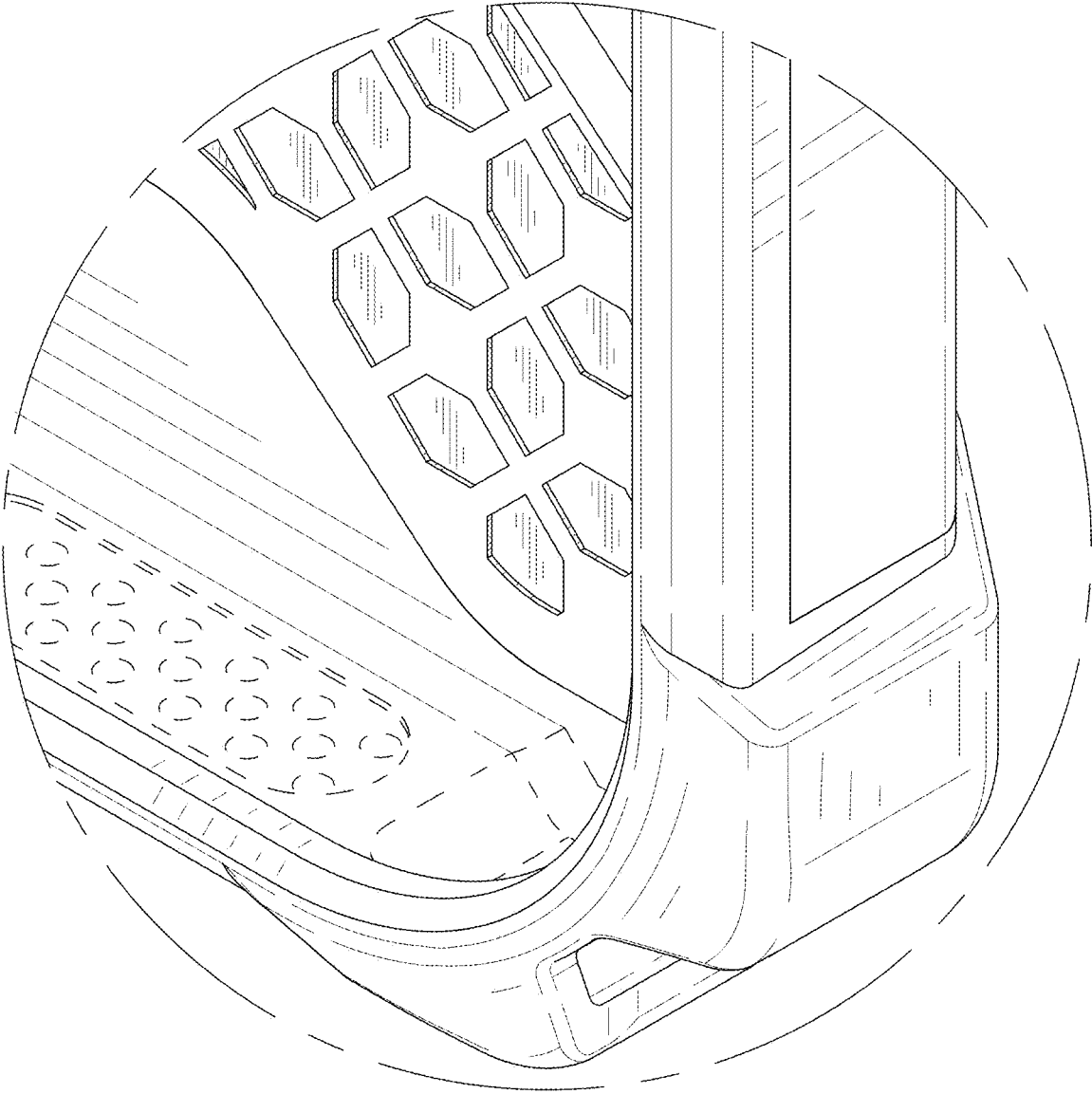
