

(57) **CLAIM**

The ornamental design for a biomedical multifunction tester, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a biomedical multifunction tester showing my new design; FIG. 2 is a lower front right perspective view thereof; FIG. 3 is a lower rear perspective view thereof; and, FIG. 4 is a lower rear right perspective view thereof. 






