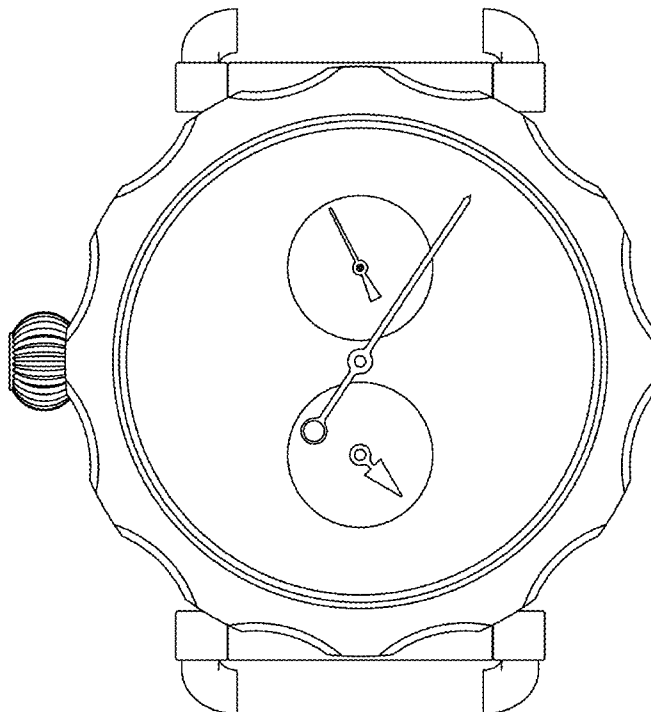
(57) **CLAIM**

The ornamental design for a watch, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a watch that has the design. FIG. 2 is a left side elevation view of the watch. FIG. 3 is a right side elevation view of the watch. FIG. 4 is a rear elevation view of the watch. FIG. 5 is a top view of the watch. FIG. 6 is a bottom view of the watch; and, FIG. 7 is a right front perspective view of the watch. The structural feature depicted by broken lines in FIG. 4 has been shown for the purpose of illustrating a portion of the watch that forms no part of the claimed design.

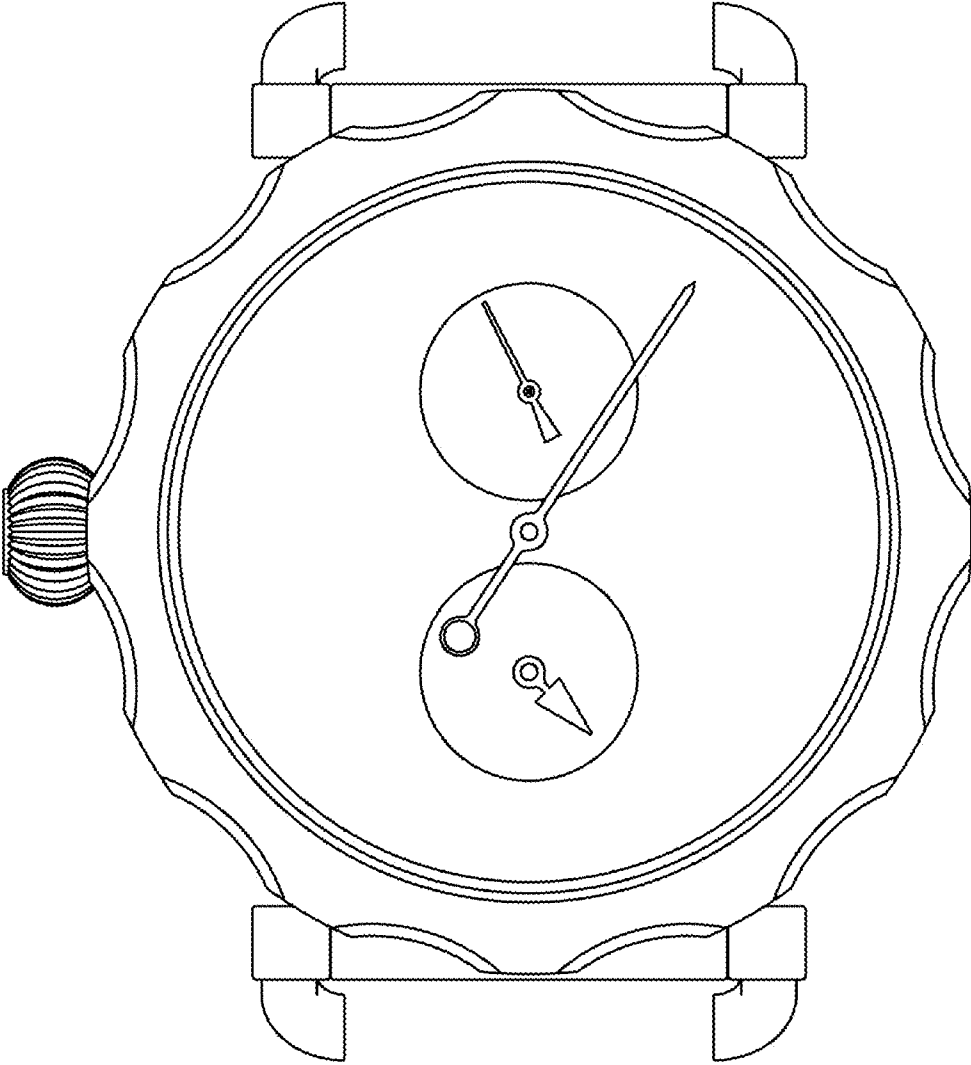

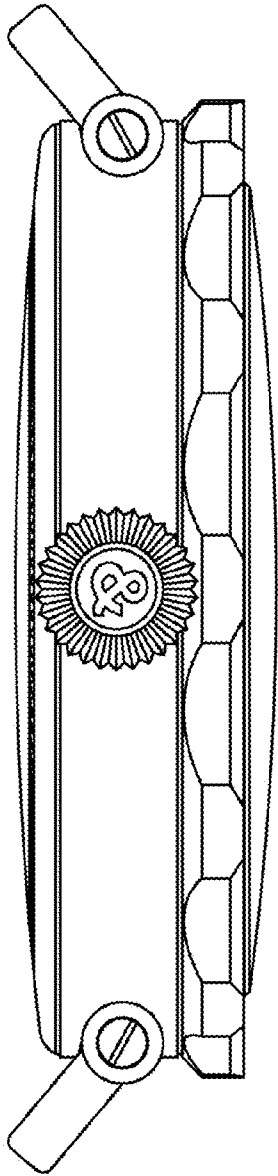

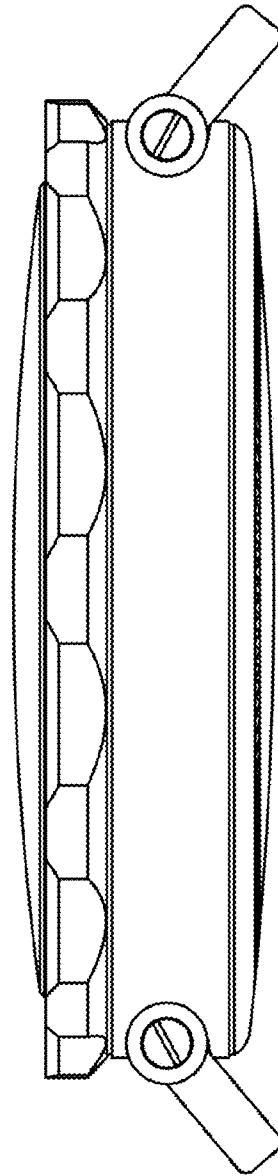

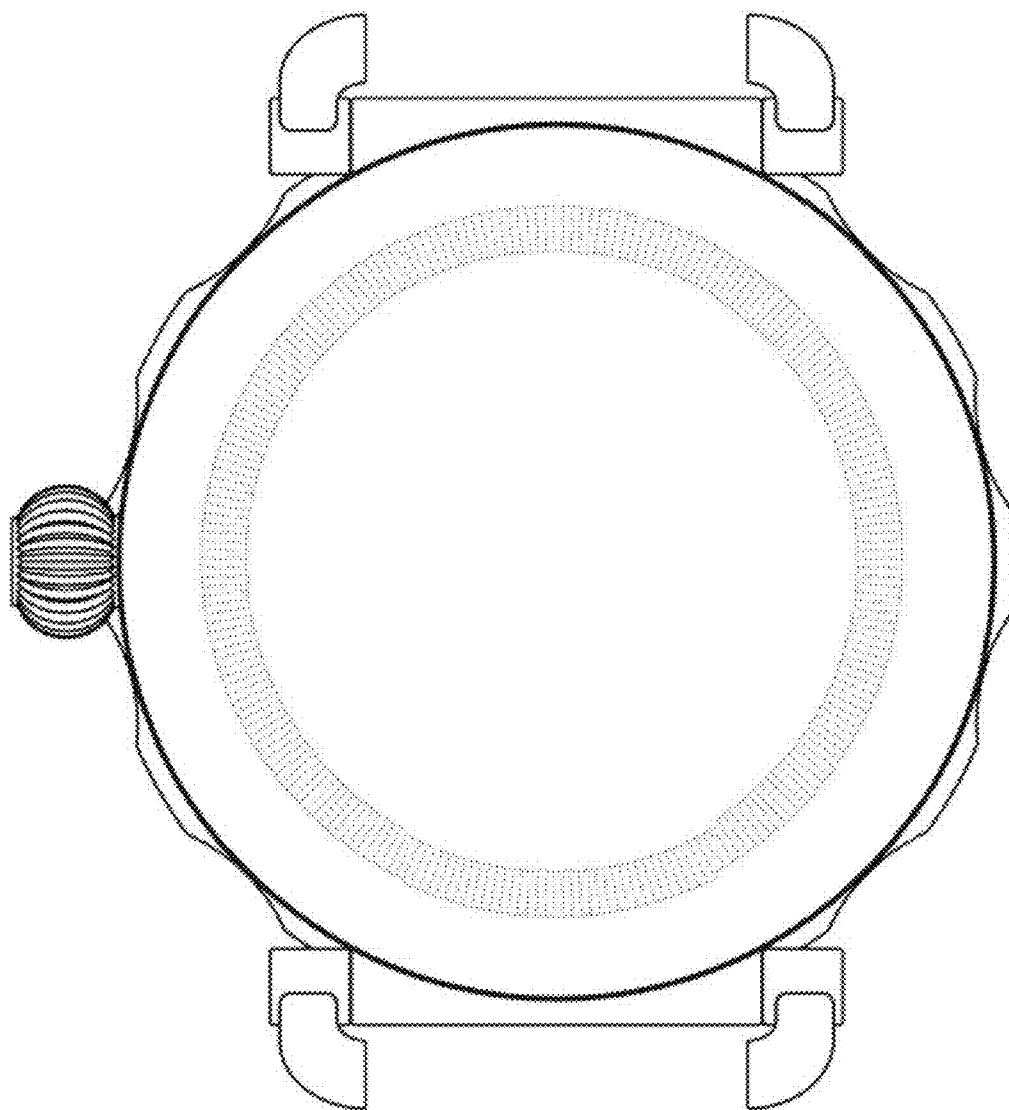

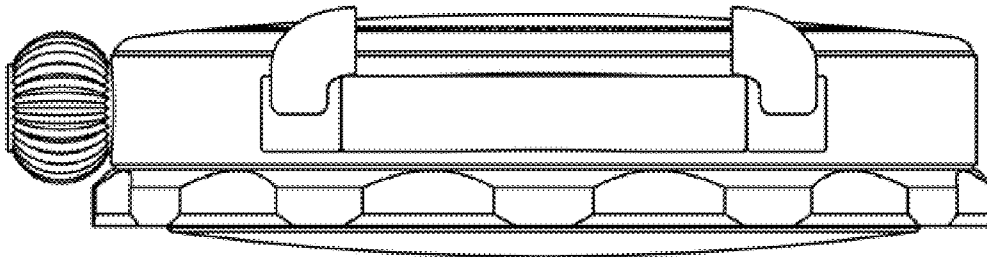

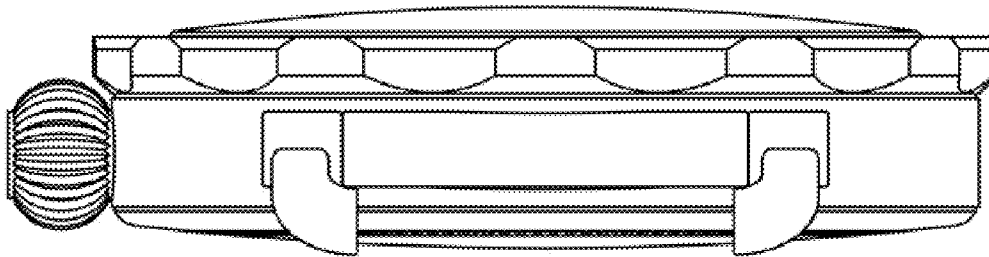

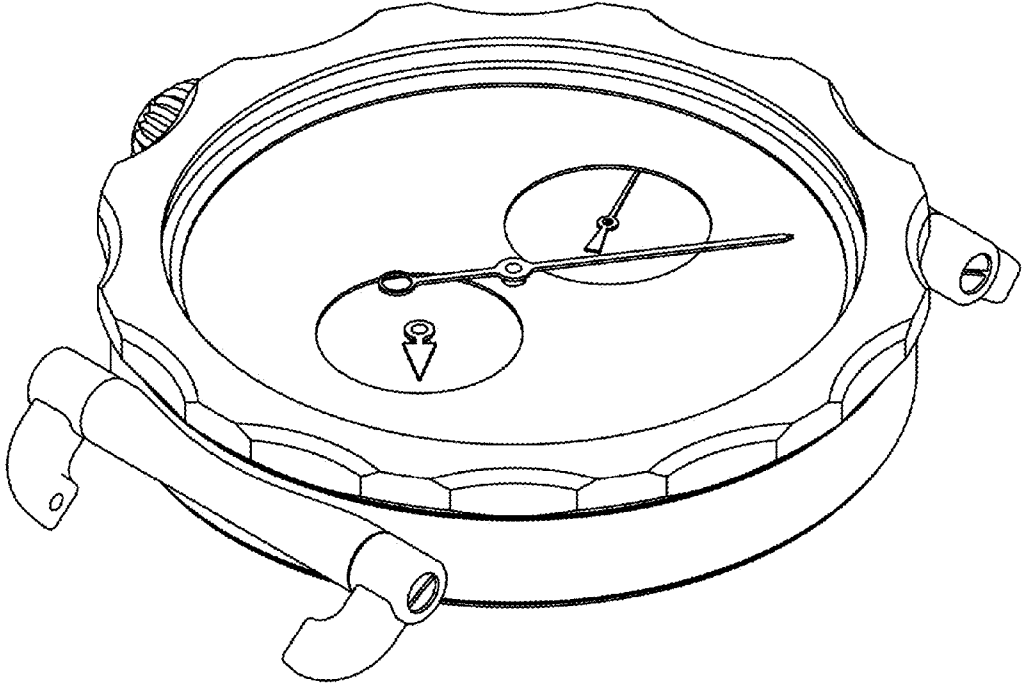
